My name is Agnes Malate and I'm a member of the Filipinos for Affirmative Action. I strongly support Abelina Madrid Shaw's nomination to the Crime Victim Compensation Commission. Her broad spectrum of experiences in various government positions, legal system, nonprofit organizations, and grassroots efforts puts her in a prime position to make the tough decisions about compensation to alleviate the physical, mental and financial hardships suffered by victims of violent crime.

As an immigration attorney, Ms. Shaw has intimate knowledge of the legal justice system. She has worked with clients who can at times be in vulnerable positions and is sensitive to others in similar positions. Growing up in a plantation community on Kauai, Ms. Shaw, went on to obtain a bachelor's degree in education and subsequently received her graduate degrees in communications and law. Her journey is a testament to her endurance, resilience, and intelligence. She has had to be tough, but underneath the exterior is one who has extended herself to those who have needed her help from all walks of life.

Thank you for this opportunity to provide testimony, and I hope you will give Abelina Madrid Shaw nomination your full consideration.
