The Department of Human Services (DHS) is in strong support of the nomination of Ms. Leslie Tawata as a member of the State Council on Developmental Disabilities. The Council is administratively attached to the Department of Health. The mission of the Council is to advocate for the fair treatment of state citizens with a developmental disability. Ms. Tawata will be the Medicaid state agency representative if she is confirmed.

Ms. Tawata brings an in-depth knowledge and expertise on the subject as the DHS/Med-Quest Division Assistant Administrator and in her previous role as the Department of Health Developmental Disabilities Division's fiscal coordinator. These skills coupled with Ms. Tawata's extensive knowledge of Medicaid programs and rules applicable to developmentally disabled clients will be invaluable to the Council.

Ms. Tawata is an able and dedicated public servant, starting her career in August 1983 as a case manager with the Med-QUEST Division (MQD) where she was promoted to increasingly higher supervisory roles. She was appointed the MQD Assistant Administrator in October 2011.

In between her long tenure with the DHS/MQD, she served as the fiscal coordinator of the Developmental Disabilities Division in the Hawaii Department of Health. In her role as fiscal coordinator, Ms. Tawata was responsible for ensuring compliance with the Developmental Disabilities Medicaid Waiver through timely submittal of required reports; ensuring compliance with federal requirements; issuing of program memoranda to providers and case management staff; and served as chair of the Division's Policy Advisory Board and Utilization Management Committee.

As the Medicaid representative to the Council, Ms. Tawata will be able to share her knowledge and expertise with the Council on the programs and policies that will impact clients with developmental disabilities.

SUBJECT: GM 781 - State Council on Developmental Disabilities Gubernatorial Nominee Leslie Tawata

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 781** to confirm the nomination of Leslie Tawata for a term to expire June 30, 2015.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the players involved in the development, implementation, and use of DD supports are represented. The law specifically requires that 60 percent of the membership of the Council be comprised of individuals with DD, their parents, or family members. Additionally, the following agencies are required to be on the Council: Department of Health as the Designated State Agency; the agencies that administer funds provided under 1) the Rehabilitation Act of 1973, 2) the Individuals with Disabilities Education Act, 3) the Older Americans Act of 1965, and 4) Titles V and XIX of the Social Security Act; the Protection and Advocacy Agency; the Centers for Excellence in DD Education, Research, and Service; agencies and private non-profit organizations concerned with services to individuals with DD.

The Governor's nominee, Leslie Tawata, meets all the Federal requirements for Council membership. She is the Assistant Administrator for the Department of Human Services, Med-QUEST Division. Her appointment to the Council would fulfill the Federal requirement for a representative of Title XIX of the Social Security Act. Her responsibilities to oversee the administration and operations of the MQD's programs and activities statewide, and ensuring the Medicaid program is in compliance with Federal regulations, will provide a direct link to the Council's advocacy in assuring access to medical and dental services for individuals with DD. Ms. Tawata's background and experience with the Department of Health Developmental Disabilities Division in convening the Waiver Policy Advisory Committee to obtain input and recommendations from individuals, family members, and service providers to improve Home and Community-Based Services waiver supports and services would assist the Council in ensuring that the waiver is meeting the needs of individuals with DD. Her experience in implementing the Medicaid Dental Third Party Administrator contract with the Department of Human Services would assist the Council in achieving its State Plan Health goal, "People with intellectual and developmental disabilities will have access to physical and mental health and medical and dental care, providing opportunities to ensure and maintain their quality of life and ability to provide their own care."

The Council is pleased with Ms. Tawata's nomination to serve on the Council and looks forward to her contributions to assist us to improve access to supports, medical, and dental care services for individuals with DD.
