Dear Members of the Committee,

It is my pleasure to support the nomination of Mark Spence to the Hawaii Aerospace Advisory Committee.

I have known Mr. Spence since 2009, and have collaborated with him in my capacity as aviation program manager at the National Oceanic and Atmospheric Administration (NOAA) National Weather Service (NWS) Weather Forecast Office (WFO) in Honolulu. Our office is one of three Meteorological Watch Offices (MWOs) in the United States, as designated by the World Meteorological Organization (WMO) and the International Civil Aviation Organization (ICAO). Under this MWO designation, we are responsible for Significant Meteorological Information (SIGMETs) for roughly 8 million square miles of the central and western Pacific.

Mr. Spence has helped to improve the two-way exchange of information between WFO Honolulu and Hawaiian Airlines, which has led to improved forecasts and services to the entire aviation community. Specifically, he demonstrated the system he helped to develop for dispatchers which consolidates disparate sources of information into a single display. This demonstration also highlighted areas where the format of our SIGMETs can impact that display, since the text-only warnings must be automatically decoded and plotted. Using the Hawaiian Airlines display as an example of an end use, our webmaster was able to provide a product in Keyhole Markup Language (KML) format that can be directly overlaid on other graphics. We provide these KML-formatted SIGMETs to the public in real time through the aviation section of our website.

When he submitted a proposal to NASA to improve clear air turbulence detection and forecasting, Mr. Spence solicited my feedback and support. Even before the proposal was finalized, I was able to use the information he shared with me to add a new turbulence identification algorithm to our operational computer system. This updated turbulence algorithm had been published in the American Meteorological Society journal *Weather and Forevasting*, but it was the input from Mr. Spence that helped bridge the gap from research into forecast operations.

Mr. Spence's vision, technical expertise, and collaborative skill will make him a valuable member of the Hawaii Aerospace Advisory Committee. Thank you for the opportunity to provide my endorsement to the Committee. This letter contains my personal opinions, and should not be considered an endorsement by NOAA or the NWS. Please contact me if you have any questions.
