RELATING TO ELECTIONS

February 14, 2013

Chair Rhoads and members of the House Committee on Judiciary, thank you for the opportunity to testify on House Bill No. 1027. The purpose of this bill is to require absentee voters to affirm by signature that the ballot was completed in secrecy and without influence by others. This includes prohibiting employers, unions, and candidates or their agents from assisting voters with completing absentee ballots.

The Office of Elections provides the following information for the committee's consideration.

The Voter Assistance Provision of the Voting Rights Act provides that "[a]ny voter who requires assistance to vote by reason of blindness, disability, or inability to read or write may be given assistance by a person of the voter's choice, other than the voter's employer or agent of that employer or officer or agent of the voter's union." 42 USC § 1973aa-6. The statute does not appear on its face to be limited to voting in polling places and as such would appear to apply absentee mail voting.

Additionally, our state law mirrors federal law in providing, in part, that "[a]ny voter who requires assistance to vote may be given assistance by a person of the voter's choice, other than the voter's employer or agent of that employer or agent of the voter's union, or the voter may receive the assistance of two precinct officials who are not of the same political party." HRS § 11-139.

The present bill appears to attempt to mirror the provisions of HRS § 11-139 regarding voting in the polling place, in the context of absentee voting and elections by mail. Additionally, it adds the category of candidates and their Testimony for H.B. No. 1027 February 14, 2013 Page 3

agents to the list of individuals who cannot provide assistance to the voter. Finally, it provides that those who violate the statute will be deemed guilty of an election fraud, punishable by fine and/or imprisonment.

We would defer to the Department of the Attorney General as to whether the inclusion of the category of "a candidate of any office" or their "agent" conflicts or is consistent with federal law, and as to whether they believe any amendments are necessary to facilitate the ability to enforce the provisions of this bill should it become law.

Chair Rhoads, Vice-Chair Har, and members of the House Committee on Judiciary, the Department of the Prosecuting Attorney of the City and County of Honolulu submits the following testimony in support of H.B. 1027.

The purpose of H.B. 1027 is to:

- 1. Require absentee voters to affirm by signature that the ballot was completed in secrecy and without influence from others.
- 2. Require absentee ballots to include information regarding election fraud, voter fraud, and related penalties.
- 3. Prohibit employers, unions, and candidates or their agents from assisting voters with completing absentee ballots.
- 4. Subject special elections by mail to the same requirements as for absentee ballots.

The Department of the Prosecuting Attorney of the City and County of Honolulu discourages employers, unions, and candidates or their agents from assisting voters with completing absentee ballots. Such actions violate a citizen's right to vote on how he or she wishes, and could influence the outcome of an election.

For these reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu supports H.B. 1027. Thank you for the opportunity to testify on this matter.

Chair Rhoads and Members of the Committee:

The Office of the City Clerk has comments on HB1027 and believes that due to the growing popularity of voting by mail, some form of guidance should be enacted for addressing voter assistance that is provided to absentee mail voters.

This bill attempts to address this issue by adding candidates to the category of persons that is prohibited from providing voter assistance. Currently, federal law allows voters to receive assistance from anyone with the exception of their employer, agent of the employer, or union agent. If a similar provision is created in state law, we recommend that it track the language contained in 42 USC 1973aa-6.

Additionally, this measure requires the inclusion of a statement within the vote by mail affirmation that the voter indicate that s/he has not been unduly influenced in casting the vote. Federal law requires a substantially similar statement for military and overseas absentee voters and creating one for regular absentee voters would also presumably educate that person of their right to vote a secret absentee ballot.

We also recommend that provisions in this bill be amended require the retention of absentee voting envelopes for twenty-two (22) months (instead of 48 months) pursuant to the federal Civil Rights Act (which is similar for all election records). Additionally, we recommend that those absentee voting envelopes be maintained by the State Office of Elections since custody of the absentee voting envelopes is transferred to them prior to the election.

Finally, while the Office of the City Clerk would cooperate with any law enforcement agency tasked with investigating infractions, we believe that we are not the appropriate agency for receiving any alleged complaints concerning the prohibited activities. If the measure is to be effective, a mechanism for receiving complaints for this newly created felony offense may be necessary.

Chair Rhoads and Committee Members:

Thank you for the opportunity to testify on House Bill No. 1027. The purpose of this bill is to require absentee voters to affirm by signature that the ballot was completed in secrecy and without influence from others; requires absentee ballots to include information regarding election fraud, voter fraud, and related penalties; prohibits employers, unions, and candidates or their agents from assisting voters with completing absentee ballots; and subjects special elections by mail to the same requirements as for absentee ballots.

Our office takes no position on the Bill but wishes to offer comments concerning various provisions and their impact to our office and operations.

It will be a challenge to implement provisions requiring absentee ballots to include information regarding election and voter fraud, and related penalties since we would be limited to printing this and related information on only one side of the ballot return envelope.

Provisions requiring the County Clerks to secure and store all ballot return envelopes for two General Elections (48 months) exceeds federal requirements in 42 USC § 1974, which specify a twenty-two month retention period. The increased retention period and the ever increasing numbers of absentee mail voters will eventually create logistical issues for the Counties.

Chair Rhoads and members of the House Committee on Judiciary, thank you for the opportunity to offer comments on House Bill No. 1027. The purpose of this measure is to require absentee voters to affirm by signature that their ballot was completed in secrecy and without influence from others; requires absentee ballots to include information regarding election fraud, voter fraud, and related penalties; prohibits employers, unions, and candidates or their agents from assisting voters with completing absentee ballots; extends the retention period for ballot envelopes; and subjects special elections by mail to the same requirements as absentee ballots.

The Office of the County Clerk (Clerk's Office), County of Maui, provides the following information for the consideration of the committee.

The requirements of House Bill No. 1027, will increase the cost of administering elections.

The insertion of an affirmation and "materials summarizing the provisions in sections 19-3, 19-3.5, 19-4, and 19-6" into the absentee envelope will increase the amount of postage required to mail out the ballots and, in our view, distract voters from the actual ballot/voting process.

Presently, pursuant to federal law, ballot envelopes are retained for a period of twenty-two months from the date of any general, special, or primary election. 42 USC § 1974. Retaining the absentee envelopes for two general elections will take up scarce warehouse storage space.

With respect to voters needing assistance to vote, Hawaii law is already consistent with federal law by allowing the voter needing assistance to designate a person of the voter's choice, other than the voter's employer or agent of that employer or agent of the voter's union, or the voter may receive assistance at the polling place by two precinct officials of different parties. HRS § 11-139.

Chair Name/Names, Vice-Chair Name or Names, and Committee Members:

The League of Women Voters of Hawaii strongly supports the intent of HB1027, and suggests two amendments to the bill. This measure adds additional safeguards to preserve the integrity of the ballot used in absentee voting and elections by mail, to insure fairness to all voters, and to minimize the opportunity for fraud. It is the League of Women Voters of Hawaii's strong recommendation that our State move to more modern elections administration by 2016, adopting a vote-by-mail program statewide, which makes the precautions described in this measure especially timely. But since many voters in Hawaii are already using absentee ballots, we support the July 1, 2013 effective date for implementation of this bill.

We think the proposed provision requiring absentee voters to affirm by signature that the ballot was completed in secrecy and without influence from others may be confusing or restrictive enough to discourage voting, and think this idea should be dropped from the bill.

The bill also prohibits employers, unions, and candidates or their agents from assisting voters with completing absentee ballots. While it may not be a good thing for these intermediaries to assist voters in completing a ballot, we think the bill should be amended to make the prohibition broader, to include

anyone whom the voter has not freely chosen to assist them. We suggest a more inclusive statement for section (b) of the bill: "Any person who, by use of force or other means, unduly influences an elector to vote in any particular manner or to refrain from voting is subject to a fine."¹

The second amendment we propose is that voters be informed of the ballot secrecy laws, by requiring that **this same statement be printed on each absentee ballot**. The reason for printing it on the ballot is so everyone knows about the law and can refer to it if necessary.

We concur with the penalties for violation of Section 15-b (illegally assisting voters in completing an absentee ballot). We urge you to pass this bill. Thank you for the opportunity to submit testimony.

Dear Chair Rhoads, Vice Chair Har, and members of the House Judiciary Committee:

Common Cause Hawaii supports HB1027. This bill would establish several precautionary measures to help deter voter fraud and voter coercion, such as: requiring absentee voters to affirm by signature that the ballot was completed in secrecy and without influence from others; requiring absentee ballots to include information on election and voter fraud, and related penalties; prohibiting employers, unions, and candidates from assisting voters with completing absentee ballots.

In light of the Governor's intent to move Hawaii to an all-mail voting system, we must ensure that further measures are taken to not only prevent voter fraud, but that unknowing citizens are aware of what voter fraud entails, and what its penalties are.

Common Cause Hawaii supports HB1027, but has the following suggestions:

• Section 1: We suggest the *addition* of: (4) a member of a noncandidate committee, or a member of a political candidate's campaign during the current election cycle

Currently, Section 1 lists three types of persons who should not assist a voter in completing her/his absentee ballot.

While the HB1027'S proposed Section 1 includes the "and their agents," we believe that language is not strong enough to specifically indicate that members of a political candidate's campaign committee should not be assisting should not be assisting a voter in completing an absentee ballot.

- Section 3: We suggest *eliminating* the first proposed line in Section 3 from the bill (which would require voters to affirm by signature that the ballot was completed in secrecy and without influence from others). *We feel that the proposed provision is confusing and unnecessary.*
- Section 3: We recommend that the second proposed line (which proposes the inclusion of information regarding election fraud, voter fraud, and related penalties) *be made available in multiple foreign language translations* consistent with the other languages for which elections materials are printed in.

Voter intimidation and coercion can happen both in in-person polling places as well as in voteby-mail. It is up to us, and the Legislature, to ensure that we address this, and establish precautionary measures to prevent and minimize voter coercion in future elections.

Honorable Chair Rhoads and committee members:

I am Kris Coffield, representing the IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 150 local members. On behalf of our members, we offer this testimony <u>in support of HB 269</u>, relating to elections.

Sometimes, elections foster unintended consequences, highlighting discrepancies in our electoral law that we may not know exist. Such was the case in 2012, when a hotly contested race for the District 30 House seat, waged between Nicole Velasco and Romy Cachola, became the subject of post-election controversy amidst concerns of voter intimidation. Cachola, who won the race by 120 votes (51 percent to 46 percent), relied more heavily on nail-in absentee voting than any other primary candidate running for public office, earning over 70 percent of his vote total through mail-in votes (mostly from one precinct, 30-02). According to at least one family living in the district, Cachola pressured an elderly woman to cast her ballot in his favor. In a Civil Beat story entitled "Concerns of voter intimidation raised in Cachola victory, published on August 16, 2012, reporter Chad Blair wrote:

The grandmother said she received her ballot on July 28. The next afternoon, Cachola visited the home when the grandmother was with the friend of a family member who did not speak Ilokano, and didn't understand what Cachola and the grandmother were talking about.

The grandmother said Cachola just kind of barged in.

"He was already in the house, saying, 'Nana, did you receive the ballot?" she told Civil Beat in English. "I was getting ready to leave to go to a party, but he would not leave. 'No, Nana, two minutes, sit down with me."

"He forced me to sit down," she said. "He said, 'Did you receive your ballot?' Yes. 'Where is it?' So I took it and opened it. He then said, 'Two minutes, you can do it now.' He would not go until I finished."

The woman handed the ballot to Cachola, who opened it.

"And he just like forced me to do the voting in front of him, and I did not want to. I told him, 'I have to go, I know what to do.' So I stopped what I did, then he looked at his name. I scratched it, and he watched me do it all the way until I finished."

The woman said Cachola then told her to put the ballot in the state Elections Office envelope, to seal it and then give it to him to mail. He then left the house with the ballot in hand.

We don't wish to cast aspersions on any representative or their campaign for public office. To be clear, Cachola has never been found guilty of election fraud and we are not accusing him of that in our testimony, suggestive as Civil Beat's story may be. Instead, we feel that the questions raised with regard to District 30 electioneering evince a need to clarify state law about what constitutes voter intimidation and/or election fraud, thereby preventing these activities from tainting future campaigns and empowering election and law enforcement officials with the legal tools necessary to prosecute those who would corrupt our system of governance.

IN SUPPORT OF HB1027

I have a talk show on 'Olēlo. I devoted much of 2012 encouraging new people to run for elective office. A appeared as a guest on my show. In the primary, A narrowly lost. Before sending a comforting and encouraging e-mail, I decided to review and analyze the election results in detail. Here's what I found:

The results were consistently in favor of A, except one reporting district - Precinct #2 Mail. If you removed Precinct #2 Mail, A would have won (approximately 70%-30%). In fact, the mail-in ballots for Precinct #2 were roughly the same percentage as the other reporting districts - only reversed. My initial thought was, "The totals must have been posted incorrectly." I notified A that there might be a posting error.

Her response caused me to dig further. I found: 1) it was common knowledge of a longstanding practice that B "assisted" senior voters in completing mail-in ballots; 2) this district included many immigrants; 3) these immigrants came from a part of the world where to report election irregularities could cost you your life; 4) voters were hesitant to come forward.

On behalf, not only of aspiring candidates, but all immigrant voters, please pass this bill. It is crucial to our form of government that elections are open and fair. Therefore, it is imperative that the legislature respond swiftly when abuse is uncovered.
