I don't live in Kahala, I'm not a member of a neighborhood board or any other governmental body, and I didn't participate in any way in drafting this bill. However, I support it and urge you to vote in favor of passage.

Passage of this bill won't help only Kahala, either. In Hawaii Kai, where I live, the scars of Genshiro Kawamoto's real estate activities during the 1980s are still visible. For decades, Mr. Kawamoto has bought up properties by the dozen, deliberately run them down, paid his small fines for doing so, kept right on buying, and kept right on running down. I don't claim to understand his business plan, but it's clear that he considers the fines only a cost of doing business. To deter operations like Mr. Kawamoto's will take something more effective than a fine — something, for instance, like a law providing for personal liability.

I am writing you to let you know that I support the House Bill 1106. As you know in recent years many homes along Kahala Ave. have been in disrepair, and are now starting to impact the safety, as well as the overall appearance of the neighborhood. It is at a point where there is rubble, and often times dead vegetation on public walkways and right of ways to our beaches. Many of these homes are also covered with graffiti. It is so bad that recently I was at Kahala beach and some tourists, visiting with their young children, asked me if this was a safe neighborhood. This was due to the condition of the properties, along with the graffiti, they encountered on their walk down to the beach.

In addition, some of these homes have been rented out for \$1 per year, which I have no problem with.
