Subject: House Bill No. 111, HD 1 Relating to Sustainable Alternative Building Code

The Department of Planning and Permitting (DPP) **does not object** to House Bill No. 111, HD 1 if it <u>applies only to counties with a population less than 500,000.</u> The bill would permit the development of "sustainable living research sites" that can be granted exemptions from certain State and County regulations to stimulate research and development of sustainable living ideas, concepts, and innovations.

DPP is an advocate of long-range, sustainable planning, as evidenced by our successful Oahu General Plan and Regional Sustainable Communities Plans. However, this measure is an infringement of home rule and the County's zoning authority established by Section 46-4, Hawaii Revised Statutes.

Moreover, we are not convinced that using a New Mexico model is appropriate for Honolulu. Our topography, economies, and settlement patterns are different. For example, Taos County, which is mentioned in the Bill, has an average population of 15 persons per square mile. In contrast, Honolulu has a density of 1,587 persons per square mile, and as you know, land available for human use is not available in vast amounts. Not only would finding suitable sites for experimental projects be challenging, but to create adequate buffers between them and existing developments may be problematic. Lastly, while we understand that the incentive of regulatory exemptions may be appealing for experimental projects, to be successful in the long run, these projects should comply with regulations at the onset. Re: Testimony in Support of Sustainable Living Research Act (SB 361/HB111)

Aloha Chair McKelvey , Vice Chair Kawakami and Members of the Committee:

I am writing to provide testimony in strong support of the Sustainable Living Research Act (SB 361/HB111). I am an environmental attorney in private practice and I served on the City and County of Honolulu's Sustainable Building Task Force from 2010 to 2012. I have also worked with individuals and non-profits operating organic farms and looking to develop sustainable living demonstration sites.

The Sustainable Building Task Force examined the limitations of current building codes and spent a considerable amount of time discussing the need for pilot projects, such as those that would demonstrate the benefits of using local and reused building materials, composting toilets, and greywater systems. This Bill does just that by establishing a permit process to allow people to practice and develop sustainable living methods and technologies while maintaining State and county oversight.

The Hawaii 2050 Sustainability Plan sets forth a number of goals and strategic actions aimed at creating a sustainable future for Hawaii, including increasing local food production, the reuse and recycling of "waste" materials, and affordable housing, as well as reducing reliance on fossil fuels. Permitting ecologically sound land uses and building methods is key to advancing these goals.

In 2007, New Mexico adopted a similar State law and is now one of the world leaders in sustainable living models. If the State encourages innovation through such measures as the Sustainable Living Research Act, Hawaii, too, can be a world leader.

Thank you for voting in favor of the Sustainable Living Research Act.
