Dear Chairperson Evans,

My testimony asking for your support of this Sustainable Living Research Bill (HB1111) is written on behalf of the Hawaii Sustainable Community Alliance. We are a Hawaii non profit with over 520 members and have been in existance for less than three years. Our mission is to promote legislative solutions to alleviate the legal obstacles that presently exist to the research and development of sustainable living practises in Hawaii.

This problem exists in most other States and steps have been taken and are being taken to adopt similar laws elsewhere across the USA. The State of New Mexico passed it's Sustainable Development Testing Site act in 2008 and this is the model upon which our Bill is based.

We are proposing the establishment of designated sites around the County of Hawai'i that will facilitate unencumbered testing of autonomous and sustainable living systems including but not limited to energy, water, food, sewage, heating and cooling, bio-fuels and building with recycled and renewable materials.

In the coming years, as resource scarcity and population increase continue, these research sites will bring about the emergence of new methods of living that will profoundly affect the quality of life for all members of both the public and private sector.

Currently, no other venue exists that encourages this level of research. Instead, by virtue of the existing paradigm sustainable development is often inhibited.

Sustainable Living Research Sites will cause new systems and inventions to occur at a more rapid rate, thus contending with the rate of resource depletion and population increase. These sites will provide a working template not only for the State of Hawaii but also for the US. The passage of this bill will add to Hawai'i's long history as a pioneer in the area of long-range planning. In the words of State Auditor Marion Higa "The visionary Hawai'i State 2050 Sustainability Plan and its related functional plans were among the first planning documents in the nation that provided integrated, far-reaching policies for the economic, social and environmental future of an entire state." The bill we are proposing will complement this effort.

The purpose of this bill is to allow and encourage privately or publically funded sustainable projects to research new low impact ways of living. This bill will create a "doorway" through the current limitations of traditional codes to support the development of more sustainable methods of living, allowing greater implementation of County and State sustainable living policies.

The potential benefits for the State of Hawai'i, rural and urban areas, and Hawai'i people in general are numerous, including:

a) Reduced dependence on fossil fuels and the co-generation of renewable energies.

r) Innovative systems for the education of children and the life-long learning of adults.

s) Improved health and well-being of both individuals and communities through education, preventive practice and integrated health centers.

t) Alternative models for collective decision-making and self-governance.

u) Strategic planning methods critical to evolving infinite sustainability including: shared vision, collaborative partnerships, issue analysis, action plans, implementation and monitoring, and evaluation.

v) Leadership in the development of new, cutting-edge sustainable growth strategies.

This revolutionary community structure provides me with invaluable support that I could never duplicate in a traditional neighborhood setting. The problem is that our homes are threatened because what we have created here is so innovative and advanced that our current archaic laws have not caught up with us. This is where we need YOUR help! Please know that we are not alone. There are dozens of such intentional communities sprinkled throughout Hawaii. Most are too fearful of condemnation and retaliation to advocate for themselves. In these times of ecological and political distress and uncertainty, we have a strong need for sustainability pioneers. We are stepping forward into that role. We need support from our local and state government so that we can continue to experiment and innovate vital community building dynamics in order to provide valuable solutions for our future...a sustainable future. I am writing to provide testimony in strong support of the Sustainable Living Research Act (SB 361/HB111). I am an environmental attorney in private practice and I served on the City and County of Honolulu's Sustainable Building Task Force from 2010 to 2012. I have also worked with individuals and non-profits operating organic farms and looking to develop sustainable living demonstration sites.

The Sustainable Building Task Force examined the limitations of current building codes and spent a considerable amount of time discussing the need for pilot projects, such as those that would demonstrate the benefits of using local and reused building materials, composting toilets, and greywater systems. This Bill does just that by establishing a permit process to allow people to practice and develop sustainable living methods and technologies while maintaining State and county oversight.

The Hawaii 2050 Sustainability Plan sets forth a number of goals and strategic actions aimed at creating a sustainable future for Hawaii, including increasing local food production, the reuse and recycling of "waste" materials, and affordable housing, as well as reducing reliance on fossil fuels. Permitting ecologically sound land uses and building methods is key to advancing these goals.

In 2007, New Mexico adopted a similar State law and is now one of the world leaders in sustainable living models. If the State encourages innovation through such measures as the Sustainable Living Research Act, Hawaii, too, can be a world leader.
