PURPOSE: The purpose of H.B. 1317 is to appropriate funds to support programs that encourage the use of the Hawaiian language and promote fluency of the Hawaiian language in prekindergarten-aged children.

DEPARTMENT'S POSITION: The Department of Human Services (DHS)

acknowledges the efforts of the Legislature to seek measures to promote the use and

fluency of the Hawaiian language in young children.

The Department currently supports existing programs that promote and encourage the use of the Hawaiian language for prekindergarten-aged children. For both the Department's Preschool Open Doors (POD) and Child Care Connection Hawaii (CCCH) subsidy programs, parents are able to choose their provider. For the POD program, there are Hawaiian language preschools that choose to be licensed by the Department, even though according to section 346-152 (a)(4) such programs are exempt from licensure. These programs opt for licensure in order to be an eligible participating provider in the POD program. For the CCCH program, parents may choose a license-exempt provider or a licensed provider. There are children receiving CCCH subsidies who are attending a Hawaiian language program.

The Department notes that some of the Hawaiian language program preschools have difficulty finding staff who meet the DHS licensing educational requirements. These programs may receive waivers for staff qualifications on a case-by-case basis, since the focus of the program is to find staff who can provide the Hawaiian languagebased requirement.

Additionally, there is federal Child Care and Development Funds (CCDF) monies provided to Keiki O Ka Aina (KOKA) via Tribal CCDF funds. The families accessing funds from KOKA would be of Hawaiian descent and may choose to use Hawaiian language programs. The families receiving KOKA subsidies cannot duplicate services with the CCCH subsidies.
