1 EOA's Position: The Executive Office on Aging (EOA) supports the intent of this measure,

2 provided that its enactment does not reduce or replace priorities within our Biennium Budget

3 Request.

4 **Fiscal Implications:** This measure appropriates \$30,000 for FY2013-2014 and \$30,000 for

5 FY2014-15 for the staffing, operation, and convening of the Task Force on Mobility Management.

6 **Purpose and Justification:** Transportation gives older adults and individuals with disabilities a

7 sense of independence and control over their lives. A lack of transportation can lead to isolation,

8 poor health, and decreased well-being, which is common in rural areas where transportation

9 options are scarce. While we support the intent of this measure, we note that the appropriations

10 are not part of the Governor's Administrative package. Should there be surplus funds available,

11 we would be supportive as we agree with the concept of this initiative as this is consistent with
