# In consideration of **HOUSE BILL 1330** RELATING TO THE DIVISION OF CONSERVATION AND RESOURCES ENFORCEMENT

House Bill 1130 proposes to appropriate funds to restore the general fund budget of the Department of Land and Natural Resources' (Department) Division of Conservation and Resources Enforcement (DOCARE). While the Department appreciates the overall concept of this bill as it includes initiatives supportive of our goals and objectives, the Department is nonetheless concerned about the cost implications it will have on the Administration's Biennium Budget Request.

In 2009, due to economic decline, DOCARE's general fund budget was reduced from \$1.7 million dollars to approximately \$500,000, a reduction of about 2/3 of the general fund budget. This resulted in the elimination of eighteen (18) positions, reductions in funds for overtime and current expenses, and the elimination of funding for equipment and motor vehicle replacements. Seven (7) more positions were abolished in July 2010. As a result, DOCARE was left with an operating budget of \$540,000 to patrol the lands under the Department's jurisdiction on six islands, which reach from the top of the mountains to three miles out to sea. This jurisdiction encompasses nearly 1.3 million acres of State lands and 3 million acres of ocean and coastal waters, as well as 750 miles of coastline. It includes state parks, historic sites, forests and forest reserves, aquatic life and its sanctuaries, game management areas, public hunting areas, and natural area reserves. It also includes protecting the public's safety when using natural and cultural resources under the Department's jurisdiction.

In addition to the cost cutting measures (mandating furloughs, implementing hiring freezes, etc) mandated by the Governor, a directive was issued by the Department's Chair at that time, which directed each division including DOCARE to reduce total cost differentials (overtime, night differential, compensatory time, pay adjustments) by 50% from the prior fiscal year. Coupled with the Governor's measures, this directive had a devastating effect on DOCARE's operations.

In order to meet these cost cutting measures, DOCARE was forced to adopt the following:

- Scheduling officers to work during the hours of 6 am to 6 pm, thus eliminating work that created night differential pay.
- Eliminating regular and holiday overtime unless the overtime was reimbursed by other agencies.
- Assigning two officers per vehicle, per shift, to reduce motor vehicle gas/oil/repair costs. While aimed at cutting costs, this measure also limited patrol coverage, response to complaints and requests for service from the public.
- Cutting non-essential programs and services. For example, the after hours live answering service was eliminated as officers were not able to respond to complaints after 6 pm.
- Delaying the purchase of vehicles and equipment (body armor, communications, equipment, ammunition) that are critical to public and officer safety.

Through the generosity of the Legislature, DOCARE received funds from supplemental budget requests approved by the Legislature to purchase body armor for officers and to purchase radio equipment to comply with the Federal narrow banding requirement. DOCARE also received \$250,000 to partially restore its operating budget, however, this amount was not enough to restore the operating budget as a whole.

The Department recognizes that the restoration of DOCARE's general fund budget is essential, so that the Department can continue to enforce Hawaii's natural and cultural resources laws to the fullest extent possible. The Department will continue to pursue federal funding opportunities and explore partnerships with other state agencies, public/private partnerships, and county/state partnerships.

Comments: Our near shore fishery is in trouble. Today, these same resources are estimated to contribute \$800 million in annual revenue to the state, with an added recreational, amenity, fishery, biodiversity, and educational value of \$364 million per year. The Division of Conservation and Resources Enforcement (DOCARE) is the only agency focused on enforcing laws that protect our natural and cultural resources. Everyone know DOCARE is woefully underfunded. Lack of enforcement is a subject brought up at every DLNR rules hearing I have attended. Given this broad scope of responsibility, and the large amount and variety of equipment, training, and manpower needed to effectively carry out DOCARE's mission, it is clear that DOCARE has been critically underfunded for many years.[4] A review of budget worksheets from the last ten years indicates past legislative appropriations for DOCARE have ranged from \$6 to \$8 million dollars annually; by contrast, the Honolulu Police Department – tasked with enforcing state and county laws in Honolulu county only, and primarily in developed or municipal areas – reported a budget of \$224 million in 2010 alone.[5] Clearly, much greater investment is necessary to ensure that DOCARE has the resources to ensure that the laws protecting our natural and cultural resources have actual teeth, and to relieve mounting community concerns regarding the lack of support for DOCARE's important mission. By restoring lost funding to DOCARE, this bill therefore provides a small but critical step in the right direction for investing in the conservation and protection of the resources that the Native Hawaiian community and the larger public rely upon.

# Testimony of The Nature Conservancy of Hawai'i Supporting H.B. 1330 Relating to Division of Conservation and Resources Enforcement House Committee on Finance Thursday, February 21, 2013, 11:00AM, Room 308

The Nature Conservancy of Hawai'i is a private non-profit conservation organization dedicated to the preservation of the lands and waters upon which life in these islands depends. The Conservancy has helped to protect nearly 200,000 acres of natural lands in Hawai'i. Today, we actively manage more than 32,000 acres in 10 nature preserves on Maui, Hawai'i, Moloka'i, Lāna'i, and Kaua'i. We also work closely with government agencies, private parties and communities on cooperative land and marine management projects.

The Nature Conservancy supports H.B. 1330.

There is widespread agreement amongst a variety of stakeholders that Hawaii's fragile environment is in need of improved compliance, enforcement and prosecution of violations of our State natural resource laws. A 2006 State Auditor's report concludes that DLNR Division of Conservation and Resources Enforcement (DOCARE) officers are spread too thin and lack the equipment they need to do their jobs. In a better economy, the Legislature had been able to provide some relief with financial support and an increase in the number of trained officers and equipment but budgets have been reduced during the economic downturn.

Against this backdrop, a number of communities across the state have been organizing themselves to become more directly involved in the care and management of their natural resources, particularly in coastal and near shore areas. Some communities have partnered with DOCARE to raise awareness of natural resource laws and to improve compliance with those laws. With increased community involvement in marine resource management and enforcement, it will help DLNR, DOCARE, and community-based managers to have additionally general funding to support their critical programs.
