And as a co-coordinator of the Kaanapali Makai Watch program, I can attest to the need for enforcement in the region of the Kahekili Fisheries Management Area specifically. This is a priority site at both state and federal levels, and DOCARE has not had a significant presence there, despite a demonstrated need. This is true for many other areas as well, and due to lack of capacity. We have dedicated and engaged volunteers who want to make a difference, but their impact is limited without a DOCARE presence and follow through.

More officers would equal more enforcement of the current rules and regulations. Right now, people are relying on others to "fish responsibly" and not break the current rules, but since the DLNR's officers are hardly to be seen, illegal activities flourish. With the passage of this bill, there will be more officers and thus better protection for our limited ocean reasources.

I am in support of House Bill 1330, and other measures to provide resources for, and strengthen the ability of DOCARE officers to effectively enforce state regulations that protect Hawaii's unique natural resources. As an avid ocean user I have seen the decline in Hawaii's coastal resources over time, and witnessed numerous resource violations within marine protected areas. In living on Hawaii, Kauai, and Maui I have seen how the shortage of DOCARE officers to respond to these calls has allowed repeat offenders to frequent protected areas as their own 'ice box' with no regard to the regulations in place, the health of the resources, or any regard for other people's rights to experience/use the resource.

Through my own experiences as a marine biologist monitoring protected areas I have seen poachers return to a protected area even after receiving a ticket and paying the fine, as the penalty for such violations does not exceed the benefit of fishing. In other words it's worth paying the fine for the fish they can get, and if we do not have the resources for DOCARE to prosecute new and repeat offenders this mentality will prevail and spread. Not only do we need more DOCARE officers in forcing the current rules we need stricter penalties.

Increasing the number of DOCARE officers enforcing these rules will not only help preserve Hawaii's natural resources, but it will also generate funds for the states through fines and asset seizures. I fully support HB 1330, and as my elected officials I ask for you to pass this bill and support our DOCARE officers.

In consideration of HOUSE BILL 1330 RELATING TO THE DIVISION OF CONSERVATION AND RESOURCES ENFORCEMENT

House Bill 1130 proposes to appropriate funds to restore the general fund budget of the Department of Land and Natural Resources' (Department) Division of Conservation and Resources Enforcement (DOCARE). While the Department appreciates the overall concept of this bill as it includes initiatives supportive of our goals and objectives, the Department is nonetheless concerned about the cost implications it will have on the Administration's Biennium Budget Request.

In 2009, due to economic decline, DOCARE's general fund budget was reduced from \$1.7 million dollars to approximately \$500,000, a reduction of about 2/3 of the general fund budget. This resulted in the elimination of eighteen (18) positions, reductions in funds for overtime and current expenses, and the elimination of funding for equipment and motor vehicle replacements. Seven (7) more positions were abolished in July 2010. As a result, DOCARE was left with an operating budget of \$540,000 to patrol the lands under the Department's jurisdiction on six islands, which reach from the top of the mountains to three miles out to sea. This jurisdiction encompasses nearly 1.3 million acres of State lands and 3 million acres of ocean and coastal waters, as well as 750 miles of coastline. It includes state parks, historic sites, forests and forest reserves, aquatic life and its sanctuaries, game management areas, public hunting areas, and natural area reserves. It also includes protecting the public's safety when using natural and cultural resources under the Department's jurisdiction.

In addition to the cost cutting measures (mandating furloughs, implementing hiring freezes, etc) mandated by the Governor, a directive was issued by the Department's Chair at that time, which directed each division including DOCARE to reduce total cost differentials (overtime, night differential, compensatory time, pay adjustments) by 50% from the prior fiscal year. Coupled with the Governor's measures, this directive had a devastating effect on DOCARE's operations.

In order to meet these cost cutting measures, DOCARE was forced to adopt the following:

- Scheduling officers to work during the hours of 6 am to 6 pm, thus eliminating work that created night differential pay.
- Eliminating regular and holiday overtime unless the overtime was reimbursed by other agencies.
- Assigning two officers per vehicle, per shift, to reduce motor vehicle gas/oil/repair costs. While aimed at cutting costs, this measure also limited patrol coverage, response to complaints and requests for service from the public.
- Cutting non-essential programs and services. For example, the after hours live answering service was eliminated as officers were not able to respond to complaints after 6 pm.
- Delaying the purchase of vehicles and equipment (body armor, communications, equipment, ammunition) that are critical to public and officer safety.

Through the generosity of the Legislature, DOCARE received funds from supplemental budget requests approved by the Legislature to purchase body armor for officers and to purchase radio equipment to comply with the Federal narrow banding requirement. DOCARE also received \$250,000 to partially restore its operating budget, however, this amount was not enough to restore the operating budget as a whole.

The Department recognizes that the restoration of DOCARE's general fund budget is essential, so that the Department can continue to enforce Hawaii's natural and cultural resources laws to the fullest extent possible. The Department will continue to pursue federal funding opportunities and explore partnerships with other state agencies, public/private partnerships, and county/state partnerships.
