# **TESTIMONY IN SUPPORT OF HB 1330**

Aloha Chair Luke and Members of the Committee:

The Sierra Club, Hawaii Chapter, with over 10,000 dues paying members and supporters statewide, respectfully *supports* HB 1330. This measure restores resources and staffing to the Division of Conservation and Resources Enforcement (DOCARE) back to prior levels.

The January 2006 auditor's report of DOCARE found that "Hawai'i's resources have deteriorated through overuse or abuse and from factors such as agriculture, grazing, and urban and residential developments. Examples of deterioration include the decline in coastal water quality, decrease of inshore marine resources, endangerment of inshore ecosystems by alien seaweeds, decline of coral reefs, and increase in the number of impaired streams. Similarly, our cultural resources have also been abused and suffered deterioration."

While the auditor blamed poor management, institutional problems, and the lack of performance indicators for much of DOCARE's ineffectiveness, it was made clear that the resources and staffing of the division have not matched the increasing level of conservation enforcement workload – estimated by the report as having grown by as much as 50% over the past ten years. While the Administration needs to firmly address the management weaknesses within the DLNR, the Legislature must provide the proper level of resources and staffing to ensure that DOCARE can get their job done.

We encourage this Committee to move this measure forward.

My name is Kevin Chang and I personally support the restoration of DOCARE funds to pre-recession levels. It is a small step in the right direction.

Comments: I have spent the last 8 years working closely with a non-profit conservation group that helps to protect the Pupukea Marine Life Conservation District (MLCD), regarding the reduction of illegal activities within the MLCD. I have work close enough with the DOCARE officers and supervisory staff to know that funding is the number one issue regarding the resources necessary to effectively enforce the laws within their jurisdiction. Our natural resources are under constant threat and to hear that only one officer is patrolling from Kaena point to Kahuku is a disgrace. When citizens call the DOCARE violation hotline and are told there is no officer available, or if they call after hours and get a voice recording, it frustrates the caller, increases the probability of conflict if the citizen feels they must intervene because they are tired of watching violations occur with no response from DOCARE. Hawaii relies on tourism and if we cant find the funds to protect what the people come to enjoy, then what is the department even there for.
