My name is Donald Straney, Chancellor at the University of Hawai'i at Hilo. We support the intent of HB1446. To meet the goals of the University of Hawai'i Graduation Initiative, the UH Hilo Strategic Plan, and the Hawai'i Papa O Ke Ao initiative to become a model indigenous-serving institution and maintain our status as a federally-designated Native Hawaiian-serving institution, permanent funding is needed to improve and expand our capacity to serve Native Hawaiians and Native Hawaiian programs at UH Hilo. This request is consistent with and expands upon the University of Hawai'i Board of Regents approved budget.

We support HB1446 provided it does not adversely impact other programs, priorities or our operating budget.

Aloha Representative Hanohano and Members of the House Committee on Ocean, Marine Resources And Hawaiian Affairs, I am Keiki Kawai'ae'a, the Director of Ka Haka 'Ula O Ke'elikōlani college. Ours is the state Hawaiian language college - distinguished by its use of Hawaiian as the language of internal operations and administration.

On behalf of our college, we want to thank you for this opportunity to express support for this bill HB 1446 which addresses the growth of Ka Haka 'Ula O Ke'elikōlani and the Native Hawaiian student population at UH-Hilo.

East Hawai'i is known for having an especially large Native Hawaiian population. We have several Hawaiian Homesteads and also other strongly Native Hawaiian communities, such as Lower Puna. UH-Hilo recognizes its responsibility to the Native Hawaiian population in its long-range plan. Funds are needed to support those students served by the Kīpuka Native Hawaiian Student Center for the entire campus.

My own college, Ka Haka 'Ula O Ke'elikōlani, is a second area of unique need and one also designated for attention in the UH-Hilo strategic plan. In 1997, the Hawai'i State Legislature passed legislation mandating that there be a college at UH-Hilo conducted through Hawaiian. The mandate was to addressing unique needs of students educated in Hawaiian in the public schools. The mandate was an ambitious one - to provide a full P-20 system of education through Hawaiian.

I am happy to report that we have met your mandate and continue to impact the increasing numbers of Hawaiian language speakers, students and families through our infant-toddler through Ph.D. efforts. For example our statewide laboratory school program is serves nearly 900 students preschool to grade twelve. Our campus major count at UH-Hilo is approximately 200 students.

Our growth has been extremely rapid. Before we became a college, there were no graduate programs at UH-Hilo. Our Hawaiian programs were the first masters and also the first doctorate at UH-Hilo. We have grown from one B.A. to two B.A. programs and in addition, offer two

M.A. programs, plus a Ph.D., and a graduate teaching certificate. Our Hale Kuamo'o Center serves the twenty-two Hawaiian language immersion schools both public and charter and eleven Pūnana Leo schools through its laboratory school agreement.

All of this growth has been positive and allows us to serve the schools across the state and our own East Hawai'i area very well. East Hawai'i has the largest percentage of students in Hawaiian immersion of any area in Hawai'i. 26.8% of the state enrollment is in East Hawai'i. Again, this year the highest percentage of growth for immersion was - the 12.5% growth at our laboratory school Nāwahī in Puna. Nāwahī is also known for the very strong high school graduation and college attendance rates of its students in Hawaiian medium education.

The resources in this bill will allow us to serve the growth our East Hawai'i district. The resources in this bill will allow us to reach out better to other areas of the state its students and families.

The resources in this bill will allow us to serve the growing numbers of Native American and other indigenous students and communities who are seeking to revitalize their precious and endangered language as we have done and continue to do here in Hawai'i.

Mahalo for giving me the opportunity to support HB 1446. Over the years, 'Aha Pūnana Leo has developed a consortium with Ka Haka 'Ula O Ke'elikolani and 'Imiloa Astronomy Center. This consortium has allowed us to further support our mission to revitalize the Hawaiian language in addition to assisting other indigenous communities beyond Hawai'i, such as a conference being conducted in cooperation with the UH Mānoa Linguistic Department in March of this year that brings together participants from other indigenious communities interested in native language revitalization.

Many have benefitted greatly by Ka Haka 'Ula O Ke'elikolani's work in preparing the work force that is needed to support our growing Hawaiian language communities. The College continues to train teachers and develop programs for Hawaiian speaking children and parents that impacts the 'Aha Pūnana Leo and builds the capacity for Hawai'i to truly emerge as a bilingual state.

Funding UH-Hilo, and specifically Ka Haka 'Ula O Ke'elikōlani, is important for our community and the benefits are felt throughout the state, especially in communities with large Hawaiian populations where the Pūnana Leo are located.
