The Administration of the Office of Hawaiian Affairs (OHA) will recommend to the Board of Trustees a position of "<u>SUPPORT WITH AMENDMENTS</u>" for HB1552, which would create an instructional Office of Hawaiian studies within the State Department of Education (DOE) for the purpose of providing instruction to public school students on Hawaiian history, culture, arts and language.

OHA appreciates the spirit and intent behind HB1552, which seeks to provide appropriate oversight and adequate resources to Hawaiian education programs in the public schools, and in particular, Hawaiian language immersion schools. In this spirit, in July 2013, OHA partnered with the Kamehameha Schools to sponsor a one-day summit with representatives from the Hawaiian language immersion community to review the Hawaiian language immersion program and make recommendations to the State DOE for improvement. Participants at this summit indicated a clear interest and desire for appropriate oversight and adequate resources for this program.

The Board of Education (BOE) is also reviwing BOE Policy 2105, the BOE's policy on the Hawaiian language immersion program. OHA looks forward to discussing new oversight structure proposed under HB1552 with the Hawaiian community and stakeholders such as 'Aha Kauleo and requests the opportunity to share the results of those discussions, including recommended amendments, with the committee.
