I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to provide testimony on comments for the concepts in House Bill 1564 Relating to Veterans.

This measure requires the counties to obtain approval from the Office of Veterans Services prior to any action that may impact the State's obligation to establish and maintain Veterans' cemeteries.

The counties have somewhat proven to fulfill most of the requirements of the State and VA National Cemetery requirements. However, the OVS requires that each county should be compliance of federal laws and ask that members of the staff be trained in caring for the veterans cemeteries statewide. OVS would like for the counties to discuss major issues pertaining to the cemeteries should it occur.

The OVS provides comments on the concepts and intent of this bill as long as its implementation does not impact or replace the priorities set forth in the Executive Biennium Budget for Fiscal Years 2015.

Our chapter of 500 retired and currently serving officers of the Uniformed Services strongly supports HB 1564. This critically important bill requires the counties to get approval from the Office of Veteran Services, who manages our state wide network of VA cemeteries, before they can take any action that may negatively impact our VA cemeteries.

We understand that there have been incidents such as when the county controlled water to a cemetery was cut off, leaving it without irrigation. I suppose that county roads could be blocked for repairs or otherwise, denying access to family and cemetery workers.

This is not to deny the county to efficiently and economically manage its assets, just to require them to cooperate with cemetery officials with timely notice of activities and understand the possible impact on these important facilities.
