COMMENTS ON THE PROPOSED LEGISLATION

HB2581 HD1proposes to reconfigure the membership of the State Building Code Council (SBCC), modifies the Hawaii State Building Codes, and requires the adoption of codes within six years among other provisions. A representative (Thaddeus Tomei) from the Elevator Section of the DLIR's Hawaii Occupational Safety & Health Division (HIOSH) sits on the SBCC.

The department supports the intent of the measure and believes the fiscal impact upon the department would be minimal if the measure were enacted.

The DLIR supports the housekeeping amendment to 107-22(3), which changes the DLIR representative to one with significant experience in elevator safety and eliminates "or fire safety". This is consistent with the department's expertise, especially as the State Fire Council also has a member serving on the Council, which is administratively attached to the DLIR. The DLIR defers to other entities on the other specific, substantive portions of the proposal.

The department is in the process of updating the Elevator Standards and has actively participated in the deliberations of the Council. The DLIR <u>strongly supports</u> the Council's efforts to serve as a clearinghouse to help affected parties navigate the various state and county codes and agencies.

> The construction and related industries are often left in the dark to try to make sense of how the various codes relate to each other. The Council serves an important role in trying to improve the compatibility and interrelationship of the codes by serving as a forum where there can be a meeting of the minds.

The Department of Business, Economic Development, and Tourism (DBEDT) offers comments on this bill, which modifies the composition of the Hawaii building code council and funds an executive director's position. We support the intent of this bill, but caution that its passage does not replace or adversely impact priorities indicated in our Executive Budget.

To be more effective, an executive director with appropriate technical credentials in the administrative rule process must oversee and facilitate the work of the Council. Proposed new members of the council include construction industry specialists with expertise on industry practices and the practicality and cost effectiveness of proposed codes.

An expected outcome of the bill's passage would be expedited adoption of the 2012 International Energy Conservation Code. The code provisions should measurably reduce energy use in homes and buildings and move Hawaii closer to its goal of energy independence.

Honorable Members of the Committee:

The Structural Engineers Association of Hawaii (SEAOH) is the local chapter of the National Council of Structural Engineering Associations (NCSEA), and we have over 200 active members in Hawaii. SEAOH has several decades of experience in assisting Hawaii with the development of the technical portions of the building codes. The primary purpose of a building code is to establish design standards for buildings in order to protect public safety.

In 2007, HRS 107 Part II, State Building Code and Design Standards, established a process that requires the maintenance of a periodically updated Hawaii State Building Code for State government projects. It is also used as the starting basis for the local county codes, so that unnecessary divergences between the building code adopted by the counties are avoided. The existing law also permits the counties to make modifications to design requirements in the local county building code without approval of the State Council. The present State Building Code Council takes on the role of a panel of knowledgeable experts and state agencies that have responsibility for the affected regulations under current state law. The 2007 State Legislature found that "The health and safety considerations related to the codes are of statewide interest, especially relating to emergency disaster preparedness."

However, since July 2012, the current process has become stalled without the capability to implement its administrative process requirements, such that presently there are no ongoing administrative activities to modernize building codes, due to the fact that the Council has not been funded since 2008. The State Building Code and its Design Standards are becoming severely out-of-date with the state-of-practice of the national standards used elsewhere in the country by architects, engineers, trade unions, and building officials, as well as the federal government.

We support this bill, HB 1633 H.D.1. It expands the State Building Code Council to include new stakeholders, provides a mechanism for the Council to periodically adopt the editions of national codes most valuable to the state rather than every edition, clarifies the codes under the jurisdiction of the Council, and finally provides an appropriation to fund the administrative rule process required under state law HRS Chapter 91. Therefore, we expect that the passage of HB 1633 H.D.1 will enable the state and counties to adopt current standards for public safety. In conclusion, this bill would make a significant improvement for maintaining public safety and it would bring renewed effectiveness to the process of incorporating Hawaii-specific concerns into our building codes and design standards.

The State Building Code Council (SBCC) was created in 2007 to review and adopt comprehensive suites of national building codes and standards for the State of Hawaii. This unfunded group has been meeting monthly but its effectiveness has been hampered without a dedicated staff to create of Admin Rules. In addition, the current makeup of the council does not include any stakeholders from the construction industry...this measure will fix this oversight.

My name is Gladys Marrone, Government Relations Director for the Building Industry Association of Hawaii (BIA-Hawaii). BIA-Hawaii is the voice of the construction industry. We promote our members through advocacy and education, and provide community outreach programs to enhance the quality of life for the people of Hawaii. BIA-Hawaii is a not-for-profit, professional trade organization chartered in 1955, and affiliated with the National Association of Home Builders.

BIA-Hawaii <u>strongly supports</u> **H.B. 1633 H.D. 1.**, which modifies the composition of the State Building Code Council and adds annual reporting requirements; allows for the staggering of code adoptions and amends code requirements; appropriates funds.

Since its creation in 2007, the SBCC has been operating with no funding. \$250,000 was originally appropriated but was never released. The role of the SBCC is significant to the public health and safety of Hawaii's residents, as well as to provide a forum for all stakeholders to review national codes and discuss and approve those provisions that benefit, and are appropriate for, Hawaii. Funding is critical for the continuance of the SBCC.

H.B. 1633, H.D. 1 also reconfigures the composition of the voting members of the SBCC by adding representatives from the construction industry. According to the International Code Council, at least 45 state building code councils nationwide include representation from the construction industry. The construction industry would offer real guidance on what practically works and what does not, as well as input on the cost of code changes, which can have a tremendous impact on the cost of construction. BIA-Hawaii would never compromise the protection of the public's health and safety in code adoption, but we also believe a cost-benefit analysis should have a place in new codes being adopted.

BIA-Hawaii **<u>strongly supports</u>** H.B. 1633 H.D. 1 and urges your favorable consideration.

The General Contractors Association of Hawaii (GCA) is an organization comprised of approximately six hundred (600) general contractors, subcontractors, and construction related firms. The GCA was established in 1932 and is the largest construction association in the State of Hawaii. The GCA's mission is to represent its members in all matters related to the construction industry, while improving the quality of construction and protecting the public interest.

GCA is in **<u>support</u>** of H.B. 1633, HD1, Relating to the State Building Code, which proposes, among other things, to modify the composition, quorum and duties of the Code Council, clarifies the code adoption process and ensures there are no conflicts with Chapter 444, HRS. Particularly, the measure proposes to amend the membership of the Hawaii State Building Code Council (SBCC) to increase the representation of members of the construction industry and also proposes an appropriation to assist with the administration of the SBCC.

In 2007, the Senate Ways and Means committee recognized the importance of the formation of the State Building Code Council when it said,

[t]he adoption of a uniform set of statewide building codes applicable to one and two family dwellings, all other residential uses, commercial and industrial buildings, and state buildings would make it possible for building owners, designers, contractors, and code enforcers within the State to apply a consistent standard. The health and safety considerations related to the codes are of statewide interest, especially relating to emergency disaster preparedness. Hawaii State Legislature. S. Comm. Rpt. 784, March 2, 2007.

Last session the Senate Committees on Public Safety, Intergovernmental and Military Affairs and Ways and Means recognized the importance of the construction industry's involvement in the State Building Code Council in the Standing Committee Report of H.B. 763, H.D. 1, S.D. 1 (2013) when it said,

> [y]our committees find that representatives from the construction industry should be included on the Council because they will provide valuable input regarding the impacts of code changes on construction projects, costs, and whether materials to meet the new requirements are available in Hawaii. Hawaii State Legislature. S. Comm. Rpt. 1311, April 5, 2013.

The GCA believes that by involving the building industry technical experts on the SBCC, it will expedite the implementation of the codes once they are approved because the people who actually have to construct with the new codes would have been involved in the entire adoption process and are able to bring up any constructability issues from the start. Thus, by adding the builders onto the council, these constructability issues can be addressed while the codes are still being discussed. GCA members have been actively participating on the State Building Code Council and recognize its importance in bringing private industry and government entities together to discuss uniform building codes and regulations, especially if any conflicts may arise.

GCA remains willing to participate on the Hawaii State Building Code Council and requests that an appropriation be allowed in this measure.
