#### HB1662: RELATING TO FARM TO SCHOOL MONTH IN HAWAII

Chair Takumi, Vice Chair Ohno, and Members of the Committee,

The Hawai'i Farm to School and School Garden Hui (HFSSGH) strongly supports HB1662, which will establish October as Farm to School Month in Hawai'i.

The National Farm to School Network broadly defines farm to school as the practice of sourcing local food for schools or preschools and providing agriculture, health, and nutrition education opportunities, such as school gardens, farm field trips, and cooking lessons.

Last year, Governor Abercrombie declared October 2013 as Hawai'i Farm to School and School Garden Month to coincide with National Farm to School Month. Aloha Chair Takumi, Vice-Chair Ohno, and Members of the Committee,

Interest for the idea of a Farm to School Program that includes increased institutional purchasing of locally grown and processed foods, and school learning garden programs is growing across the State of Hawai'i. The USDA's National Farm to School Program is bringing increased capacity across the nation and is working to increase state capacity for local procurement and school learning gardens. Laupahoehoe Charter School on Hawai'i Island was recently awarded a USDA Farm to School Planning Grant.

According to the HFSSGH DOE 2012 School Learning Garden Survey of 413 schools, 43% indicated that they had a school garden used for instructional purposes, 21,577 students participated in those programs accompanied by their 830 teachers growing food on 30 acres of land. The eight schools that weighed their produce grew 4.5 tons of food that was consumed by the children and their families.

HDOE School Food Services is committed to increasing institutional procurement of locally produced fruits and vegetables, meat, and dairy. Today on Hawai'i Island, our children are drinking milk from our local dairies and eating papaya from our farms. We know that locally produced foods are fresher, contain more nutrients, and build our local agricultural economy.

This year, Governor Neil Abercrombie proclaimed October 2013 as the First Farm to School Month in Hawai'i. This coincides with the National Farm to School Month each October. This provides a yearly venue for bringing increased attention to the 100's of school learning gardens, increased opportunities for institutional purchasing, and telling the stories of our local farms, farmers, and value added products.

This past October, we celebrated the first Farm to School Month by initiating the new FoodCorps Hawai'i Program. FoodCorps is Hawaii's newest Americorp program placing Hawaii's young leaders in school learning gardens on three islands. Thank you for your consideration of this yearly celebration of Hawaii's emerging Local Food System.
