I am Major General Darryll D. M. Wong, State Adjutant General and the Director of State Civil Defense. I am testifying in **SUPPORT** of House Bill 1667 HD2.

This bill exempts qualifying totally and permanently Disabled Veterans who are 100% Veterans Affairs (VA) rated from paying the State motor vehicle registration fee. As of November 2013, the Department of Veterans Affairs reported there are 2,203 Hawaii veterans rated at 100% disability.

This exemption would be a small recognition of those veterans who incurred military related injuries and are now rated 100% disabled.

Good morning Chair Luke, Vice Chairs Nishimoto & Johanson and Committee members:

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to support the concept of House Bill 1667, HD2, which exempts qualifying totally and permanently Disabled Veterans who are 100% Veterans Affairs (VA) rated from paying the State motor vehicle registration fee.

It also requires the Office of Veterans Services to report the number of qualifying Veterans to the Legislature and Department of Taxation annually and to change the effective date to September 1, 2014 to give the City Customer Services adequate time to update their computer system for vehicle registration.

As of November 2013 and according to VA metrics for Hawaii, there were 2,203 Veterans rated at the 100% disability rating.

The OVS supports the intent of this measure as long as its implementation does not impact or replace the priorities set forth in the Executive Budget for Fiscal Year 2015.

Permanently disabled veterans were not included.

For these reasons I support of HB 1667, as amended by the Committee on Veterans, Military, & International Affairs, & Culture and the Arts, and respectfully urge this body to exempt qualifying disabled veterans from paying the state motor vehicle registration fee on one of their non-commercial vehicles. I applaud the Legislature for putting forward a bill that will show a small measure of our appreciation for their sacrifices.
- 2. By Act 141 (2008), the Legislature exempted one noncommercial vehicle owned by members of the National Guard, military reserves, and active-duty armed services, including the Coast Guard, who are residents of Hawaii from paying the Motor Vehicle Weight Tax. Permanently disabled veterans were not included, yet they are equally deserving of this exemption.

For the foregoing reasons, I support this measure.

BRIEF SUMMARY: Adds a new section to HRS chapter 249 to provide that any totally and permanently disabled veteran who is: (1) a resident of Hawaii; (2) other than dishonorably discharged from the U.S. uniformed armed forces; (3) determined by the U.S. Department of Veterans Affairs to have a service-connected 100% disability rating for compensation or a service-connected disability rating of 100%; and (4) in receipt of disability retirement pay from any branch of the uniformed armed forces, shall not be required to pay any state motor vehicle registration fees provided the exemption shall not extend to vehicles used for commercial purposes, nor to more than one vehicle of the disabled veteran.

EFFECTIVE DATE: September 1, 2014

STAFF COMMENTS: This measure proposes to exempt one noncommercial motor vehicle owned by disabled veterans who are residents of the state from the state motor vehicle registration fee. The legislature by Act 141, SLH 2008, exempted from the motor vehicle weight taxes, one noncommercial motor vehicle owned by members of the national guard, reserves, active duty armed services, including the coast guard, who are residents of Hawaii.

Inasmuch as the motor vehicle weight tax and registration fees are user charges designed to recover the cost of construction and maintenance of Hawaii's highway system, there is little justification for the proposed exemption. All motorists use the state highways and should, therefore, lend a hand in paying for good and safe roads. Any exemption granted to a select group of users requires that the lost revenues be made up by those who must continue to pay. So while the exemption would provide relief to a disabled veteran, a single mom making minimum wage, barely making ends meet, must continue to pay these fees. Motorists who will have to pick up the additional costs created by this proposed exemption should hold those who would propose such an exemption responsible for raising their taxes.

#### H.B. 1667, H.D.2 RELATING TO VETERANS

House Committee on Finance

The Department of Transportation (DOT) appreciates veterans and respectfully recognizes the merits to reward their sacrifices for duty, honor and country. Lowering fees and charges and anything else that might be helpful to them would be taken into consideration.

The DOT, however, **opposes** H.B. 1667, H.D.2 because it would have an adverse impact on fees that support the operations, maintenance, and construction of our highways.

This exemption for the state motor vehicle registration fee will reduce the revenues deposited into the State Highway Fund. The state vehicle registration fee accounted for 16.5 percent of the total State Highway Fund Revenues for fiscal year 2013 and is estimated to provide the same percentage for fiscal year 2014. Any proposed decrease would have a negative impact on the health of the State Highway Fund.
