The Honorable Chair Sylvia Luke, and Members of the Committee:

The Hawaii State Teachers Association (HSTA) **<u>strongly opposes H.B. 1675</u>**, Relating to instructional time.

HSTA is the exclusive representative of more than 13,500 public and charter school teachers statewide. As the state affiliate of the 3.2 million members of the National Education Association, HSTA strongly affirms its collective bargaining process regarding instructional time.

HSTA believes quality student instructional time requires preparation, delivery, and assessment that is focused and meaningful to achieve quality student learning and growth. Further, HSTA believes that quality student instruction requires adequate time for teachers to plan, articulate, and collaborate. As a result, planning and preparation should be imbedded in the school day. Act 167 does not address this.

Since the passage of Act 167, (session Laws of Hawaii 2010) schools across Hawaii have been working towards implementing a bell schedule to conform to Act 167. Numerous meetings, time, and plans have been spent in order to implement Act 167/52 by the teachers and school officials. The Department of Education (DOE) has also tried to manage a plethora of different bell schedules which all resulted in numerous changes, redefining definitions of instructional time, and revised DOES memos stating issues and errors.

Many secondary (middle and high) schools are having difficulty in implementing their bell schedules to comply with the required 990 hours for SY 2014-2015. Elementary schools are utilizing opening, closing, homeroom, and study hall to count as student instructional time under Acts 167/52.

HSTA recommends the repeal of Act 167 in its entirety. Many schools struggle to comply with this law and that instructional hours should be collectively bargained and not mandated by law.

HSTA strongly affirms its position with the Board of Education to negotiate instructional time.

Thank you for the opportunity to testify in strong opposition to H.B. 1675.

Dear Chair Luke, Vice Chairs Nishimoto and Johanson, and Committee Members:

This testimony is submitted in opposition to HB1675, with recommended amendments.

The Hui for Excellence in Education (HE'E) is a diverse coalition of over 40 parent and community organizations dedicated to improving student achievement by increasing family and community engagement and partnerships in our schools. Our member list is attached.

Act 167, establishing a minimum number of student Instructional Hours and days per year, was passed in 2010 for three primary purposes:

- 1. Prevent future furloughs for students.
- 2. Provide instructional time equity among Hawaii students and their mainland peers.

3. Establish transparency and clarity in the definition and amount of instructional time provided by each school.

Act 167 sent a clear message to the community, that the legislature takes education seriously and that reduction of student instructional time would never again be compromised due to budget issues. All Hawaii students would receive the same amount of instructional time as their peers in Hawaii and on the mainland. All Hawaii families would know that their child receives the same amount of instruction as every other student in the state. Hawaii is unique, the only state that is one school district, with one funding source, and one union contract for all teachers. This should help insure that equity exists across the state. Instructional time for students should be no different. The DOE has undertaken the task of aligning the bell schedules for secondary schools and has made great progress. We support their effort to continue to meet the instructional time goals set forth in Act 167.

Rather than delete the 1080 instructional hours we recommend the following amendments:

- 1. Defer the implementation date until the next bargaining year so that any additional costs associated with increasing the time can be included in that contract.
- 2. Apply the increased time to 1080 instructional hours to secondary schools only, and to 990 instructional hours to elementary schools, which is consistent with instructional time for secondary and elementary schools nationally.

Telephone: 808 926-1530 Contact@HEECoalition.org The process of aligning the secondary schools has been difficult, but the Department of Education (DOE), principals, staff and School Community Councils (SCCs) have worked hard to find schedules that work for their schools. If they wish, schools can, under the law, apply for a waiver. This is an important component of the law and if a school can make a compelling argument for the waiver, the BOE can grant the request. This provides a reasonable option for a school with unique circumstances. Finally, it should be noted that increasing the minimum student instructional time in the future for secondary schools, amounts to an increase from 5 hour 30 minutes to a 6 hour instructional day plus lunch and passing, or an approximately 7 hours day such as 8:00 am - 3:00 pm for students. This still allows time for after school activities, sports, and jobs for students. It would also make Hawaii student instructional time align with or exceed more than 50% of states, which is huge increase from 2010 when our state had some of the lowest instructional minutes in the country.

We strongly encourage you to stay the course with this law, and consider our amendments as a compromise.

Thank you for the opportunity to testify and for your consideration. Our opposition to this bill represents a 75% consensus or more of our membership.

HB1675: Testimony in Opposition with proposed Amendments

Aloha Chair Luke, Vice Chair Nishimoto, Vice Chair Johanson and members of the Committee,

Please do not delete the goal of 1080 hours of instructional time for our students.

We would like to start by commending the Department, principals and SCCs who have been working diligently to comply with the initial phase of this law and are making great progress statewide. It has not been easy, and we want to acknowledge their efforts. Also, it should be noted that the compliance will take place within the existing contract at no additional cost.

In researching the most current data on instructional time in states across the nation, we find that our minimum instructional time, particularly at the secondary level (even with the increase to 990 hr/yr beginning in 2014-15), is still below the minimum time in the majority of states.

As such, we oppose the elimination of the next phase, section (d) of the bill, which further increases the minimum student instructional time.

We request the following amendments which we believe will assist with the next phase.

1. Push the implementation of the 1080 (6 hours/day) to the 2018-2019 school year. This will give the department four years to adjust to the first phase (5 hours-30 min/day) and give the stake holders time to negotiate any necessary contract changes.

2. We support having the Board redefine Instructional Time.

BACKGROUND:

Act 167, establishing a minimum number of student Instructional Hours and days per year, was passed in 2010 for three primary purposes:

- 1. Prevent future furloughs for students.
- 2. Provide instructional time equity between Hawaii students and their mainland peers.
- 3. Establish transparency and clarity in the definition and amount of instructional time provided by each school.

Act 167 sent a clear message to the community, that the legislature takes education seriously and that reduction of student instructional time would never again be compromised due to budget issues. All Hawaii students would receive the same amount of instructional time as their peers on the mainland. All Hawaii families would know that their child receives the same amount of instruction as every other student in the state.

In 2009, with the implementation of furlough Fridays, it became apparent that student classroom time could be a negotiable budget item. Without a state mandate to protect student instructional time or number of days, the state and unions could adjust the number to meet budget requirements. Act 167 protected students instructional time and made it non-negotiable.

During discussions regarding the increase to 1080 hours, it was always suggested that this increase to a 6 hour student day, could require an increase in teacher time, requiring a funding increase from the legislature. For that reason it was originally targeted at the year of a teacher's contract negotiation.

Finally, Act 167 was implemented to bring transparency and clarity to student instructional time statewide. At the time of implementation research from elementary and secondary schools, showed that student instructional time varied considerably, particularly at the secondary level. This, despite the fact, that Hawaii operates as one school district, with one funding source and one contract for all teachers statewide. Now, after four years of research and information gathering, the DOE and the schools are all moving to successfully comply with the law by the 2014-15 school year. This is a great accomplishment, one that should be acknowledged and appreciated. It was also accomplished without additional resources and within the current contract.

Pushing the implementation date forward would align the increase in student instructional time with the next contract negotiation. This would allow the Department and the unions to address any additional costs associated with the increase in instructional time.

Finally, the law does allow for schools to seek a waiver from the BOE. This is an important and valuable option for schools that can demonstrate a need to be exempt.

We encourage you to consider our proposed amendment and we look forward to working with the Committee and the DOE on this issue.

HB1675 - STRONGLY OPPOSE

As a teacher, I am very concerned about the increase of instructional hours. Although I support our Union's (HSTA) opposition because of teacher pay (negotiated vs. mandated), my concern lies with most needy, Federally funded students. Adding more time to the school day will remove essential support to our English Language Learners and students with Special needs. Already, we struggle to fund and retain Educational Assistants and Part Time Teachers. Part Time Teachers cannot work over 17 hours a week. To support our large population of ELLs (1 out of 8 students), we previously hired four PTTs to assist our ELLs in their core classes. With budget cuts, we now have only 3 PTTs. This still did not support every ELL to the capacity that they (teacher and students needed). Currently, our ELLs do not have the assistance they desperately need. With Common Core on the way, and text becoming increasingly more difficult, these students need even more support. Additionally, all students with IEPs will have to have updated IEPs with these additional hours included. As you may know, IEPs need to be attended by a Team, as well as the parent. For only one student, this can take hours to coordinate and complete. Additing minutes onto each day will seriously tax the already stressed resources for our most needy students. When additional minutes are added to the school day, our English Language Learners (ELLs) and students with special needs will be affected.

Please consider the students first and the support that they need in order to succeed.

Aloha, I am Loren Ayresman, a math teacher at King Kekaulike High School (Presidential Awardee for teaching Mathematics in 2005) and I oppose HB1675 due to the following reasons:

- 1) HB1675 will be detrimental to the students it is intended to support.
- 2) HB1675 will increase the dropout rate for our school
- 3) HB1675 does not make sense at the school level.



I teach a wide variety of students, from the very best and brightest, to our most struggling students, and HB1675 hurts both ends of this spectrum. Our highest achieving students lead very busy academic lives. Most of these students take multiple AP courses and participate in many service organizations and extracurricular activities. To say the least, these students are busy. Now my advanced students are worried that they will not have enough time afterschool to finish their homework. As it is, my top students have difficulty keeping up with daily assignments. Assuming that students will do all their homework during non-instructional time is unrealistic given all the meetings and other student leadership responsibilities that go on in high school. Adding more "seat time" will just push them to stay up later at night in order to keep up with school work.

I also coached football, and some of our players would catch the Maui Bus (which runs infrequently compared to the Honolulu bus system) and get home at 9:00 pm after practices. Push practice back by 45 minutes each day, and now this student's schedule gets ridiculous. Because of Title IX, boys and girls soccer (sharing 1 field) and boys and girls basketball (sharing 1 court) often start practice after dinner. HB1675 will move the start time back and students will get home later.

At King Kekaulike High School we currently have a 7 period schedule that allows students to get an "early release" to attend classes at UH Maui campus. HB1675 will force us to revise our bell schedule and eliminate this "early release" program. Now, HB1675 takes away the opportunity for students to earn college credits while still in high school.

This "early release" program also allows students to work during the school day. The students in this program generally are lower income students, who are working in order to help support their family. With the implementation of HB1675, students will now have to make a decision to either stay in school and graduate, or drop out and earn money to support their family. In our community of Upcountry Maui, we have a very strong sense of 'ohana. Given this choice, students will undoubtedly choose to help their family by sacrificing their high school diploma. Our school was recently placed in the "focus" category due to our dropout rate. HB1675 will not help this situation. We should find innovative ways to keep students in school, not generate reasons to drop out.

After talking to my students about HB1675, they would like me to ask you some questions. What kind of chair are you sitting on right now? Is it padded? Is it comfortable? My students would like you to know that student chairs are rigid, hard, and generally uncomfortable. They would like to challenge you to sit in a regular student chair for an hour and feel what they go through on a daily basis. HB1675 would require longer classes (up to 84 minutes), which doesn't sit well with my students (pun intended). Also, in the afternoon, the in class temperature gets warmer. With the BOE adding 1 week of Winter Break, that extends the school year into June, which is warmer than a week of school in January. How much improvement is HB1675 expecting by adding minutes to the hottest part of the day?

Also, HB1675 does not add teacher led "instructional" minutes to the daily schedule. So how does increased time in school without instruction increase student success? According to a 2013 Legislative Report Relating to School Year and Instructional Time http://Irbhawaii.info/reports/legrpts/doe/2013/act52_slh11_13.pdf (Page 5) there is no association between increased instructional minutes and student growth percentage. The data does not support this bill. As I recall, during the year we were furloughed, scores actually increased. The state developed bell schedules include increased study hall time in order to reconcile this situation. Which begs the question, what are teachers supposed to do when their classes are over and study hall begins? Should we announce "OK, class is over. Let study hall begin." When students are in my classroom, I am going to help them, no matter what time it is. To me, during study hall, I am still instructing students. But according to this bill, I am supposed to stop instructing when this "study hall" begins. HB1675 assumes that somehow learning happens in a classroom without instruction. As one of my students asked, " How does sitting in a classroom longer without instruction make us smarter?"

This is just some of the unintended consequences of a bill that seems logical at the legislative level, but is problematic at the school level. If our school required more instructional minutes, we would have added minutes through the School Community Council process years ago. Our school has gained a 6 year accreditation by The Western Association of Schools and Colleges (WASC), and has been recognized by the Washington Post as one of the Most Challenging High Schools in the state of Hawaii.

Testimony by Hawaii Government Employees Association February 21, 2014

H.B. 1675 - RELATING TO EDUCATION

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO supports the intent of H.B. 1675, which repeals the requirement to implement a school year of one hundred eighty days including one thousand eighty instructional hours for both elementary and secondary school grades for the 2016 – 2018 school years. This measure also repeals the definition of "student instructional hours" contained in Section 302A-251 and provides that it be defined by the Board of Education.

While this bill repeals the 1,080 instructional hour requirement for the 2016-2018 school years, this measure does not address the difficulties schools are having in the implementation of the 990 hour requirement for school year 2014-2015. The number of instructional hours does not necessarily equate to an improvement in student achievement and growth. What is important to the educational successes of our children is that they be provided with quality instruction.

This measure also provides that "student instructional hours" is to be defined by the board. The HGEA maintains its position that this matter is subject to negotiations with the exclusive representatives of affected employees. At minimum, this measure should include language that clearly requires that "student instructional hours" be defined by the Board after it completes negotiations with the respective exclusive representatives.

Thank you for the opportunity to testify supporting the intent of H.B. 1675 repealing the requirement to implement a school year of one hundred eighty days including one thousand eighty instructional hours for both elementary and secondary school grades for the 2016 – 2018 school years.

This testimony is submitted in opposition to HB1675, with recommended amendments.

The Hui for Excellence in Education (HE'E) is a diverse coalition of over 40 parent and community organizations dedicated to improving student achievement by increasing family and community engagement and partnerships in our schools. Our member list is attached.

Act 167, establishing a minimum number of student Instructional Hours and days per year, was passed in 2010 for three primary purposes:

- 1. Prevent future furloughs for students.
- 2. Provide instructional time equity among Hawaii students and their mainland peers.
- 3. Establish transparency and clarity in the definition and amount of instructional time provided by each school.

Act 167 sent a clear message to the community, that the legislature takes education seriously and that reduction of student instructional time would never again be compromised due to budget issues. All Hawaii students would receive the same amount of instructional time as their peers in Hawaii and on the mainland. All Hawaii families would know that their child receives the same amount of instruction as every other student in the state. Hawaii is unique, the only state that is one school district, with one funding source, and one union contract for all teachers. This should help insure that equity exists across the state. Instructional time for students should be no different. The DOE has undertaken the task of aligning the bell schedules for secondary schools and has made great progress. We support their effort to continue to meet the instructional time goals set forth in Act 167.

Rather than delete the 1080 instructional hours we recommend the following amendments:

- 1. Defer the implementation date until the next bargaining year so that any additional costs associated with increasing the time can be included in that contract.
- 2. Apply the increased time to 1080 instructional hours to secondary schools only, and to 990 instructional hours to elementary schools, which is consistent with instructional time for secondary and elementary schools nationally.

The process of aligning the secondary schools has been difficult, but the Department of Education (DOE), principals, staff and School Community Councils (SCCs) have worked hard to find schedules that work for their schools. If they wish, schools can, under the law, apply for a waiver. This is an important component of the law and if a school can make a compelling argument for the waiver, the BOE can grant the request. This provides a reasonable option for a school with unique circumstances. Finally, it should be noted that increasing the minimum student instructional time in the future for secondary schools, amounts to an increase from 5 hour 30 minutes to a 6 hour instructional day plus lunch and passing, or an approximately 7 hours day such as 8:00 am - 3:00 pm for students. This still allows time for after school activities, sports, and jobs for students. It would also make Hawaii student instructional time align with or exceed more than 50% of states, which is huge increase from 2010 when our state had some of the lowest instructional minutes in the country.

We strongly encourage you to stay the course with this law, and consider our amendments as a compromise.

Thank you for the opportunity to testify and for your consideration. Our opposition to this bill represents a 75% consensus or more of our membership.

Honorable Chair Luke and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 175 local members. On behalf of our members, we offer this testimony <u>in support of</u>, with proposed amendments for House Bill 1675, relating to education.

While we feel that instructional time requirements should be subject to collective bargaining, we understand that variances in instructional time statewide have precipitated difficulty in evaluating achievement outcomes and that the link between instructional time and student achievement is an evolving science. For assessment purposes, it is important to ensure that all schools operate from the same baseline, which this bill, following Act 167, accomplishes. A number of secondary schools have faced difficulty meeting the 990 student instructional hour requirement currently called for by §302A-251, prompting intraschool debates over school schedules (often resolved by "2+2" hearings), as well as grievances over processual compliance by school administrators. Such problems are likely to be exacerbated if schools are forced to implement greater instructional time requirements (up to 1080 by 2018). Moreover, in May of 2013, the Hawaii State Department of Education scaled back its pilot of extended learning time for lowperforming schools in designated "zones of innovation," signaling a need to ensure that ELT reforms are targeted, strategic, and focused on specific classroom settings, learning objectives, and student populations.

That said, to ensure the participation of teachers and educational officers in redefining instructional hours, we urge the committee to amend the bill's proposed revision of §302A-251(e) to read: "For purposes of this section, "student instructional hours" shall be defined by the board in consultation with the appropriate exclusive representatives," or something to that effect. We maintain that "student instructional hours" are not merely those minutes spent on direct instruction in the classroom, but also include and are not limited to project-based learning, technology-assisted learning, learning assessments, student advisory time, homeroom, directed study, any activity related to a general learner outcome, and statewide performance assessments. The definition also impacts the distribution of instructional time throughout the school day, touching on contractual matters related to bell schedules, the academic calendar, professional development, teacher preparation time, and evaluation protocols. For those reasons, we feel that participation of the exclusive representatives—HSTA and HGEA, specifically—should be mandated by this measure.

My name is Jodi Maeda and I am a teacher at Kaua'i High School. I am writing in strong opposition to HB1675.

As a teacher who works above and beyond my contract hours on a daily basis, it is very frustrating to me when I am continually asked to do more and more in my classroom with increasingly less time and resources. There are several things that are required when delivering a quality lesson to my students - time to plan, time to collaborate with my colleagues, and quality resources to create that lesson.

HB1675 would require me to teach more, without increasing my planning time or collaboration time. Do you think that would make me more effective or less effective? High school teachers have an average of 45 minutes daily to prep. We have over a hundred students each. It is not even possible to grade the papers for 50 students in that prep period, let alone, plan the upcoming lessons.

Yes, we can request planning days - if we are willing to have a sub teach our classes. Sub plans require additional prep time. Re-teaching our students after a non-highly qualified substitute has taught the lesson takes up additional instructional time.

I could give you many more examples of how little time we have to actually plan for quality instruction. However, I would like you to think about something else...

You can say "well, you knew that you would have to work extra when you became a teacher...it's part of the job...etc." Is that what we should tell the college students who want to become teachers? "Be prepared to work more and more extra hours for free, because 'it's part of the job'?"

When are we going to start treating teachers like professionals? How can we attract quality teachers into the profession, when we expect them to continually do more and more with less?

I know a number of extremely good teachers who are leaving the profession, because they just can afford (both financially and with their time) to stay in the profession. They are tired of sacrificing EVERYTHING just to be considered an "effective" teacher.

Please stop passing legislation that requires us to keep doing more with less. Allow these issues to be negotiated so that teachers can be fairly compensated for all the things they are required to do. Please support the REPEAL of Act 167 and OPPOSE HB1675.

significantly more difficulty. This may cause compliance issues.

Self-Contained classroom teachers in special education will not only have difficulty with taking their lunch, and recess as is currently the case, they will now need to fissure out what to do with students during their

prep, The allocation of EA's time will need to be longer as the students

are on campus longer and thus stretching our limited resources and possibly costing the department to contract more paraprofessionals.

What is the benefit to the students? They will have time in their day for study hall, which is not intended to be instructional time, just supervisory.

The idea of schools adding an extra hour every day to their schedule, and eventually raising that additional time to an hour and a half might sound good initially to parents and the community, but people must realize that simply lengthening the school day is NOT the answer. In fact, it leads to serious problems. I am a public school teacher. The vast majority of my students are working after school, involved in clubs or sports, or in marching band. Many get home, regularly, at 8pm and then start on their homework. If the school day is lengthened they will either face the choice of dropping out of extra-curricular activities they love or coming home extremely late and being too tired to fully devote their time to school work. Why has no one considered the busy after school lives of high school students? Why does no one address the fact that parents and community support are really the key issues that can improve a student's education? Unless parental and community roles and expectations are also changed, education and the school system will not have better results simply by adding on to the school day.

Let's think back to how this whole fiasco started. Linda Lingle instigated and pushed for furloughs. The public turned on the idea. Then, to over-compensate, she and Duke Aiona swung the other way and made a big deal to lengthen the school day. Just because furloughs were a bad idea, going to the other extreme is not necessarily the answer. Also, how will the state fairly pay teachers for this HUGE increase in time? Are we, unlike any other profession, going to be expected and demanded to basically work for free? Teachers should not be expected to just "suck it up†because there are students involvedâ€"we are professionals and this is a job. H.B. 1675 - RELATING TO EDUCATION

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO supports the intent of H.B. 1675, which repeals the requirement to implement a school year of one hundred eighty days including one thousand eighty instructional hours for both elementary and secondary school grades for the 2016 – 2018 school years. This measure also repeals the definition of "student instructional hours" contained in Section 302A-251 and provides that it be defined by the Board of Education.

While this bill repeals the 1,080 instructional hour requirement for the 2016-2018 school years, this measure does not address the difficulties schools are having in the implementation of the 990 hour requirement for school year 2014-2015. The number of instructional hours does not necessarily equate to an improvement in student achievement and growth. What is important to the educational successes of our children is that they be provided with quality instruction.

This measure also provides that "student instructional hours" is to be defined by the board. The HGEA maintains its position that this matter is subject to negotiations with the exclusive representatives of affected employees. At minimum, this measure should include language that clearly requires that "student instructional hours" be defined by the Board after it completes negotiations with the respective exclusive representatives.

Thank you for the opportunity to testify supporting the intent of H.B. 1675 repealing the requirement to implement a school year of one hundred eighty days including one thousand eighty instructional hours for both elementary and secondary school grades for the 2016 – 2018 school years.

As many hard-working and dedicated public school teachers, I strongly oppose this bill. My biggest argument stems from quantity not equating to quality. It seems that the purpose of this bill is to placate voters. However, I am a voter and so are some 13,000 teachers. Mandating a random number of instructional hours does not equate to improved student achievement. Increasing the cook time for a lasagna does not give you a better tasting lasagna, it gives you burnt lasagna. The effect will be the same for students, teachers, administrators and all others who are a part of a studentÊs educational experience at our public schools.

Why are these types of decisions being made by non-educators, many of whom sit on the Board of Education? (who according to the language in this bill will be the entity that will determine specifics.) Like ACT 167, this is a flawed methodology in educational reform. Legislation should focus on working to ensure that fiscal resources are being used effectively and are actually reaching students. Most teachers I know spend countless hours beyond current instructional hours working with students who need the extra help and providing students with activities and experiences that enhance their educational experience. Purpose of Bill:	Requires all public secondary schools to implement a school year that includes nine hundred ninety student instructional hours beginning with the 2014-2015 school year. Repeals the requirement that by the 2016-2018 school years, all public schools implement a school year of one hundred eighty days and one thousand eighty student instructional hours for both elementary and secondary school grades. Clarifies that the definition of "student instructional hours" shall be determined by the board of education.

Department's Position:

The Department of Education supports HB 1675 which proposes to repeal the SY 2016-2018 requirement for 1,080 student instructional hours, and also makes other conforming amendments to Section 302A-251. The Department has found that it is a challenge for schools to meet the requirements of Section 302A-251 (known also as Act 167/Act 52) in the context of the current Collective Bargaining Agreement and the Department's budget.

The Department also supports repeal of the definition for "student instructional hours" that is contained in Section 302A-251 and to instead, require that the Board of Education determine the definition. The Department recognizes the need for clarification of the definition to avoid unnecessary and differing interpretations and will work with the Board to provide a clear definition of student learning time that includes all high-quality learning opportunities.
