### In consideration of HOUSE BILL 1679 RELATING TO THE DIAMOND HEAD SEAWALL

House Bill 1679 proposes to appropriate \$3,000,000 for Fiscal Year 2014-2015 to the Department of Land and Natural Resources (Department) for planning, design, and construction costs for the repair and maintenance of the Diamond Head seawall. **The Department opposes the bill.** 

As the bill notes, litigation in the First Circuit Court over the ownership of the Diamond Head seawall recently resulted in a court opinion finding that "the State owns the Seawall and the real property under Seawall by surrender and/or has an easement over and across the Seawall by implied dedication . . . ." No final judgment has yet been entered in the case. The Department of the Attorney General is evaluating the opinion, and will evaluate the judgment when it is issued, to determine whether an appeal of the Circuit Court's ruling is appropriate. Until that time, any appropriation for repair and maintenance of the seawall would be premature.

- Diamond Head sea wall is 100 years old and provides lateral and direct ocean access to residents and visitors alike.\* Access has been uninterrupted for 100 years. The Diamond Head sea wall is a cultural, historic and recreational treasure for the State of Hawaii.
- The Court recently ruled that the Diamond Head sea wall is owned by the State of Hawaii in Civil No. 07-1-1122.
- Diamond Head sea wall has not been well maintained for many years. It needs engineering evaluation and pedestrian improvements. Public safety is paramount.

Re: House Bill 1679 relating to Diamond Head Seawall

Allow me to support HB 1679 relating to Diamond Head Seawall. On November 29, 2013, a Hawaii Circuit Court opinion stated that the Diamond Head seawall and the real property under the seawall is owned by the State of Hawaii.

Thus, the State has the responsibility to maintain the seawall and has on-going liability should there be a mishap on the seawall. Please note that the State of Hawaii has in the past, after Hurricane Iwa (1983-1984) repaired the seawall with State funds. Please note further that the seawall has been a public throughfare for at least half a century.

Given the above, the State of Hawaii should accept responsibility for the repair and maintenance of the seawall.
