I. OVERVIEW OF THE PROPOSED LEGISLATION

H.B. 1737, HD1, proposes to provide an appropriation of \$700,000 to the Office of Community Services (OCS) to support the expansion of the newly-created State-funded Immigrant Resource Centers, contracted by the Office with nonprofit service providers, for language-accessible direct information and referral services to new immigrants. In addition, the measure requires OCS to consider and report to the Legislature on the following: a) the current process for solicitation and administration of the grants-in-aid programs; the feasibility of handling the processing of all of the grants-in-aid requests; and recommendations to streamline the grants-in-aid process.

II. <u>COMMENTS ON HOUSE BILL 1737, HD1</u>

The Office of Community Services (OCS), established in 1985 by Act 305 and codified as Chapter 371K, Hawaii Revised Statutes, serves as the lead agency in State government to facilitate and enhance the development, delivery, and coordination of effective programs for the

economically disadvantaged populations, including immigrants and refugees. OCS administers and delivers Federal and State funded programs through purchase of service contracts with non-profits.

OCS has long recognized the long view that investing in immigrants has a positive effect on Hawaii's economy and society. The ability of immigrants to achieve successful social integration and economic self-sufficiency is enhanced by providing them with languageaccessible entry points or "portals" to a wide range of information on acculturation training, job training, job placement, health and social services to strengthen their families. The Immigrant Resource Centers, established in strategically located areas, provide wrap-around services, including outreach, intake, information and referral to a comprehensive array of services. The Centers are currently located in the following geographic areas: Hilo, Hawaii; Kapaa, Kauai; Kalihi and Ewa Beach, Oahu. The proposed appropriation would provide additional funds for the expansion of services to other underserved areas such as: West Hawaii, West Kauai, and Waipahu.

OCS supports the measure, as amended, provided it does not supplant the Administration's budget package for FY 2015. Accordingly, OCS accepts with full intention to comply with the requirement to consider and report on the current administration of the Grantsin-Aid (GIA) program, the feasibility of handling and processing of all GIAs, and recommendations to streamline the GIA process.

Catholic Charities Hawai`i (CCH) strongly supports HB 1737, HD1. We ask that additional funding of \$700,000 be provided through this measure and designated to the current Immigrant Resource Center providers:

- \$200,000 Hawaii (Catholic Charities Hawaii)
- \$100,000 Kauai (Child & Family Service)
- \$400,000 Oahu (\$200,000 each for Susannah Wesley Community Center and Parents and Children Together)

CCH is a tax exempt, non-profit agency that has been providing services to immigrants and refugees for more than 30 years and has witnessed the struggles that our newly arrived neighbors go through to understand and navigate our system of government so that they can access the resources that they need to successfully transition to life in Hawai'i.

In August, 2013, CCH opened an Immigrant Resource Center (IRC) in Hilo, Hawaii to serve as the "first stop" for immigrants, migrants, and low-income persons to improve access to needed services, resources, and benefits with the goal to increase economic self-sufficiency and eliminate barriers to social adjustment. The program has primarily assisted migrants from the Compact of Free Association (Chuuk, Palau, Marshall Islands). In addition immigrants from the Philippines, Mexico, Thailand, Costa Rica, Portugal, Iran and Russia have also been served.

Currently, the IRC on the island of Hawaii is able to provide only limited support for immigrants and migrants in Kona/West Hawaii. Additional funds through this bill would enable CCH to more comprehensively address the needs of immigrants and migrants throughout the island of Hawaii.

Here's an example of how the Hawaii IRC is helping immigrant/migrant families:

A Micronesian family of four (father, mother, adult daughter, and one young grandchild) came to the IRC to get assistance initially for an immigration issue. An IRC staff who is a Board of Immigration Appeals (BIA) Partially Accredited Representative, was able to assist them to obtain their I-94s and Social Security Cards. Their English is very limited but the

IRC's Chuukese-speaking staff was able to speak to them in their native language to identify their needs during the Intake and Assessment process. Based on identified needs, here is how the IRC was able to assist this immigrant family:

- The father who was unemployed, was referred to Goodwill for Employment Core Services. The IRC staff have kept in touch with the counselor there to ensure that he receives help to secure employment.is continuing.
- The IRC helped the father apply for medical insurance.
- The mother who is disabled from a stroke is unable to work. The IRC staff helped her complete an application for financial assistance from the Welfare office and IRC staff went with her to serve as interpreter.
- The family's oldest child, a single parent with a young child, has lived in Hawaii for some time and lost her job recently. However, she was not given a final check upon departure. Our IRC staff contacted her former employer and spoke to the manager who directed our staff to call their main office on another island. Our staff talked with the HR Coordinator and a final paycheck was send to the daughter.
- The same daughter needed help preparing a resume. IRC staff taught her how to use the computer in the IRC resource library and provided guidance in preparing her resume. She was then directed to Goodwill for Employment Core Services to assist with job search.
- The parents and daughter are coming to the IRC resource library daily to use Rosetta Stone to improve their English skills. They have also signed up for the free English class at UHH. These classes are being provided as a collaboration of CCH and UHH's Department of English, TESOL program. IRC clients can attend these free non-credit classes without a high school diploma and despite limited or no English skills.
- This family is at a high risk of being homeless. IRC staff helped them apply for Section 8, low income apartments and State housing.

The above migrant family, and many other immigrant and migrant families are now on their way to stabilizing their lives and taking concrete steps toward self-sufficiency.

My name is Haaheo Mansfield. I am employed at Parents And Children Together and serve as the Senior Vice President of Programs for the agency. Parents And Children Together currently receives funding from the Office of Community Services to provide services to immigrants through the Immigrant Resource Center (IRC). Our current target community all of Honolulu proper. PACT supports the initiative from the Office of Community Services to include Waipahu. I **strongly** urge you to support HB 1737 HD 1.

As you know, the flow of immigrant migration to Hawaii has remained steady since pre-Territory years. Families from Pacific Rim and Pacific nations come to Hawaii for health care, education and the dream of opportunities not available to them in their home countries. Hawaii has struggled to meet the challenges of new groups as they arrive and brave attempts have been made by churches and others in the private sector to facilitate speedy acculturation. However, these efforts have not been able to meet the evolving needs of immigrants.

As one of America's major Pacific points of entry, Hawaii must allocate more financial resources to supporting positive acculturation for immigrant groups up front or face the even higher costs related to treatment services at the back end of their stay here. Without a structured and proactive acculturation process, immigrant families often find themselves shunned by the larger community because they lack the social skills necessary to navigate the written and unwritten rules of life in Hawaii.

Expansion of the Immigrant Resource Center on each respective island will help reduce the negative impact of migration and increase the likelihood of positive and successful acculturation for immigrants, thus costing taxpayers less in the long run. Our belief is that Hawaii can thrive with an informed and acculturated citizenry. The Immigrant Resource Center can help make that a reality.

The Office of Language Access ("OLA") appreciates the opportunity to testify in support of H.B. 1737 HD1 Making an Appropriation for the Office of Community Services. My name is Serafin Colmenares, Jr. and I am the Executive Director of OLA.

The bill provides appropriations to expand the Immigrant Resource Centers (IRC), a project of the Office of Community Services (OCS) which are currently located in four locations: at the Catholic Charities Hawaii Office in Hilo, the Child and Family Service Center in Ewa Beach, the Kuhio Park Terrace Family Center in Kalihi, and the Child and Family Service Center in Kapaa on Kauai. The purpose of the immigrant resource centers is to restore state-funded, comprehensive services for Hawaii's immigrant communities marginalized by poverty and lack of language access to needed resources.

About 7,000 immigrants arrive in Hawaii every year, and many of them are limited English proficient (LEP). Currently, there are more than 150,000 people in the state who are LEP. The OLA was established by law to ensure that Hawaii's LEP population is able to have equal access to government-funded services, programs and activities. The expansion of the IRCs statewide will do much to help ensure that LEP individuals are able to have that access.

We strongly urge that your committee pass this measure.

OLA appreciates this committee's commitment to immigrant services.

I. OVERVIEW OF THE PROPOSED LEGISLATION

H.B. 1737, HD1 proposes to provide an appropriation of 4700,000 to the Office of Community Services (OCS) to support the expansion of the newly-created Statefunded Immigrant Resource Centers, contracted by the Office with nonprofit service providers, for language-accessible direct information and referral services to new immigrants. In addition, the measure requires OCS to consider and report to the Legislature on the following: a) the current process for solicitation and administration of the grants-in-aid programs; the feasibility of handling the processing of all of the grants-in-aid requests; and recommendations to streamline the grants-in-aid process.

II. Comments on House Bill 1731, HDI

Child & Family Service has been providing Immigrant Resource services through the Family Centers, Nana's House and Hale Ho'omalu, since August of 2013. There is a great need on Kauai for these services. In the first few months of opening our door, we were flooded with a demand for services, and quickly maximized service capacity. In the 6 months that we have been providing services, we have worked with 33 out of our 35 families we intended to serve in the first year. Additionally, as our services are full with a wait-list, we have enrolled 7 immigrant families in case management at Hale Ho'omalu. All 40 families listed above have received individual support plans in which they define their strengths and challenges, and work towards resolution of the barriers to economic self-sufficiency.

The families that we serve have received acculturation training, and assistance with securing jobs and understanding job orientation and training. We have provided in-

terpretation and translation services, and assistance with filling out job applications. We have had employers ask us to return to assist with more of their employees, and have received multiple requests for training for businesses and organizations. We have served as a liaison between the United States Citizenship and Immigration Service, assisting families by assisting them with forms and documentation for USCIS, as well as assisting them with legal aid services. We have assisted families to access necessary medical care, such that they are prepared to lead economically stable and productive lives on the island. We have provided training, or served as a liaison to 15 businesses and organizations in the 6 short months of operation. We have learned that there is a need for understanding our populations in family court, homeless shelters, job training programs, etc.

Additionally, we have met with representatives from the Department of Health and the Civil Defense and understand that there is a great need to assist the families in emergency preparedness, and also for school emergencies for immigrant children. Currently, our civil defense system on Kauai is not broadcasted in multiple languages, nor are emergency protocols for schools broadcast in multiple languages. Systems need to be enhanced to protect the vulnerable families. We are finding that the immigrant and COFA migrant families who now live on Kauai as our neighbors are benefitting greatly from the services, yet the demand for services is much greater than our current program is able to provide.
