Bill No. and Title: House Bill No. 1883, Making an Appropriation for the Veterans Treatment Court.

Purpose: Appropriates funds to support the Veterans Treatment Court.

Judiciary's Position:

The Judiciary strongly supports House Bill No. 1883, which appropriates funds to the Judiciary to support the First Circuit's Veterans Treatment Court.

The Judiciary along with its stakeholders (Department of Veterans Affairs, Department of the Attorney General, Office of the Public Defender and Department of the Prosecuting Attorney) have worked in collaboration with each other, to form the Veterans Treatment Court (VTC) which held its first hearing on January 4, 2013, and admitted its first clients on January 11, 2013. Currently the VTC has twelve clients. The majority of these clients have multiple mental health diagnoses related to their military service and also have a long history of substance abuse and criminal behavior.

In addition to the VTC Coordinator and the Judge, the VTC team consists of a dedicated Public Defender, Prosecuting Attorney and Veterans Affairs Officer. The legislature previously appropriated a position for the VTC Coordinator but did not fund this position. Currently the

position is being funded through federal grant monies. This grant is currently in the second year of its three year duration.

If funds are provided through this measure, the Judiciary will use the funding to cover the established Coordinator position, as well as establish two additional permanent positions, a necessary Probation Officer position and a Circuit Court Clerk, to assist with the calendars of the VTC as well as the Mental Health Court. Both of these courts hold a weekly calendar and when at capacity, have a combined client total of 75 which stretches the judicial clerk resources in both of the courts. The VTC caseload is continuing to increase and a dedicated probation officer would allow the VTC to better serve its clients in such activities as coordinating services and treatment for clients; attending court/team meetings; tracking client progress; and providing the intensive supervision that is an important element of treatment courts. Without this Probation Officer position, this role of oversight, court attendance and tracking, and coordinating client supervision and activities that will fall to the Coordinator, which will reduce the Coordinator's effectiveness in overall VTC program management and may affect the VTC's ability to meet its objectives in helping its clients achieve success in this court as well as possible growth and expansion of the VTC.

The Judiciary's only concern regarding this bill is to ensure that because the funding amount identified constitutes an addition to the original Judiciary budget request contained in House Bill No. 1638, this addition does not come with a corresponding reduction to any items already included in our base budget request. If the Legislature is inclined to move forward with this funding, we would respectfully request that the bill be amended to include language that provides funding for one full-time equivalent (1.0 FTE) social worker V (\$53,364), and the authorization and funding to establish two additional permanent positions: (1) one full-time equivalent (1.0 FTE) social worker IV (\$47,400) and (2) one full-time equivalent (1.0 FTE) circuit court clerk 1 (\$37,968), for a total cost of \$138,732.

Good morning Chair Takai, Vice Chair Ito and Committee members:

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity **to support** House Bill 1883. This measure would appropriate funds to support the Veterans Treatment Court in Hawaii.

The Veterans Treatment Court (VTCs) under the leadership of First Circuit Court Judge Ed Kubo has treated 10 defendants in its first year of operation. The need to fully fund full-time employment (FTE) authorizations is paramount as more attorneys submit application for their clients to participate in the program.

This program has very low recidivism rates, has garnered successes in dealing with veterans for various issues, and has established viable monitoring links towards rehabilitation. Over 100 VTCs across the nation have experienced a reduced number of repeat offenders, thereby reducing our overall prison population.

We defer to the agency with direct responsibility for implementation of the Veterans' Treatment Court program.

The OVS supports the concepts and intent expressed in this measure as long as its implementation does not impact or replace the priorities set forth in the Executive Budget for Fiscal Year 2015.

Thank you for this opportunity to speak on behalf of Hawaii's Veterans and their families.

Thank you for the opportunity to provide testimony **in support** of HB 1883, which would appropriate funding to the Veterans Treatment Court in Hawaii. PHOCUSED is a statewide coalition of health, housing, and human services organizations committed to strengthening policies and programs that benefit the marginalized and underserved in Hawaii.

According to the National Alliance on Homelessness, Hawaii has the highest rate of homelessness in the nation. In 2009, a survey published by the VA's Community Homelessness Assessment, Local Education and Networking Group (CHALENG), found that there were up to 800 homeless veterans in the state of Hawaii. Veterans represent a disproportionate amount of our homeless population. It is critical that we act as a community to address this issue.

The Veterans Treatment Court will provide individualized assessment of problems, judicial tracking and monitoring of treatment participation while encouraging successful reintegration into society. The court provides necessary early intervention and rehabilitation to veterans, particularly those that are homeless. Veterans Treatment Courts have a proven track record of success; the original court in New York, now a system of ten courts, has a recidivism rate of just 1% for its participants.

Once again, PHOCUSED **strongly urges your support** of this bill to appropriate funds to the Veterans Treatment Court.

Thank you for the opportunity to testify in support of HB 1883, which appropriates funds to support the Veterans Treatment Court. I am Betty Lou Larson, the Legislative Liaison at Catholic Charities Hawaii.

Catholic Charities Hawaii's Housing Placement Services have been assisting homeless veterans and their families to obtain and maintain permanent housing for many years. Through various programs including the Homelessness Prevention and Rapid Re-Housing Program (HPRP), Housing Placement Program (HPP) and Supportive Services for Veteran Families Program (SSVF), veterans have received financial assistance along with supportive case management from our agency.

Although many veteran consumers of Catholic Charities Hawaii programs have experienced success in ending their homeless plight, there are many more who have not been able to access assistance due to legal and or mental health issues. In 2006, one in four veterans aged 18-25 met criteria that suggested substance abuse. A report published in 2000 by the Bureau of Justice Assistance found that 81% of all justice-involved veterans had a substance abuse problem prior to incarceration. Thirty-Five were identified as suffering from alcohol dependency, 23% had been homeless in the prior year, and 25% were identified as mentally ill.

The Veterans Treatment Court (VTC) has built upon the positive experience Hawaii has had with treatment courts including the Hawaii Drug Court (HDC) program and the Mental Health Court (MHC) program. The VTC has drawn on the strengths and lessons learned from these other specialty courts while providing a unique treatment program tailored to the needs of our veterans. These unique features include, but are not limited to, a strong partnership with the Veterans Administration (VA) who will come to the court to assess discharge status, benefit eligibility, etc. The VTC also provides a mentor program developed with the VA that matches the veteran with a mentor of the same war, same branch of service and same rank. In addition, the VTC also provides targeted treatment for veterans with Post-Traumatic Stress Disorder (PTSD) and Traumatic Brain Injury (TBI) since the HDC and MHC rule out clients with TBI.

The Veterans Treatment Court (VTC) is currently funded by a federal grant that covers only a portion of the costs incurred to run this program. Additional funding will allow the VTC to hire additional staff to support the two who currently administer the VTC and ultimately will help more of our wounded warriors to achieve stability and obtain and maintain long-term housing.
