In consideration of HOUSE BILL 1901 RELATING TO WILDLIFE

House Bill 1901 proposes to amend Chapter 183D, Hawaii Revised Statutes, by adding a new section to be appropriately designated as "Reciprocity Enforcement Agreements", whereby the State of Hawaii would join 37 other states in an Interstate Wildlife Violator Compact, where lawbreakers who have lost their hunting, fishing, or trapping licenses in one state, e.g. due to poaching, would lose their ability to hunt, fish, or trap in other member states within the Compact agreement. The Department of Land and Natural Resources (Department) supports the intent of this measure, and offers the following comments:

Licenses are currently sold by agents other than the Department's Division of Conservation and Resource Enforcement (DOCARE) Officers, and currently no database is checked prior to issuing a license to a hunter. In many states, wildlife enforcement is carried out by state police. Hawaii's licensing agents would not have access to the interstate database, and all hunting license purchases would have to be somehow checked at a clearing house location, such as the DOCARE Office on each island, or centrally in Honolulu. Unique identification, such as drivers' licenses and social security numbers, would need to be verified and entered into the database in order to check for violations in other states. Logistically, the process of entering violators into a database, maintaining a centralized database, and checking new licensees against the interstate database, will require significant extra staff time and addition funding. Potentially, the issuing of hunting licenses would be delayed. The administrative rules would have to be amended if the statute was changed, in order to coordinate the law and rules with the other states.

Hon. Chair and Members,

HRA supports this measure in the hope that it will help reduce poaching in Hawaii. Poaching is prevalent here, but the public perception that it is stealing, often with a firearm, is not. Poachers threaten lawful hunts, do significant property damage, and give hunting and ethical law-abiding hunters a bad name.

In an anonymous statewide poll of recreational activity, an estimated 10,000 people report they hunt annually, but DLNR sells only about 2,000 licenses annually.

Federal Pittman-Robertson funds from excise taxes on firearms, ammunition, and archery equipment, earmarked for multi-use habitat improvement and hunter safety programs, are distributed to the states partially based on the number of hunting licenses sold annually. Poachers cheat those programs.

On behalf of The Humane Society of the United States-Hawaii office, we respectfully urge your support of House Bill 1901. This bill would allow the state to become a member of the national law enforcement network known as the Interstate Wildlife Violator Compact.

Wildlife officials estimate that nationally tens of millions of animals are poached each year. Poaching is a serious problem and far more often than not, poaching activity remains undetected and poachers go unpunished for their crimes. In fact, it is estimated that despite the tireless efforts of game wardens and wildlife protection officers, a mere one to five percent of poachers are ever apprehended by law enforcement.

Poachers exploit wildlife and callously disregard the laws that protect it. They steal from legitimate sportsmen and wildlife watchers. Adequate penalties are imperative for deterring illegal hunting activity. An important component of any law enforcement effort, including one that protects wildlife, is enforcement reciprocity with other states. This truth has already been realized by the 47 states that have passed the legislation necessary to join the compact. These states report that there is little if any fiscal impact as the database containing this information is free to access for state wildlife personnel, who are members of the Compact.

Modeled after the equally successful Driver's License Compact, the Interstate Wildlife Violator Compact was first developed back in the early 1990s. If enacted in Hawaii, it would prevent wildlife violators who have lost their hunting, trapping, or fishing privileges in member states from coming to Hawaii to circumvent those license revocations.

Enacting the compact would also ensure that those who have been punished with license revocations for illegal hunting, fishing, or trapping in Hawaii can't avoid their punishment by engaging in those activities in another member state.

In addition, if a nonresident violates wildlife laws in a member state, the compact streamlines the citation process which conserves valuable law enforcement time and court system resources. Without the compact, a nonresident violator is required to immediately post collateral or a bond to secure appearance for a trial at a later date, or is taken into custody until the collateral or bond is posted, or is taken directly to court for an immediate appearance. Under the compact, the wildlife officer treats the nonresident like a resident and where appropriate can issue a citation and release the person on personal recognizance and they can comply with the terms of the citation just as a resident would. The possibility of losing their license if they fail to comply with the terms of the citation serves as the incentive to comply, just as it would for resident lawbreakers.

Over the past two decades, states across the country have become members of the compact, and today only 3 states have yet to pass the legislation required to join. These 3 states, including Hawaii, are unable to reap the benefits of a commonsense and successful law enforcement tool enjoyed by other member states. No state deserves to be a safe haven for lawbreakers and joining the compact would end Hawaii's status as a hunting destination for out-of-state wildlife criminals.

On behalf of The Humane Society of the United States and our supporters in Hawaii, I strongly urge your support of HB 1901.
