In consideration of HOUSE BILL 1902 RELATING TO HUNTING

House Bill 1902 proposes to prohibit any net reduction of public hunting area on each island, and requires the Department of Land and Natural Resources (Department) to make comparable land available for hunting upon making land unavailable for hunting. **The Department appreciates the intent of this bill but has concerns that it would be impractical to implement and may have unintended consequences. The Department provides the following comments on this bill.**

The Department has concerns that the requirements imposed by the bill may be impractical or impossible to achieve. Many of the state's most important public hunting areas are managed through voluntary cooperative agreements with private landowners, or through agreements with other governmental agencies. The Department does not necessarily have control over areas that a landowner may choose to withdraw from such agreements. Similarly, the Department may be required to restrict or close areas to comply with court orders, to protect public safety, or to manage wildlife disease outbreaks. In such cases, securing comparable lands to replace those lost may not be possible.

In addition to managing public hunting areas, the Department is mandated to manage lands for the protection of natural and cultural resources that provide vital environmental and economic benefits to the people of Hawaii. Control of game mammals in certain areas is an essential management tool for that purpose. Restricting the Department's ability to carry out those responsibilities will result in loss of watershed yield and function, damage to native ecosystems, sedimentation and damage to near shore fisheries and marine environments, and may result in lawsuits resulting from take of endangered species. The Department is committed to enhancing public hunting and increasing hunting opportunities. Statewide, 900,000 acres of public hunting lands are available, with over 700,000 acres on Hawaii Island alone. This constitutes a large proportion of the approximately 1,000,000 acres managed by the Division of Forestry and Wildlife statewide. Acreages of public hunting areas are increasing, not decreasing. In the past decade, more than 17,000 acres of new hunting opportunities have been added to the Division's managed lands and an additional approximately 28,000 acres are in the process of being added. In addition, the Department has included a request for \$750,000 in general funds for the public hunting program. Those funds will be used to directly benefit the approximately 11,500 licensed hunters in Hawaii through improved game management and to continue the Department's public hunting access and acquisitions program.

The Department is actively and successfully pursuing net increases in public hunting areas but urges the committee to consider that this measure may be impossible to comply with and that support for the administration's budget request for the hunting program will provide a more productive means to achieve the desired goal.

Chair Cindy Evans, Vice Chair Nicole E. Lowen, and Committee Members:

I am a resident of Maui and a sport hunter. I support HB 1902, with amendment, because it will help maintain hunting areas for the public to use for subsistence, recreation, and environmental management.

Hunting on public lands is an important component of Hawaiian culture worthy of being passed on to all residents of the State of Hawaii. It also provides an opportunity for hunters to provide food for their families which otherwise might not be affordable to all of them. The act of hunting, regardless of whether game is actually harvested, is a form of recreation that helps promote the health of participants and respect for the natural environment. In addition, hunting helps maintain a healthy environmental balance between land and wild animals.

On the island of Maui, the rapidly growing population of Axis deer increasingly poses an economic and health hazard to farmers and motorists. Allowing hunters access to land where the deer herds live helps maintain an environmental balance at little or no cost to the State of Hawaii.

I hunt wild boar. Every time I hunt I observe firsthand the damage that one wild pig does to native plants, birds, and other animals as well as to agricultural land. Without a natural predator, hunters help keep the wild boar population in check, again at little or no cost to the State of Hawaii.

For the preservation of the Hawaiian culture, and to provide opportunities for subsistence harvests, recreation, and environmental management, hunters must have access to the land where the deer and wild boar populations thrive. HB 1902 is a big step towards ensuring this access for the future.

Proposed Amendment:

In the interest of humane treatment of all wild game and for the safety of hunters, I wish to raise for your consideration an amendment to HB 1902. Current hunting regulations limit the means of harvest carried by an individual hunter to only one weapon.¹ From my personal experience, this means that if I hunt with bow and arrow, I may not carry a long knife or other backup weapon. Similarly, when I hunt with a long knife or spear, I may not carry another long knife, spear, or pistol as a backup weapon.

There are a number of areas in Hawaii's hunting regulations which warrant updating to reflect changes in technology and safe hunting practices. From experience, I know that amending Hawaii Administrative Rules can be a slow process. In the immediate interest of humane treatment of wild game and of hunter safety, however, I propose a clause be added to the Hawaii Revised Statutes to remove any limit on the number of weapons or means of harvest carried on or employed by a hunter as long as the weapons are consistent with the most lethal means allowed in that area. This might be accomplished by modifying HRS §183D-3 to read as follows:

§183D-3 Rules. Subject to chapter 91, the department shall adopt, amend, and repeal rules:

- Concerning the preservation, protection, regulation, extension, and utilization of, and conditions for entry into wildlife sanctuaries, game management areas, and public hunting areas designated by the department;
- (2) Protecting, conserving, monitoring, propagating, and harvesting wildlife;
- (3) Concerning size limits, bag limits, open and closed seasons, and specifications of hunting gear which may be used or possessed, provided that there shall be no limitation on the number of weapons carried by a hunter; and
- (4) Setting fees for activities permitted under this chapter, unless otherwise provided for by law.

¹ HAR §13-123-22 (b) (2) states, "<u>While hunting, each hunter shall be limited to carrying on their person only</u> <u>one legal firearm that is consistent with the hunt.</u> (Emphasis added.) However, a hunter may carry another hunter's unloaded firearm in addition to his own unloaded firearm in close proximity to the other hunter. In addition, each hunter is required to make their weapon, cartridges or muzzleloader firing components, game and license available for inspection, upon the request of a duly authorized representative of the department. Refusal to permit said inspection shall be considered a game law violation and may result in the revocation of hunting privileges by the department, after notice and hearing." Inquiries of State of Hawaii biologists have confirmed that this restriction is extended to all weapons or means of harvesting wild game. As a result, a hunter may not carry a backup weapon to humanely dispatch a wounded animal or protect him or herself in the event that his or her primary weapon malfunctions.

TESTIMONY IN OPPOSITION TO HB 1902

Aloha Chair Evans and Members of the Committee:

The Sierra Club of Hawai'i, with over 12,000 dues paying members and supporters statewide, *opposes* HB 1902. This measure requires a one-for-one trade: for every acre of land protected for natural resources, an equal amount of land must be set aside for hunting.

The Sierra Club strongly believes we can have *both* adequate public hunting areas and protection of Hawai'i's amazing and unique natural resources. Too often we slip into an "either/or" discussion. And, when that happens, protection of natural resources typically loses. Hawai'i is known



as the endangered species capitol of the world, largely because of a lack of vigorous protection, and now much of our precious cultural and natural heritage is disappearing before our eyes.

The rationale for balance also comes from smart land use planning. As the photo above demonstrates ungulates can overgraze our natural vegetation, thus leading to massive erosion problems. This erosion eliminates our source of drinking water as well as causes sediment to settle on our coral reefs.

We encourage this Committee to find a better solution. Hawai'i can have adequate public hunting areas <u>and</u> protect critically threatened habitat reserves from the impacts of invasive species. We can achieve both goals without having to resort to an eye-for-an-eye approach.

The Hawaii Game Management Advisory Commission (GMAC) was instituted in 2012 to advise County, State, and Federal agencies on matters relating to the preservation of subsistence hunting and fishing, as well as the protection of traditional and cultural gathering rights.

We respectfully request that HB1902 be amended to reflect an Act date of January 1, 2014.

Hunting has played a crucial roll in a sustainable lifestyle for many families in our State. Hunting is a generational activity and an important foundation for good quality time with family and friends, a source of good exercise and a way of preserving culture and traditions. Economically speaking hunters contribute approximately \$36 million annually to our communities through the purchase of hunting gear, equipment, license, fees, food, fuel, off road vehicles and other associated expenses related to hunting. One other very important service hunters provide is keeping game animal populations in check within designated hunting areas at little cost to the State. If you visit any designed hunting area you will see managed levels of game with little to no impact on the environment. Where animals present a potential problem you will find that hunting is not permitted. These areas for one reason or another are rarely if at all open for hunting. It is very frustrating to see good quality game out of reach of hunters to only be eradicated and left to rot.

The Rain Follows The Forest Watershed Protection Plan will severally impact game and cultural hunting practices in Hawaii. We respect the ten year objectives of the Watershed Protection Plan that will double the area that is currently protected. Unfortunately the one hundred year plan and associated map of priority watershed protection areas will encompass all our vegetative lands. At this rate there will be little to no land available for hunting. Will there be a future for hunting in Hawaii?

In all verity, we would like to see that any further acreage set aside for Watershed Protection or preservation projects by DLNR or related agencies require equal and comparable land to be established for hunting.

For these reasons the Hawaii County Game Management Advisory Commission resolutely support HB1902.

Good morning Chair Evans, Vice-Chair Lowen, and members of the committee:

My name is David Lane Henkin, and I am an attorney with Earthjustice. We appreciate the opportunity to testify regarding House Bill 1902, which would prohibit any net reduction of public hunting area on each island.

We have no objection to the apparent intent of the bill – to ensure adequate hunting opportunities for Hawai'i's residents. We have serious concerns, however, about the way the bill seeks to accomplish that goal. Requiring the Department of Land and Natural Resources (DLNR) to replace, acre-for-acre, any land that is made unavailable for hunting would drastically increase the cost of long overdue efforts to protect our irreplaceable native forests and the watersheds they protect from the devastating impacts of feral pigs, goats, sheep and other game mammals. In many cases, these vital conservation efforts take place in remote areas that, while nominally currently open to public hunting, are rarely used and accessed.

Because so much land is already set aside for hunting (over 900,000 acres statewide), DLNR may not always be able to acquire on the same island replacement land of equal or higher wildlife habitat, as HB 1902 demands. Conservation measures that are essential to prevent species extinctions, to protect watersheds so that future generations have adequate supplies of fresh water, or to provide recreational opportunities would be unable to go forward.

The Legislature should not impose on DLNR a mandate to replace every square inch of land withdrawn from hunting, regardless of the value of the land to actual hunters or the public benefit conferred by protecting the area from destruction by game mammals. Accordingly, we urge the committee to hold HB 1902.

Mahalo for the opportunity to offer this testimony.

I, Alan Nakagawa, strongly support HB 1902 – No net loss of public hunting area. I have been a hunter on the Big Island for over 40 years and have witnessed the continued loss of hunting opportunities and areas. Large scale fencing projects throughout the island (especially in the Mauna Kea and Pohakuloa Training Areas) have not only eliminated large populations of animals but also prevents access. Loss of hunting areas with the opening of the new saddle road provided mitigation for loss of plant/wildlife habitat but no value or mitigation was awarded for the loss of hunting areas. As hunting areas are lost due to fencing, poor habitat management, or reduced game populations the demands on the remaining areas are greater causing poor hunting quality and dangerous situations. It is also important that hunting lands are not only equal in size but the quality of the habitat needs to be considered.

Once again I strongly support this bill.

Testimony of The Nature Conservancy of Hawai'i Opposing H.B. 1902 Relating to Hunting House Committee on Water and Land Wednesday, January 29, 2014, 9:45 AM, Room 325

The Nature Conservancy of Hawai'i is a private non-profit conservation organization dedicated to the preservation of the lands and waters upon which life in these islands depends. The Conservancy has helped to protect nearly 200,000 acres of natural lands in Hawai'i. Today, we actively manage more than 35,000 acres in 11 nature preserves on Maui, Hawai'i, Moloka'i, Lāna'i, and Kaua'i. We also work closely with government agencies, private parties and communities on cooperative land and marine management projects.

The Nature Conservancy opposes H.B. 1902.

We believe that a more effective solution than requiring a one-for-one acreage exchange would be to support the DLNR's programs to improve hunting access, including its supplemental budget requests for:

- \$750,000 in general funds to match federal funds in support of programs and staff that improve access to those State lands already open to hunting as well as create hunting access to other appropriate non-state lands; and
- \$10,000,000 in general obligation bond funds to help purchase Central O'ahu lands that would include expanded hunting opportunities.

While we agree that both native and introduced wildlife resources need to be wisely managed both for their benefits and, in some cases, for the risks they pose, we don't believe that a statutory directive requiring the Department of Land and Natural Resources to provide an absolute minimum acreage for public hunting areas is necessary or appropriate.

There are currently **more than 900,000 acres of public hunting areas** across the state managed by the DLNR's Division of Forestry and Wildlife. The State constitution, State statutes and administrative rules currently provide sufficient directive, authority, and process—including resource user and stakeholder participation—for managing wildlife, hunting and hunting areas in Hawai'i. Certainly, reasoned discussion and planning is important to determine where and how to manage both native and introduced wildlife, including significant areas for both enhanced game animal production for public use and enjoyment, as well as game animal removal for native species, habitat, watershed, public health, private property, and agricultural protection.

Thank you for the opportunity to testify on this measure.

Aloha. Conservation Council for Hawai'i opposes HB 1902, which legislates no net loss of hunting areas. Such policy is not in the public's best interest. It would hinder ongoing and necessary programs to protect native Hawaiian forests, watersheds, and habitat for unique, rare, and endangered Hawaiian plants and animals. We do not support sustained-yield mammal hunting in Hawaiian native forests, watersheds, and habitats.

HB 1902 is also unnecessary because there is no shortage of public hunting areas in Hawai'i with over 700,000 acres currently available on the Big Island and over 900,000 acres statewide. There are huge areas on the Big Island in which public hunting is not adequate to control the large numbers of feral pigs, goats, and sheep on the island. For example, large herds of feral goats graze along the highway and roadways of Kona and Kohala – a traffic incident and tragedy waiting to happen and an example of how public hunting alone cannot control the exploding populations of feral and game mammals on the Big Island. Feral sheep and mouflon by the hundreds, if not thousands, occur in critical habitat for the palila on Mauna Kea in spite of court orders to the State to remove all feral goats, sheep, and mouflon from palila critical habitat. Feral pigs are virtually everywhere unless they have been fenced out, including private yards, gardens, farms, ranches, and nurseries.

Our members include hunters and fishers. We support responsible game management in <u>appropriate</u> areas. We support fencing around appropriate hunting areas to restrict the range of feral and game mammals, and to reduce the damage they cause on public and private land. We support programs and public access to hunting areas that allow hunters to help remove feral and game mammals from sensitive native forests and watersheds. We support better game management in appropriate areas.

For decades, native forests were neglected. Most of them still are. A mere 10 percent of our native forests and watersheds is currently protected and managed. What does this mean for the remaining 90 percent? Slowly, funding and political will have resulted in a renewed commitment to manage our native forests for their highest and best use – watersheds, habitat for rare and endangered Hawaiian species, and recreational uses that do not involve incompatible feral and game mammals. Just because people may have hunted in native forests prior to their management as watersheds and important habitats, this does not mean these forests should continue to support introduced common feral and game mammals for hunting. Other areas are much more suitable for sustained-yield hunting, including forests and woodlands that are predominantly non-native in species.

Instead of bills, such as HB 1902, we recommend the following: 1) fund game management in <u>appropriate</u> areas; 2) require fencing around public hunting areas to reduce the damage caused by feral and game mammals, and resulting conflicts; 3) facilitate access to hunting areas and to areas where public hunting is needed as a management tool; and 4) explain to hunters that watersheds and native species habitat are the highest and best uses of our remaining and diminishing native forests. HB 1902 does not address the inherent conflicts that arise from maintaining introduced, continental feral and game mammals in native Hawaiian forests, watersheds, and ecosystems. Please oppose HB 1902 and instead make a positive difference for both the hunting community and the general public. Mahalo nui loa for the opportunity to testify.

Comments: Below are my previously submitted comments for the Puu Waawaa exclosure fencing proposal that summarize my support for hb 1902 and my reasoning. Cumulative effects of state of Hawaii ungulate fencing projects on acreage of public lands open to hunting: Recently DOFAW and other agencies (NPS) have been reducing the total number of acreage on Hawaii Island that is available to hunting. Past and planned large scale fencing projects have removed public lands that were historically utilized for hunting and other recreational uses (planned Pu'u Wa'a wa'a fences and existing forest bird sanctuary, NAR fences) and converted them into ungulate free exclosures for the purpose of conserving and protecting native species. In addition to fencing lands to eliminate ungulates, DOFAW currently (2013) utilizes aircraft shooters to reduce or eliminate the ungulate population within the Mauna Kea Forest Reserve and Game Management Area thus effectively removing this large tract of land from the public lands available to Hawaii citizens for hunting big game (goats, pigs, and sheep). This situation is frustrating to hunters as the area is both a "Game management Area" and palila critical habitat and it appears DOFAW can't accomplish both goals in the same place. The Natural Area Reserve system is also fencing their public lands to remove ungulates and is planning additional fences and ungulate removal operations in the near future (example Manuka). This would seem reasonable as the intended use of NARS lands is to preserve native species. However, some of the NARS public lands were historically utilized by hunters and the Manuka reserve is currently utilized by goat hunters. Protecting Hawaii's native species is a noble goal and supported by many citizens of the state of Hawaii. However, many hunters in Hawaii are concerned that more and more tracts of historic public hunting lands are being reclassified as conservation/preservation lands without mitigating those losses by opening up other public lands of similar guality to hunting. Moreover, Hawaii citizens want assurances that not all of the public hunting lands will be converted to ungulate free zones and that there will be some minimum public acreage left for hunting purposes on Hawaii Island. As part of the cumulative effects ana lysis for the Pu'u Wa'a wa'a fence project environmental assessment, Hawaii citizens need certain assurances that a minimum percent of public lands will not be fenced to eliminate ungulates and that losses of hunting lands by planned fencing projects will be offset (mitigated) by creating at least an equal acreage of accessible, guality public lands for the management of wildlife for hunting purposes.
