In Consideration of HOUSE BILL 1903 RELATING TO OUTDOOR HERITAGE MONTH

House Bill 1903 proposes to designate September as "Outdoor Heritage Month" to celebrate Hawaii's diverse natural environment and recreational activities. **The Department of Land and Natural Resources (Department) appreciates the intent of the bill and would offer the suggestion to modify the month of celebration from September to June to coincide with the annual Presidential and Gubernatorial proclamations of June as "Great Outdoors Month."**

America's Great Outdoors Week was first recognized in 1998 and has become an annual monthly celebration of our natural resources, including forests, parks, and other public waters and lands. It also encourages the public to get outdoors and experience the natural environment. Hawai'i joined this national event in 2012 when the Department requested a Governor's proclamation. June was selected to coincide with National Trails Day, National Fishing and Boating Week, and Take Pride in America. The Department believes that this already established venue provides an opportunity to accomplish the intent of this bill.
