TESTIMONY ON H.B. No. 1998 - RELATING TO CABLE TELEVISION SYSTEMS.

TO THE HONORABLE ANGUS L.K. MCKELVEY, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Catherine Awakuni, and I am the Cable Television Administrator at the Department of Commerce and Consumer Affairs (the "**Department**"). I am providing comments to H.B. No. 1998, which requires the Director of the Department to order cable franchise applicants to provide equipment and maintenance sufficient to ensure that public, educational, and governmental ("**PEG**") access channels are received in quality equivalent to local broadcast signals on the cable operator's system.

At the outset, please let me note that there appears to be signal quality differences for some of the PEG access channels. In particular, I was recently advised by Akaku, the organization designated to provide PEG access in Maui County, that it experiences significant signal degradation on its channels. That said, however, the Department believes that these disparities could and should be addressed more directly through discussions among the PEG access providers, the cable operators, and the Department. Prescriptive legislation that pinpoints just one aspect of the negotiations process in which the Department engages with the cable franchise applicant is unnecessary.

Olelo, the PEG access provider on Oahu, has implemented digital signal transport to Oceanic Time Warner Cable's system as a result of the Oahu franchise renewal process. Just as the Department worked with Oceanic Time Warner Cable and Olelo to upgrade analog transport equipment as a result of the Oahu franchise renewal process, the Department intends to work with Akaku and Oceanic Time Warner to upgrade analog transport equipment as part of the Maui franchise renewal process.

Aloha Chair McKelvey, Vice Chair Kawakami, and members of the committee,

On behalf of Oceanic Time Warner Cable, which provides a diverse selection of entertainment, information, and communication services to over 425,000 Hawaii households, schools and businesses and currently employs more than 1,000 highly-trained individuals, we appreciate the opportunity to express our concerns and opposition to HB 1998.

HB 1998 requires the director of the Department of Commerce and Consumer Affairs, upon the submission of an application for (or renewal of) a cable television franchise, to order the applicant to provide public, educational and government access (PEG) programming in high definition (along with closed captioning, stereo and multiple audio programming) to subscribers.

Federal law is clear and unambiguous that a local franchising authority, such as the DCCA, cannot mandate the type of technology in which a cable operator provides its services to subscribers, including the transmission technology that the operator uses to provide PEG programming. Accordingly, HB 1998's attempt to regulate how, and in what form, a cable operator provides PEG programming is preempted by federal law and is clearly unenforceable.

Section 624 of the federal Cable Act (47 U.S.C § 544(e)) provides that "No State or franchising authority may prohibit, *condition*, or restrict a cable system's use of *any type* of subscriber equipment *or any transmission technology*." (Emphasis added). The Federal Communications Commission, the federal agency mandated to interpret and implement the Cable Act, has noted that "[T]he phrase 'transmission technology' includes both the transmission medium . . . and the specific modulation or communications format." See Implementation of the Cable Act Reform Provisions of the Telecommunications Act of 1996, Report and Order, 14 FCC Rcd 5296, 5356-57 ¶ 141 (1996), aff'd on recon., 17 FCC Rcd 7609 (2002) ("2002 Implementation Order"). Thus, the FCC has further confirmed that "local authorities may not control whether a cable operator uses digital or analog transmissions nor determine whether its transmission plant is composed of coaxial cable, fiber optic cable, or microwave radio facilities." *Id.*

HB 1998 proposes to do exactly what the Cable Act proscribes: it directs the DCCA to impose a unilateral condition upon a cable operator's franchise application that would mandate the cable operator to use a specific transmission technology and communications format (high definition) to transmit PEG programming. Accordingly, HB 1998 must be deferred.

In addition, Oceanic notes that the Cable Act carefully balances the needs of all subscribers and places conditions and restrictions upon the state's authority with respect to the establishment of channel capacity requirements for PEG programming. The Cable Act provides that a franchising authority may require "adequate assurance" that a cable operator will provide "adequate" PEG access channel capacity, facilities, or financial support. 47 U.S.C. § 541(a)(4)(b). The FCC has observed that "Because the statute does not define the term 'adequate,' we have the authority to interpret what Congress meant by 'adequate PEG access channel capacity, facilities, and financial support,' *and to prohibit excessive LFA demands in this area, if necessary.*" First Section 621 Report & Order, ¶ 112 (emphasis added). The FCC has further concluded that "adequate' should be given its plain meaning: the term does not mean significant but rather 'satisfactory or sufficient." *Id.; see also* Second Section 621 Report & Order, ¶¶ 12-13 ("Much of the 'PEG/I-Nets' section of the First Report and Order applies equally to incumbents and new entrants," including "our refusal to adopt standard terms for PEG channels for new entrants.").

Oceanic is supportive of public access programming to the extent that it provides programming of interest to its subscribers and to the extent that it is provided in a fiscally-responsible manner. All of the current public access providers in our state have channel capacity on Oceanic's system and currently receive a substantial amount of their operating and capital funding from Oceanic's subscribers through franchise fees and capital payments. Oceanic has, and will continue, to provide adequate public access channel capacity, facilities and financial support consistent with its legal and franchise obligations; however, broadcasting PEG programming in HD (if even such a requirement could be imposed in the first instance) would go far beyond the FCC's mandate with respect to PEG programming and would require Oceanic to reallocate substantial bandwidth and other resources to the detriment of other high-demand services, including faster broadband speeds, that many of Oceanic's subscribers have requested and have come to expect.

Oceanic believes that the foregoing considerations are why none of the communities on the Mainland where Time Warner Cable operates has unilaterally imposed a requirement that PEG programming be transmitted in high definition as proposed by HB 1998.

As federal law is on point, and unambiguously speaks to this issue, the state may not authorize the DCCA director to require a cable operator to utilize specific transmission technology to provide PEG programming in high definition, and the committee should defer this measure.

Thank you for the opportunity to offer our testimony on this bill.

Subject: Testimony in Strong Support of HB1998 Relating to Cable Television Systems

My name is Roy Amemiya, CEO and President of 'Ōlelo Community Media. 'Ōlelo operates four PEG channels on O'ahu and since our founding nearly 25 years ago, more than 100,000 locally produced programs have been aired. We support the intent of HB1998 because it would allow cable viewers that subscribe to HD service to view these programs in a higher quality. Currently, although we transmit our signal in digital and are able to send it in HD, both Hawaiian Telcom and Oceanic TWE (TWE) currently only provide SD capability. TWE transcodes the signal into a lower grade analog quality. While transmitting in analog is good from the standpoint that all subscribers, including basic subscribers are able to watch these community and government programs, the trade-off is a degraded signal.

We would like to point out that this bill, in its current form, would exclude O'ahu. This is because the requirements are triggered upon DCCA granting an application to receive or renew a cable franchise. While the neighboring islands have cable franchises up for renewal, on O'ahu both TWE and Hawaiian Telcom are at the early years of long term franchises.

Accordingly, while we support the intent of HB 1998, we ask that the committee consider more inclusive language.

Comments: In Learning Gardens and sustainability education, bringing life to schools and schools to life, Williams and Brown (2012), shared the perspective of Carlos Garcia, superintendent of San Francisco Unified School district, an avid school garden proponent. In his words: • I would not want people to think of gardens as "just a garden." Rather, I want them to think of gardens as being better than a textbook. • To me, school gardens are an academic issue. • I believe that we can use gardens as an educational tool, make learning joyful, fun and relevant. Every child eats food. Gardens create connections between what students see in the market and what they get in science and in writing. The educational value is most important - gardens make education relevant. (p. 194) Across the large pond of the Pacific Ocean, Danny Garcia, principal of Kohala Elementary School shared this perspective: I wanted all my students to use the garden as a laboratory of discovery. That's why I call it the Discovery Garden. My most involved student, Na'a (not his real name), is autistic, and has a full time aide with him all day, and weekly occupational therapy (OT), and physical therapy (PT) sessions. When his OT suggested that she use gardening as a tool for teaching Na'a, I jumped to support it 100%. Ming Wei, the school garden teacher worked with Ms. N to create situations in the garden for Na'a to learn particular skills. For example, Ms. N wanted Na'a to practice crossing his midline by twisting a piece of rope of string around a vertical stick. Ming Wei got Na'a to plant pea plants, and to weave the plants up the trellis behind it. Na'a built a rock wall for the school garden to learn how to sort sizes, largest rock on the bottom, smallest on top. And then he planted pollinator-attrac ting plants on top of the wall. The Discovery Garden can meet the academic and educational needs of all my students, from the youngest to oldest, from the most involved student like Na'a, to the gifted and talent students. The garden does not discriminate. It is open and giving, a reflection of the pono culture we need to promote. The GLOs, they give some direction to understand the pono culture. Self-directed learning, complex thinking, community contributor, guality producer, effective communicator and ethical use of technology, they are all outcomes of a pono culture. (personal communication, field notes, fall 2010 - 2011) When Danny shared the above with me, it validated the work and effort taken to understand the six GLOs from a Hawaiian cultural and value perspective. Less than a hundred years ago, the Hawaiians were self- sufficient, feeding themselves from land and sea. We are so far removed from that practice in this century, importing 85% of our food and 90% of our energy sources. We are educating our students for a future we do not know about. Changes in technology, climate, globalization, and culture are happening rapidly. Some of the skills I learned as a child are now obsolete. However, the six GLOs are life-long skills, culturally pertinent and ageless. I believe that these are some of the skills needed to help us create a sustainable future. I stated before

that my first assumption of education was: the purpose of education is to help us create values in our actions, develop love in our thinking, and foster equality and righteousness in our emotions. I believe that the findings of this research project exemplify that the interdisciplinary standards-based school garden curriculum used in the Discovery Garden at Kohala Elementary School was a positive step in the direction to meet the purpose stated above. As students develop and apply the six GLOs, they can create values in actions; they can care for the earth in the place and space of the school garden and thus, can develop love in their thinking; and they can foster equality and righteousness (pono) in emotions as they work with their community around food.
