### RELATING TO PRESCRIPTION DRUG BENEFITS

Chairperson Nakashima and Members of the Committee:

The Employer-Union Health Benefits Trust Fund's (EUTF) Board of Trustees (Board) has not yet had a chance to review and discuss HB 2050. However, I would like to inform you that the EUTF is poised to send out a Request for Proposals (RFP) to conduct a comprehensive claims audit of the current pharmacy benefit manager (PBM) to ensure that claims are being processed in accordance with the contract between EUTF and the PBM, that participants are receiving the benefits to which they are entitled, and that cost containment measures and contractual pricing mechanisms are being uniformly applied. The draft RFP is being presented to the Board at its January 28, 2014 Board meeting (see attached agenda). Upon Board approval the RFP will be posted on the State Procurement Office's website to solicit competitive proposals. The scope of the audit will include, but not be limited to:

- Audit of administrative procedures and system edits
- Audit of claims processing, including verifying claims are paid in accordance with contract provisions

- Audit of rebates
- Audit of mail order brand drug acquisition costs

The period of the audit will be May 1, 2012 to June 30, 2013 for the active employee and non-Medicare retiree plans and July 1, 2012 to June 30, 2013 for the Medicare retiree plans.
