The Honorable Karl Rhoads, Chair; The Honorable Sharon E. Har, Vice Chair; and Honorable Members of the House Committee on Judiciary:

Thank you for considering the Hawaii State Ethics Commission's testimony on HB No. 206, Relating to Mandatory Ethics Training. The Commission <u>strongly supports</u> this bill.

The State Ethics Code requires certain high-ranking state elected and appointed officials to attend a mandatory ethics training class administered by the Commission. The state officials who are currently required to take this class include all state legislators, members of the Board of Education and the trustees of the Office of Hawaiian Affairs, the Governor and Lieutenant Governor, and all executive department directors and deputy directors.

HB No. 206 requires mandatory ethics training for additional high-ranking state employees. Under the bill, mandatory ethics training would be required for all state employees who file public financial disclosure statements with the State Ethics Commission. This would include the President, Vice Presidents, Chancellors, and Provosts of the University of Hawaii; the Superintendent and Deputy Superintendent The Honorable Karl Rhoads, Chair The Honorable Sharon E. of Education; the State Librarian and Deputy State Librarian; the Administrative Director and Deputy Director of the Courts; the Administrative Director of the State; and the Administrator and Assistant Administrator of the Office of Hawaiian Affairs.¹

The Commission believes that requiring these additional employees to attend an ethics training class will instill a greater awareness and understanding of the ethics laws at the highest levels of state government.

HB No. 206 also provides greater flexibility to the Commission in scheduling and conducting the mandatory ethics training class. Currently, the law requires that the class be held in January of each year and be at least two hours in length. The bill provides that the class may also be held at other times as determined by the Commission and deletes the two hour requirement. This will enable the Commission to avoid scheduling conflicts with other events in January, such as the opening of the legislative session and pre-session informational budget briefings by state agencies.

We appreciate the opportunity to testify in support of HB No. 206, Relating to Mandatory Ethics Training. We would like to thank this Committee for its consideration of our testimony in support of this measure.

¹ Another bill that the Commission strongly supports is **HB No. 207**, **Relating to Public Financial Disclosure Statements**, which would require members of the following additional state boards to file public financial disclosure statements: the Board of Regents, the Board of Agriculture, the Board of Land and Natural Resources, the Hawaiian Homes Commission, the Hawaii Labor Relations Board, the Labor and Industrial Relations Appeals Board, and the Public Utilities Commission. If HB No. 207 is passed, the members of the state boards affected by the bill would also be required to receive mandatory ethics training under HB No. 206.

TESTIMONY OF SUPPORT Carmille Lim, Executive Director, Common Cause Hawaii

Dear Chair Rhoads, Vice Chair Har, and Members of the House Judiciary Committee:

Common Cause Hawaii supports HB206, which would require all legislators and employees* whose financial disclosure statements are public, to complete mandatory ethics training. This bill would also allow the Ethics Commission to conduct training at times other than in January; it will also repeal the minimum duration requirement for training.

We believe that by requiring employees to complete ethics training, we are taking precautionary measures to protect them -- by empowering them to learn about what the Ethics Commission's Codes of Conduct and expectations are, and by extension, how we as citizens expect employees to conduct themselves.

Further, by allowing the Ethics Commission to conduct training at times other than in January, legislators can focus their energy on legislative session. Lastly, the current ethics training mandate requires a minimum of two hours in duration. By repealing the existing minimum two hours duration for training, the Ethics Commission is given the flexibility to conduct a more efficient and shorter training, if they so choose.

Thank you for the opportunity to testify in support of HB206.

*Employees as defined in **§84-3**: "Employee" means any nominated, appointed, or elected officer or employee of the State, including members of boards, commissions, and committees, and employees under contract to the State or of the constitutional convention, but excluding legislators, delegates to the constitutional convention, justices and judges.
