Aloha Chair Takai and members. My name is Allen K. Hoe, I am here today to speak in support of HB 2071. As a keiki o ka aina, when it came my time to serve my country, in 1966 I did so with a lot of pride following in the "local" tradition of many of my ohana and friends. I thought I knew what being a "Gold Star Family" meant in the days of my youth.

In combat in Vietnam I experienced the horrors of war as I witnessed buddies standing next to me lose their lives. In Vietnam the casualties we took made us all a little numb to the cruel realities of war. I thought that I understood what being killed in combat was all about.

On January 22, 2005, when the 2 Army Officers came to my home in beautiful Maunawili Valley, I was not prepared for that message and the reality that my son Nainoa, had given his last full measure devotion, as President Lincoln would say, for his country in a place so foreign and so evil.

It still puzzles me why little is known about one of our Nation's most revered symbols, the "Gold Star Lapel Button" which Congress approved in 1947 to recognize the families of service members who lost their lives while engaged in action against an enemy of the United States. In 1973, Congress added the Lapel Button for the Next of Kin of Deceased Personnel to honor those who lose their lives while serving on active duty or while assigned in a Reserve or National Guard unit in a drill status.

House Bill 2071 which proposes to designate a special day in honor of the families of the men and women who have sacrificed so much for our great nation is a very fitting tribute and a way to remind all of us that freedom is not free.

I respectfully submit my testimony in support and urge the members of this committee to adopt this measure.

Aloha,

I would like to share my testimony.

I do not wear the Gold Star Pin with the purple background, but I do wear the Gold Star Pin known as the "Next of Kin Lapel" because my husband died while serving in Active Duty, but not down range. As a Gold Star Family Member I feel that passing the bill will not only show continuous support from our legislature and continuous education to the community of the sacrifices that our Service Member and, us, Families made, but a true way of continuously honoring those who made the ultimate sacrifice for our wonderful nation. My husband served four tours down range (1 Afghanistan and 3 Iraq), and was fortunately able to return home. However, August 21, 2012 changed our lives when we were notified of his death. He died at South Hampton, NY, due to a heart failure while traveling with our Presidential and Vice Presidential team with his unit, White House Communication Agency. Whether our Service Members were Killed in Action, or died on the Roads, due to illness or because they took their own lives, our Fallen Heroes and Families should be recognized and Honored for the many sacrifices made. This is why, I, as a Gold Star Family Member, request that the bill be passed.

I hope that you are able to use my testimony. Thank you for allowing me to share.

My name is Brandy Williams and I am the widow of Sgt. Eugene Williams. My husband was killed in Najaf, Iraq in support of Operation Iraqi Freedom. He deployed to Iraq with the 2-7th Infantry Marne Division out of Ft. Stewart, GA. His unit was one of the first to enter Bagdad and on March 29, 2003 my husband and three other soldiers were manning a road side check point. A taxi cab pulled over and waved for help. As my husband and his soldiers approached the vehicle, the driver detonated a bomb, killing my husband, Cpl. Michael Curtain, PFC Deigo Rincon and PFC Michael Creighton.

Our lives were forever changed that day. I lost my best friend, soul mate and the father of my then 3 year old daughter and another daughter still in my womb. Almost 11 years have gone by and not a day goes by that we don't think about him as we miss him dearly. We continue to honor him in every way we can. My husband loved what he did and went to war proudly serving his country. We have lost and continue to lose many brave service members. As we hope they will never be forgotten, honoring them through their families will help to ensure this.

I am asking that you support HB 2071, Relating to Gold Star Family Day. This day will help to honor our fallen loved ones. It will help to ensure that Hawaii will never forget those that have died fighting for their country.
