HOUSE BILL NO. 2076 RELATING TO PEST CONTROL

Chairperson Wooley and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 2076 relating to pest control. This bill amends Section 141-3, Hawaii Revised Statutes to read that the "department of agriculture [shall,] may, so far as reasonably practicable, assist [, free of cost to individuals,] in the control or eradication of insects, mites, diseases . . .; and [shall] may in like manner distribute to points where needed, beneficial insects, or pathogens and other antidotes . . . ."

The Department believes this bill may not be necessary. It is the Department's opinion that Section 141-3 HRS, already gives the Department the discretion on whether or not to assist landowners in the control or eradication of pests. Particularly, HDOA believes that "reasonably practicable" in Section 141-3 gives the Department sufficient discretion.
