9 "Traffic infraction" means the same as defined under 10 section 291D-2.

"Uncontested traffic infraction" means a traffic infraction for which the person noticed under section 291D-5 does not contest the infraction. A person "does not contest" an infraction if, in accordance with section 291D-6(b)(1), the person admits the commission of the infraction without requesting a hearing to explain mitigating circumstances and pays or remits bail forfeiture by mail within thirty days.

RELATING TO TRAFFIC INFRACTIONS AND RELATING TO MOTOR VEHICLES

House Bill Nos. 214 and 590 both require the Director of Finance to transmit to the counties, 30 days after the end of each fiscal quarter, the proceeds from uncontested traffic infractions, as identified by the Judiciary.

House Bill No. 214 adds a new chapter to the Hawaii Revise Statutes (HRS) titled "Transmittal of Uncontested Traffic Fines and Forfeitures to Counties" and requires the Director of Finance to transmit to each county an unspecified percentage of all the proceeds from uncontested traffic infractions committed in that county that are in excess of the administrative costs of the Traffic Violations Bureau (TVB).

House Bill No. 590 adds a new section to the HRS and limits the proceeds from uncontested traffic infractions to those relating to the use of mobile electronic devices while operating a motor vehicle.

The Department of Budget and Finance opposes both measures because they would reduce general fund revenues. Furthermore, Judiciary, in testimony on House Bill No. 1749 from the 2012 Legislative Session, stated that determining the administrative costs of the TVB would be "extremely complex and the accounting to do this would be expensive and time consuming." While salaries for TVB positions are easily identifiable, traffic violation activities are also performed by District Court

personnel, court administrators and judges who are not solely dedicated to those functions alone. In addition to identifying and allocating those salary and fringe benefit costs, it would be necessary to identify and allocate support costs such as database management and maintenance, non-District Court support staff (information technology and fiscal operations) and other administrative costs.

Bill No. and Title: House Bill No. 214, Relating to Traffic Infractions

Purpose: Requires the state director of finance to transmit to each county a percentage of all fines and forfeitures collected for uncontested traffic infractions committed in that county, with certain exceptions. Effective July 1, 2013.

Judiciary's Position:

The Judiciary takes no position as to the merits of this bill, but wishes to comment on certain operational and technical aspects. The Judiciary respectfully recommends that reference to paying the "administrative costs of the traffic violations bureau" be removed, and, should this bill move forward, a specific percentage to be transferred, as provided for in the bill, be established.

House Bill No. 214 states:

"...the state director of finance shall transmit to each county not more than thirty days after the end of each fiscal quarter _____ percent of all fines and forfeitures collected for uncontested traffic infractions committed in that county which are in excess of amounts required by the State to pay the administrative costs of the traffic violations bureau." (page 2)

Essentially, determining the exact "administrative costs" incurred in operating the TVB in four different circuits would be extremely complex and the accounting to do this would be expensive and time consuming. As noted in the Legislative Reference Bureau's report, "Stop, Go, Caution: the Feasibility of Transferring the Traffic Violations Bureau to the Counties, Report No. 4, 1996":

> "It is unclear exactly what costs are associated with operating and supporting the TVBs. While the Judiciary was able to supply the Bureau with figures as to the most recent fiscal year's realizations, it is not set up to pull out all of the costs associated with running the system. It can pull up staff salaries, for example, but not benefits, nor can it isolate all the costs for support services."

With respect to staff salaries, it is easy to identify the amounts for positions that are identified as dedicated to TVB positions; however, many of the District Court personnel, court administrators, and judges work in traffic violation activities but are not dedicated to those functions alone. With regard to support costs, they would include a large element of the Judiciary Information Management System (JIMS), the primary computer database for handling traffic offenses. In addition, there is the non-District Court "support staff" which plays an important role in TVB functions, such as JIMS staff, Information Technology and Communications Division staff, and fiscal officers.

Therefore, reference to the "administrative costs of the traffic violations bureau" should be removed and discussion limited to establishing a specific percentage to be transferred to the counties.
