#### In consideration of HOUSE BILL 2177 RELATING TO COMMUNITY FOOD FORESTS

House Bill 2177 proposes to establish a community food forest program that works collaboratively to provide a source of healthy food. The Department of Land and Natural Resources (Department) supports the intent of this bill, but does not feel it is necessary.

House Bill 2177 proposes to create a program within the Department focused on the establishment and maintenance of community food forests. The idea of community food forests or agroforestry systems provides a number of benefits to the public, including increasing tree canopy cover, improving watershed health, providing a source of food, and contributing to healthier and happier communities. The Department's Division of Forestry and Wildlife has already begun discussions with communities surrounded by forest reserves to engage their interest in community managed agroforestry systems as a part of the forest reserve system. These community discussions have raised a number of issues for the Department; include the ability to provide long-term maintenance to manage these food forests, as well as protection of these areas from vandals. The Department does not have sufficient resources to maintain or police such areas. Ideally, these agroforestry systems would be managed by their communities, thus encouraging engagement with our natural environment, connecting communities with their food resources, discouraging vandalism, and improving health through the active maintenance of these areas.

Through the Forest Stewardship Program, the Department has been encouraging private landowners to invest in such agroforestry projects, which has included both privately owned food forest establishment as well as community managed agroforestry systems. The Kokua Kalihi Valley project on Oahu is an excellent example of a community managed forest that provides forest resources and opportunities for the public to engage in forest management. Additionally, the Department also supports the implementation of Kaulunani Urban and Community Forestry Program, funded in part by the United States (U.S.) Forest Service, which works with local government and communities to increase and improve management of our urban forests and trees. Kaulunani has participated in and funded numerous tree planting projects at our elementary, intermediate and high schools; at our urban parks and cemeteries; along roadways; and in our city zoos.

The purpose of a food forest is to plant and grow an edible urban forest garden that grows our own food, bring the community together while improving public health. Adequate and sufficient spaces are needed, along with sufficient funding and personnel to run such a program. The Department recognizes that community forest gardens are important to an island state. The existing Urban and Community Forestry Program has funded food forest type projects, and also has worked with numerous communities across the state over the last 20 years. If this initiative were adequately funded there would be ample opportunities to have a successful program.

The Department believes that through these two existing programs, the goals for House Bill 2177 could be met without creating a new program. The Department does note that due to increase interest from the public over the last two years as well as the reduction in grant support provided by the U.S. Forest Service, funding for these programs is becoming more limited. The Kaulunani Program is funded entirely through the U.S. Forest Service grant program and donated match from community groups and tree planting projects.
