Testimony of Lynn N. Fallin Deputy Director, Behavioral Health Administration February 19, 2014

1 Department's Position: The Department of Health supports H.B. 2304, H.D. 1, relating to the

- 2 Neurotrauma Advisory Board.
- 3 Fiscal Implications: There are no fiscal implications.

4 **Purpose and Justification:** H.B. 2304, H.D. 1, proposes to amend HRS §321-3 to change the

5 minimum number of members on the Neurotrauma Advisory Board (NTAB) from 21 to 11 members

6 as appointed by the Director of Health. The smaller number of members will allow the board to

7 have quorum on a regular basis and improve the effectiveness of its statewide advisory board's

8 capacity to assist the Department to meet its legislative charge. More importantly, a total of three (3)

9 survivors or family members of individuals with neurotrauma will be appointed to the Board by the

10 Director and will have the highest number of representatives as compared to the other groups. This

measure proposes to delete representation from the Spinal Cord Injury Association as this

12 association is no longer in operation. A spinal cord injury survivor or family member will continue

13 to be represented on the NTAB. The Department has discussed this measure with the Board and

14 they are in support of reducing the number of board members. The Department is recommending an

amendment to this bill by amending language in Section (b) (6) to remove the requirement of the

Promoting Lifelong Health & Wellness

1	Department appointing a representative from the American Stroke Association with "One
2	representative for persons with stroke." This amendment provides the Department with flexibility in
3	appointing to the Board a family member of a stroke survivor, a stroke survivor, or an entity or
4	organization representing individuals with stroke. Lastly, this measure will allow the Director to
5	appoint up to three state and county ex officio non-voting members to the NTAB. Partnerships and
6	collaboration with such entities will provide a more coordinated effort for NTAB initiatives.
