RE: H.B. 237, H.D. 1; RELATING TO ALTERNATIVE SCHOOLS FOR JUVENILES INVOLVED IN THE JUSTICE SYSTEM.

Chair Rhoads, Vice-Chair Har, and members of the House Committee on Judiciary, the Department of the Prosecuting Attorney of the City and County of Honolulu ("Department") submits the following testimony in strong support of H.B. 237, H.D. 1. The original bill was part of the Department's 2013 legislative package.

The purpose of this bill is to address and curtail increases in juvenile crime, which have prompted business groups to request assistance in curbing crime against their establishments. Of particular concern is the number of incidents involving juvenile offenders as young as 12 years old, many of whom are being excluded from the public education system.

At the same time, the Family Court has begun a program called Juvenile Detention Alternative Initiative (JDAI), diverting students from detention because of a philosophical belief that juvenile detention is inappropriate for juvenile offenders. Unfortunately, there are not many alternative programs currently available for juvenile offenders. Thus, we are faced with the problem of addressing the safety of businesses and the community while Family Court diverts juvenile offenders to detention alternatives that are lacking or non-existing.

H.B. 237, H.D. 1 would provide funding for the Department of Education ("DOE") to establish and implement two (2) additional "alternative schools" for at-risk youth, to be located in the Leeward School Distrct and Honolulu School District. While the Department defers to the DOE regarding exactly what would be entailed or necessary to implement these additional alternative schools, we recommend looking to the DOE's "High Core Program" (formerly known as Storefront School)— located in Central School District—as a prime model for duplication.

KANESHIRO PROSECUTING ATTORNEY High Core serves students who are identified by their home-schools as severely alienated or at-risk, and specifically seeks to reduce or prevent student dropout in the school district. In addition to academics, High Core helps at-risk students to develop appropriate socio-emotional competencies and other self-development through guidance and counseling activities.

In this way, alternative schools can address the needs of individual students by providing non-traditional education in an actual school environment, by utilizing curriculum specially designed to be appropriate and relevant, with a committed and decisive effort to keep at-risk youth in the education system. We need to divert these youth from the juvenile justice system and continue to provide them with appropriate education.

Because High Core has had such success using a stand-alone facility for its programs, the Department would highly prefer that this be done for the alternative schools in Leeward District and Honolulu District as well. In particular, it appears that Queen Lydia Liliuokalani Elementary School campus may no longer be in use, shortly, so this may be a good location for the Honolulu District's alternative school.

Although the Department's primary role is to prosecute juvenile and criminal cases within the justice system, our overarching focus is on public safety for the community, and that starts with prevention and education. As such, the Department strongly supports the duplication and implementation of programs such as High Core, to assist at-risk youth before they ever become part of the juvenile justice system, or the criminal justice system.

Attached is the budget breakdown for one school—based on figures from High Core / Storefront—to estimate the anticipated costs. To fund two additional schools, the approximate cost would be \$1.4 million. In light of the much-higher costs of prosecuting, imprisoning, supervising and/or treating adult offenders, the Department strongly believes that the cost for these two alternative schools is a small price to pay, to educate our at-risk youth and provide hope to a generation of youth who may otherwise end up in our adult correctional system.

For the foregoing reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu strongly supports H.B. 237, H.D. 1. Thank you very much for considering this matter.

To The Honorable Chair Rhoads and Members of the Committee:

The Hawaii State Teachers Association (HSTA) <u>supports to H.B. 237, H.D. 1</u>, "Relating to Alternative Schools for Juveniles involved in the Justice System."

HSTA is the exclusive representative of more than 13,500 public and charter school teachers statewide. As the state affiliate of the 2.2 million member National Education Association, the HSTA supports H.B. 237, H.D. 1 which provides the means in the form of a grant-in-aid to the Department of Education for an alternative school in Leeward District.

HSTA believes in legislation that provides separate facilities for minors detained for criminal offenses from, those detained for status offenses. As such, these facilities should be separate from those for adult offenders.

While it is easy to focus energy only on successful students, HSTA feels that an equally important part of nurturing a safe school environment is the development and viability of a wide range of alternative education programs which help troubled students find positive and constructive ways to deal with anger, frustration, or alienation.

Further, HSTA believes that all methods of behavioral interventions should be exhausted before resorting to the exclusion of students in a school setting. This does not preclude the removal of the offender from the school setting in order to protect other students and school employees.

As such, HSTA supports <u>H.B. 237, H.D. 1</u>, "Relating to Alternative Schools for Juveniles Involved in the Justice System."
