In consideration of HOUSE BILL 2380 RELATING TO SHARK AND RAY PROTECTION

House Bill 2380 proposes to prohibit any person from knowingly capturing, harming, or killing any species of shark or ray in state waters. The Department of Land and Natural Resources (Department) appreciates the intent of the bill and offers the following comments:

The Department believes the scope of the bill including all species of shark is too wide. We recommend that the species of sharks included in the bill be limited to those species categorized as *Vulnerable*, *Endangered* or *Critically Endangered* according to the International Union for Conservation of Nature (IUCN) Red List of Threatened Species.

The Department also recommends the same criteria be applied to all rays in State waters.

The capture of sharks in federal waters is permitted by the Magnuson–Stevens Fishery Conservation and Management Act. Once the fisher in possession of a dead shark passes from federal into state waters, the proposed measure's prohibition on the capturing, harming, or killing of sharks will be difficult to enforce as proof the shark was taken within state waters will be difficult to determine.

We are in strong support of HB2380 for the following reasons:

>> Most shark species are at the brink of extinction due to over exploitation and careless fishing practices

Many of the shark and ray species found in Hawaii are now extremely rare or endangered. Even when the animals are not targeted, commercial fishing practices kill millions of sharks every year as bycatch. We must take drastic steps to halt and reverse this trend. Protecting sharks and manta rays in State waters is an important step for a better future.

>> Sharks are worth more to the economy alive than dead. Killing a shark for its fins or for sport has minimal, one time economic gains. A live shark has inmeasurable value for our ocean eco system. On islands that depend on dive tourism, sharks and rays are the number one attraction that will bring divers to a site. People from all over the world will travel great distances and spend their whole vacation in areas that offer diving with sharks and manta rays. Studies have shown that in Palau, a major scuba diving destination in Micronesia, a single reef shark can have a value of \$200,000 over its lifetime due to sharks and rays being one the main drivers of the dive tourism industry.

>> Live sharks are an intrical part of food security for Hawaii. They play a cruial part in the health of our oceans. Sharks and Rays are also an important link to our potential as a eco tourism destination. Heatlhy ocean eco systems depend on a healthy stock of top predators. There is no doubt. Scientific data has been collected, proven and published. There is no question that a healthy reef needs healthy fish populations. Fish populations need predators to be kept in balance. Even dolphins and turtles depend on predators to keep diseases from spreading by taking out the sick and weak before they can pass on their virus to the rest of the population.

Tourists value the opportunity to see ocean life in its most natural state. Hawaii still has a chance to become a haven for marine life if the State starts to aggressively protect its resources from over fishing. Reefs will have a chance to recover, and reef fish could become abundant again. Protecting sharks and rays is an intrical part of that equation. This would not only ensure food security for the future, but it would turn Hawaii into a desitnation for eco touristm, which is one of the fastest growing tourism markets world wide.

>> Hawaii is setting a great example as a State that acts with foresight and that values its natural resources. The Hawaii shark fin ban of 2010 is still being heralded as one of the most succesful measures of ocean conservation. Many States and Nations followed this ground breaking law.

>> Cruelty to animals is no longer tolerated by the international community.

Recent videos of sharks being caught and tortured by fishermen in Hawaii went viral on the internet and the following outrage and disgust showed clearly that people do not approve of these practices any more. Protection of sharks has become an issue of highest priority in most countries, including the ones that most of our visitors come from. **Reactions to senseless shark slaughter caused a bigger outrage than shark attacks.** If you have followed the trend of how residents and visitors reacted to shark incidents in Hawaii, by internet, blogs and YouTube, you will have noticed that the outrage over the possible culling of sharks was by far greater than the fear of recurring attacks.

TESTIMONY IN SUPPORT OF HB2380 RELATING TO SHARK AND RAY PROTECTION

Dear Committee, Chair and Members,

World Oceans Day Hawaii is in strong support of HB2380 for the following reasons.

I. <u>Sharks and Rays are indispensable to the health of the ocean</u> ecosystem and human survival:

Sharks have occupied the top of the oceanic food chain for the past 450 Million years, mastering a delicate balancing act by keeping fish populations in check, predating on the sick, the old and the weak. Without sharks, the ocean's health will continue to steadily decline.

More than 70% of the oxygen we breathe is supplied by the sea, two-thirds of the world's population relies on the ocean for their main source of protein and more than 2 billion people depend on it for income. – There is no doubt that without healthy oceans, human life on Earth becomes a significant challenge.

II. Most shark species are threatened by extinction due to overfishing:

Many shark and ray species found in Hawaiian waters are becoming increasingly rare and endangered due to destructive fishing practices, by-catch and habitat destruction. We must take consequential measures to ensure their survival. Protecting sharks and rays under HB2380 is a crucial step towards successfully managing our marine resources and safeguard the animals that call the ocean home.

Many shark populations have declined by as much as 90%. Of the 546 shark species assessed by the International Union for Conservation of Nature (IUCN), 110 are classified as endangered, threatened or vulnerable. Sharks now represent the greatest percentage of threatened marine species on the IUCN Red List.

III. Sharks and Rays worth more alive than dead - Benefits of ecotourism:

Scientists from the University of British Columbia have come to the conclusion that shark ecotourism generates over US\$314 million per year (a figure that could double in the next twenty years if tourism trends continue). – See figure below.

In contrast, the value of shark fisheries has been in decline in spite of increased fishing efforts and expanse. Their results suggest that if trends continue, the protection of shark species could have important economic benefits.

Hawai'i now has the opportunity to choose long-term sustainable development over shortsighted financial gains.

The shark ecotourism industry currently generates over US\$314 million in expenditures per year. Projections indicate that global expenditures could double in the next 20 years.

IV. Hawai'i: An international champion for the Oceans

By protecting sharks and rays, our state can continue to be a champion for the oceans, at the forefront of shark conservation. Following the groundbreaking 2010 Hawai'i shark-fin ban, which encouraged states across the nation to stand up for sharks, Hawai'i now once more has the opportunity to prioritize environmental stewardship and sustainability for current and future generations.

While Australia is executing a shark cull as you read these words, Palau's President Tommy Remengesau announced today (February 5, 2014) that the island nation would become a 100% marine sanctuary, banning all commercial fishing. – He states: "It's our livelihood, it's our culture, it's our economy - I always say the economy is our environment and the environment is our economy."

My question for you is: "Isn't it ours, too?"

Please help by passing HB2380 out of your committee without exemptions, delays or additional language that may weaken its effectiveness.

TESTIMONY IN SUPPORT OF HB2380 RELATING TO SHARK AND RAY PROTECTION

Dear Representatives Hanohano, Cullen and Committee Members:

PangeaSeed, a locally based ocean conservation organization, strongly supports the passage and implementation of HB2380 RELATING TO SHARK AND RAY PROTECTION, as written and posted this date for public comments.

I. For the sake of preserving cultural heritage for generations to come:

Through our educational activities, we connect and collaborate closely on a daily basis with members of the local Hawaiian community, both young and old alike. – And I see first-hand the importance and cultural significance of sharks and oceans to the Hawaiian people. Through story telling and personal experiences passed down through generations, the human connection to sharks and oceans is undeniable in Hawaii – and one that is truly unique and inspiring.

II. Sharks and manta rays are worth more to the local economy alive than dead:

Killing shark for their fins or for sport and manta rays for their gills has a very limited one time economic benefit. Where as a live shark or manta ray provides immeasurable value for the health and balance of our quickly depleting oceans. The United Nations estimates that global fish stocks could be in complete collapse by mid-century if the current destructive fishing practices continue.

Studies have shown that a single reef shark in Palau, Micronesia can have a value in the hundreds of thousands of dollars over its lifetime due to sharks and manta rays being top sought-after animals for scuba divers.

The dive industry is a multi-billion dollar industry with individuals and families planning entire vacation budgets around interactions with the marine animals such as sharks and manta rays. These people seek out locations considered rich in ocean biodiversity - with Hawaii being at the top of the list of destinations. These tourism dollars help to sustain otherwise limited island economies that depend on the health of our oceans for its short and long term survival.

Manta ray tourism in the Hawaiian Islands is hailed as world-class – with the Kona coast being a top destination for divers the world over. The manta ray tourism industry in Kona is extremely profitable and essential to the wellbeing of the local community. By taking steps now to protect manta rays, you are investing in the sustainability and health of Hawaii's natural resources for generations to come.

III. Sharks and manta rays play a critical role in the health and balance of our oceans:

Scientific data has been collected, proven and published focusing on how sharks being top apex predators are controlling agents and play a critical role in the balance of our oceans in ways other fish do not. Global fish populations depend on these top predators to be kept healthy and in balance. Without sharks and rays balancing the fragile ocean ecosystem, sick and diseased fish will have no natural predators posing a massive threat to food security in Hawaii and the world. While species lower on the food chain will boom in population causing a spiraling cascade of catastrophic consequences.

With our planet's human population now over 7 billion – and estimated to reach 9 billion by mid-century, the issue of food security threatens us all. The oceans are the life support system of our planet providing 70% of the oxygen we breathe, regulate weather & climate change, feed and provide jobs for over 2.5 billion people on the planet. Taking away vital marine animals of such importance can and will result in catastrophe. Healthy oceans need healthy shark and ray populations.

IV. An estimated 100 million sharks are killed each year to satisfy the global trade in shark fins:

Sharks and rays have inhabited our seas for hundreds of millions of years but humans know comparatively little about them. However we do know, like humans, most large sharks and rays are long-lived, late to mature and produce few offspring which means they can not handle the pressures of overfishing. Though the IUCN (International Union for Conservation of Nature) estimates that many sharks species have declined by as much as 90% due to unregulated and illegal fishing practices fueled by the demand for shark fin in Asia.

Many of the shark and ray species native to Hawaii are now considered rare and endangered in other parts of the world. Even though these shark and ray species might not be the target of commercial fisheries, they are caught and killed in the millions annually as by-catch. We must take this rare opportunity to put in place and secure laws and regulations that help to protect oceans and marine species for the benefit of ourselves and for future generations.

V. The tides are changing and Hawaii's future is in your hands:

In 2010 the state of Hawaii made global headlines with its lawmakers banning the sale, trade and possession of shark fins. The pioneering decision kick started a trend and continues to make waves around the world persuading other states and island nations to realize the importance of protecting sharks and oceans. By supporting HB2380, you have the rare opportunity to add to this legacy and continue to lead the global movement to sustain our seas. Passing this bill would once again place Hawaii at the global forefront of ocean conservation.

All eyes are on Hawaii - and the world is watching to see what choice you will make regarding the outcome of HB2380 – sustainability or destruction. Please take into consideration the current situation in Western Australia: as I type this testimony, the government's recklessly continues to catch and kill large sharks (including protected species) – which has resulted in a global media backlash with a massive international online movement criticizing this ignorant and unsustainable policy.

Though in the western pacific, President Remengesau announced yesterday during a United Nations oceans conference that the island nation of Palau will ban commercial fishing and its 200 nautical mile Exclusive Economic Zone will become a 100% marine sanctuary. Mr. Remengesau said, "We have no choice - the ocean is our way of life." "It's our livelihood, it's our culture, it's our economy - I always say the economy is our environment and the environment is our economy."

There are countless positive reasons why you should support and pass HB2380 without hesitation – many of which have been mentioned in the testimony above. We ask of you, the committee, to continue to champion for our sharks, manta rays and our oceans. Please support and pass this wonderful and inspiring legislation for the health and sustainability of Hawaii's future.

Comments: Aloha, E kalamai (sorry) I could not be there in person but I live on Hawai'i Island. However, I wanted to provide written testimony and share that I strongly SUPPORT bill HB2380! According to a recent IUCN study (1), more than a quarter of the world's sharks and rays are at a risk of extinction. Here in Hawai'i, sharks and rays are currently being afforded little to no protection (save for the new West Hawai'i Rules Package that since Dec 2013 has protected nine species for West Hawai'i waters only). In fact, some fishermen are still culling sharks because they are a nuisance for their business! And this is legal :(However, sharks are a keystone species within coral reef ecosystems, and their protection is of utmost importance to the health of our marine resources (2,3,4). I have attached a very relevant study by Ruppert and colleagues (2013) for you to review and provided the websites for the rest of the articles for further research. Again, I wholeheartedly support this bill (HB2380) in it's entirety, as it would prohibit the take of any shark or ray species in State waters. WildAid strongly supports the passage and implementation of HB 2380 RELATING TO SHARK AND RAY PROTECTION, as written and posted this date for public comments.

Peer-reviewed scientific research over the past decade reveals that because many of Hawaii's shark species are apex predators their full protection can help support healthy reefs, sustain fish biodiversity, and even enhance local subsistence and small-scale fisheries. Additionally, iconic and culturally important species such as **niuhi** (tiger shark; *Galeocerdo cuvier*) are listed as *near threatened*, globally, on the IUCN's (International Union for the Conservation of Nature) Red List of Threatened Species, making their local protection urgent and valuable.

Given our current understanding of the plight of many ray species, globally, this proposed bill's protection of rays is to be commended. Divers and eco-tourists seek-out and value interacting with both large and small rays; and with Kona already recognized as a world-class destination for manta rays, Hawaii may benefit from increased economic development around diving with more protected rays. Our current and on-going research reveals that manta and mobula ray populations are under increasing threat globally as the market for their gills in China continues to grow; their protection is now urgent.

With the passage of HB 2380, following Hawaii's precedent-setting 2011 shark fin ban law, Hawaii will continue to be recognized as a global leader in shark, and now ray conservation, setting a positive example for additional states and nations to also protect valuable chondrichthyan (shark and ray) populations.

Thank you for accepting our testimony and for your work to protect Hawaii's marine resources.

The Office of Hawaiian Affairs (OHA) offers the following <u>COMMENTS</u> on HB2380, which would prohibit the capturing, harming, or killing of any shark or ray species in state waters.

OHA supports the intent of this measure, in seeking strong protections for culturally important species that also serve critical ecological functions. OHA appreciates the recognition in this bill of the cultural significance of Hawai'i's shark and ray species to Native Hawaiians. For example, sharks and rays are recognized as kinolau for Kū and Kanaloa, and certain individuals and species can be regarded as 'aumakua by some families. Sharks and rays are used for traditional and customary practices, including in the crafting of implements, weapons and ceremonial objects; their meat also serves as a source of food. Sharks and rays are also featured in moʻolelo, 'ōlelo no'eau, and other cultural narratives that inform the Hawaiian understanding of the world and our natural environment.

OHA further understands that the ecological services provided by apex predators such as sharks also promote a healthy ocean environment, which is necessary for the continuation of Native Hawaiian cultural and subsistence practices.

OHA urges the committee to consider providing some pathway for the continuation of Native Hawaiian traditional and customary or subsistence practices that may involve the taking of sharks or rays, to the extent that such practices may be continued without threatening the continued existence of these creatures, or the critical ecological services they perform. Insofar as some shark and ray species found in Hawai'i may still be considered as having a "lower risk" of extinction, as species either "near threatened" or of "least concern," OHA believes that limited exceptions to the general take prohibition for sharks and rays may be possible. In the interest of perpetuating Native Hawaiian culture and the cultural connection between Native Hawaiians and the natural ocean environment, OHA urges the committee to provide some reasonable avenue for the continued exercise of cultural or subsistence practices, should it decide to move this measure forward.

On behalf of The Humane Society of the United States' members and supporters across Hawaii and The HSUS's international arm, Humane Society International (HSI), we urge your support of H.B. 2380, based on the following:

- In 2010, Hawaii became the first state in the world to enact a prohibition on shark-finning and the sale of shark-fins or fin products. This measure would complement this existing law, again poising Hawaii to be the leader in shark and marine conservation.
- Up to 73 million sharks are estimated to be killed annually for their fins. While laws such as the above are slowly helping to improve shark populations, many species are still threatened and face possible extinction.
- This measure does NOT impact federal commercial fishing laws, and only applies to Hawaii state waters (3 nm).
- There have been numerous incidents, one most recently on the Big Island (Honokohau Harbor) where sharks were harassed and harmed for no purpose other than cruel enjoyment. This measure would prohibit the "recreational" harassment and take of sharks.
- While we don't currently have any large-scale shark-hunting tournaments, like those on the East Coast of the U.S., this would prohibit any future "tournaments" where sharks are taken simply as a 'challenge' as to who can kill the largest.
- Sharks are apex predators; when they are removed our entire marine ecosystem is negatively impacted.
- We do not object to the necessary taking of sharks for education or research or as deemed necessary by other shark experts, especially if removed non-lethally.
- We support the same protections for rays and the addition of any and all ray species present in Hawaii waters.

Aloha Chair Hanohano and Members of the Committees:

The Sierra Club of Hawai'i, with over 12,000 members and supporters, *supports* HB 2380. We concur with the findings of this bill regarding the importance of sharks and rays in ocean ecosystems; their significance in Hawaiian culture; and the need to afford them special protections.

Manta rays, listed by the International Union for Conservation of Nature and Natural Resources (IUCN) as a threatened species worldwide, are already protected under Hawai'i law. Expanding protection to include all ray species in Hawai'i would afford similar protection to the spotted eagle ray, which the IUCN lists as a "near threatened" species with a declining population worldwide. This species is protected by law in Florida state waters, in part to raise public awareness of the need for extensive conservation action. By protecting these rays in Hawaiian waters, we would be sending a similar message for the need for conservation in the Indo-Pacific region, a message that would also be appreciated by the many visitors to our waters fortunate enough to have seen this graceful creature during one of their dive trips.

We are pleased to see that this bill reflects an awareness among lawmakers of the need for an ecosystem approach to fisheries management, one that recognizes the roles species play in ecosystems and accords them worth beyond their possible economic value as a source of food or sport for humans. We urge you to pass this bill.

Aloha House,

As a fisherman, I have some concerns about HB2380. I know there have been some recent abuses of both rays and sharks. My specific concern is about sharks. I did see the YouTube video of those young men that abused the tiger shark at the mouth of Honokohau harbor recently. What they did was disgusting and should be against the law. In fact, when they went to the tackle shop to buy the equipment to do the dirty deed, they were told that it wasn't illegal but they were also advised by the tackle shop owner and another fisherman that was in the shop not to do it.

As I stated, I'm a fisherman. In fact, I catch and release more sharks than any other charter boat captain in Kona and possibly even the state of Hawaii. I do big game bottom fishing and was the top tag and release captain in the whole state when it came to the tagging program for Kahala and Ulua. To top that off, I'm the one credited with the discovery of Almaco Jack (Seriola rivoliana) in Hawaii. That's the fish that Kona Blue (now Kampachi Farms) is raising. I'm the one that turned them on to that particular fish. These fish along with gray snapper and sharks are my main target for my customers to fight.

With that said, the language of the bill worries me. First, the word "knowingly" Capturing or harming a shark. That word is subjective. If I am bottom fishing in an area where I know there is a likelihood of catching a shark, could that be identified as "knowingly" by enforcement? I had a conversation with Dr. Bill Walsh one time and he told me that as defined, the word "take" in the laws concerning undersized fish of certain kinds that are illegal, that by hooking it and bringing it up to the boat (even though I usually don't even know what is on the other end of the line) that would be considered "taking" and I would be breaking the law. Can you see how absurd that is?. That brings me to the word "captured" in the bill. If I hook a shark and bring it to the boat, isn't that the same thing even though I fully intend to release it? I am "catching" it. Also the word "harms". That word is also subjective. If I hook a shark and my angler fights it up to the boat for release, couldn't that be interpreted as "harmed" just because I hooked it? One thing the House should know is that "cutting the line" on a shark it the absolute worst thing you could do. While the shark is swimming, the line dragging through the water keeps tension on the hook making it almost impossible for the shark to shake out the hook and the line might also get hung up in some coral. If you bring it to the boat, you can get almost all the line off but usually can't get the hook back. I have caught many sharks over and over and it really doesn't take them long to get rid of a hook. I have rescued many sharks that have line attached to the hook from encounters with other fishermen and when I catch them and I'm usually able to get the line off and even the hook sometimes. Definitely more healthy for the shark.

Another concern I have is a well known practice done here in Hawaii that when a shark is harassing you while fishing (this is especially true when night fishing), that you tie a small float to a line and hook and feed it to the shark. The shark is now towing the float and is distracted from eating all of the fish you are trying to catch. It works well and the shark is later able to swim "at" the float, get slack in the line and shake the hook out. When Kampachi farms was being harassed by a very big tiger shark several years ago, that was the exact advice they were given by DAR to take care of their problem. Under HB2380, wouldn't that practice be illegal?

I understand the good intensions of people wanting to discourage the deliberate harming of sharks but there must be a way to also protect us fishermen from breaking the new law during the course of just doing what we do. Fish.

IN SUPPORT OF HOUSE BILL 2380 RELATING TO SHARK AND RAY PROTECTION

Sharks and rays are vital to the health of not only Hawai'i's waters, but to the health of our oceans, ourselves, the Hawai'ian culture, and our economy.

Most sharks and rays, being apex predators, are key in the health of the ocean's ecosystems; they keep the population of lesser fish species in check so that species numbers stay balanced in a given area. Invasive species are also likely to be consumed by these predators, keeping the native ecosystem functioning normally. Sick and diseased are also easily consumed by sharks and rays, making it less likely to pick up these fish in nets or on lines and placing them in markets to be sold to restaurants or the general public. Sharks especially, have great significance in Hawai'ian culture, having high places in mythology along with symbolism to the native people. Ecotourism industries such as shark cage outings and dive companies bring in a great percentage of money to our economy here on the islands. Manta rays and whale sharks are considered "must-sees" among many tourists, and many are willing to pay to see these magnificent creatures in their natural environment.

If anybody knowingly removes sharks and rays from the water, not only are they disrupting the ecosystem, but they are inadvertently putting other human beings at risk by increasing the probability of sick and diseased fish being caught and sold as food for people when they normally would have been removed naturally by predators. Anyone removing sharks and rays are also allowing invasive species to get a foothold, since the predators are not around to consume them. People killing sharks or rays are also descerating an important aspect of the Hawai'ian culture and taking business away from those running ecotourism outings by eliminating the essential sights to their dives.

Overall, I am in support of bill HB2380. I am in agreement with most of the administrative penalties proposed in this bill; however, I personally believe heavier fines should be imposed for violating section 2 of this bill, being: Exactly \$1000 for each shark harmed, taken, or killed on a first offense; and exactly \$5000 for each shark harmed, taken, or killed on a second offense.
