Eternal Flame memorial on Beretania Street, as well as committee member reimbursements (travel costs) and overview administrative services associated with development of the report to the State Legislature; and

 DAGS defers to DLNR-State Historic Preservation Division on matters relating to historical significance.

Aloha Chairman Takai, Vice chair Ito and members of the Committee gathered to discuss HB 2440 that is titled **Re: to the Hawaii State Capitol Area**, but could also be entitled **Re: to the Relocation and Continued Dishonor of Queen Liliuokalani.** I am Soulee Stroud president of the Association of Hawaiian Civic Clubs here to say that we will not support moving the statue of Queen Liliuokalani across the street near the Eternal Flame.

Members of the Hawaiian Civic Clubs were involved in the planning and dedication of the Queen's statue. Gladys Brandt, a prominent member of the community and staunch civic club member was the chair of the commission. There was much discussion as to the placement of the statue, including whether it was proper for the Queen's back to be toward Iolani Palace.

Ultimately it was decided that she faced the Capitol leading her people into the future from <u>"...the walkway behind the State Capitol, a quiet and</u> <u>peaceful oasis" and a "...place of reflection" to quote the words of HB 2440.</u> These are the exact same reasons the Statue Commission chose the current location, a quiet place conducive to appropriate chant and ritual on significant dates. A place to reflect on the Queen and history.

This bill would move the statue to a noisy street next to bus stop where the Eternal Flame was dedicated years ago to honor Hawaii's military. We suggest that the area around the Eternal Flame should be spruced up and improved to include the military accoutrements suggested by HB 2440.

Further, the planned Hawaiian historical accoutrements cited in HB2440 should be added to the area around the statue of Queen Liliuokalani.

The AHCC holds the military veterans of Hawaii in highest esteem and many of our own members have served valiantly. Hawaii's veterans certainly deserve to have dedicated memorials added to those already in existence...but not by relocating the Queen's statue.

The painful memory of the Queen's humiliation and a nation stolen is extremely significant to Native Hawaiians, and her statue should not to be moved around at the whim of the legislature using Hawaii's military and veterans as cover in HB2440. That is unnecessary and disrespectful.

The Committee's agenda for today cites nine other bills that will benefit veterans and Hawaii's military community that the AHCC does not dispute. Create more memorials to veterans, that's fine....just leave the Queen's statue alone. We will not support HB2440 and ask that the bill be held in committee.

Comments: I have read HB2440 with disappointment. The statue of Queen Lili'uokalani is in the appropriate place and should not be moved. She stands as a reminder to all legislators that they are in the islands of Hawaii and that the nation of Hawaii never ceased to exist. Perhaps that is why they wish to move her - so they avoid having to look in her eyes? Lili'uokalani's statue has become a gathering place and symbol for many community groups, schools and individuals who come to the capitol, particularly Hawaiians. Like the Kamehameha statue one block makai, she faces the mountains, the clouds that form there, the source of water, the heavens. Unlike the Kamehameha statue which has become a gathering place for tourists to snap a picture, Lili'uokalani is a gathering place for her people and stands as a rem inder to her people that the legislature has a responsibility to care for these islands. Putting up plaques doesn't honor the alii of the past; all it does is carve away another portion of the core historical structures of the Hawaiian nation for the tourists. One wonders if this is part of a larger intentional pattern. First was to limit the gathering of Hawaiians on the grounds of 'Iolani Palace in the last few years. Is this the next step? To remove them away from the seat of governance? There are many ways to silence a voice and nip away at the spirit of a community. Do not let this bill be part of that. Instead, save a lot of money and use the funding to educate the members of the legislature about the importance of the location of the Queen's statue right where it is. I ask respectfully that legislators oppose this bill.

My name is Momi Cazimero. I am here to speak in support of House Bill 2440 Relating to the Hawaii State Capitol Area.

"ETERNAL FLAME"

Relationships of physical structures are important, especially in a space as limited and as sought-after as the State Capitol. A step toward moving in that direction begins with the relocation of the "Eternal Flame" which honors men and women who served in the Armed Forces. Presently the "Eternal Flame" is situated across the Capitol entrance on Beretania Street and the Korean/Vietnam War Memorial along Richards Street. By relocating the "Eternal Flame" to where the statue of Queen Lili uokalani is now located and by designating the makai walkway as "Memorial Mall", a relationship is established with the Korean/Vietnam War Memorial. This proximity focuses on the military service and sacrifices of our men and women in a "united tribute". The area makai of the Capitol is more appropriate as a place of reflection because it is removed from demonstrations, sign waving and activities that assemble along Beretania Street. It is fitting and meaningful, therefore, to dedicate the makai walkway extending from Richards Street to Punchbowl as "Memorial Mall" with the "Eternal Flame" as its commemorative icon.

Poignantly, a Christmas tribute begins at the "Eternal Flame" where a candle is lit. The flame is cupped and carried back to the Korean/Vietnam War Memorial. There, in a midnight candle light ceremony, veterans come together to sing "Silent Night" in remembrance of those who did not come home. This Christmas tribute to fallen comrades has taken place every year since 1995 when the Memorial was dedicated.

"SPIRIT OF LILI'UOKALANI" STATUE

At her current site, Queen Lili'uokalani remains symbolically—deposed. The Queen stands behind 'Iolani Palace, with her back toward the seat of government where she reigned as *Ali*'i

of the Hawaiian Kingdom. Moreover, Lili'uokalani stands behind the Capitol of the government that evolved from the Territory of Hawai'i, which before that was the Republic that deposed her. That is UNjust.

The rightful place for the statue of Queen Lili'uokalani is at the current site of the "Eternal Flame." That site is fitting because she was born near the Queen's Medical Center and relocation will place her next to Washington Place that was her home, and near St. Andrews Cathedral where she attended church services. Further, she will face the Hawai'i State Capitol, the icon of her people's and Hawai'i's future. In part, that future was realized through her steadfast resolve, 'onipa 'a, to protect her people by relinquishing her crown. The Queen's statue IS the embodiment of Lili'uokalani's spirit and deserves a rightful place of honor.

Further, to instill the history of the Hawaiian Kingdom in perpetuity—bronze plaques or a frieze capturing their essence and an account of each of the *Ali* '*i*—King Kamehameha I – Kamehameha II – Liholiho, Kamehameha III – Kauikeaouli, Kamehameha IV – Alexander Liholiho, Kamehameha V – Lot Kapuāiwa, King Lunalilo, King Kalākaua including Lili'uokalani— would be installed on the curved wall framing the Queen's statue. This will bring historic validation to $N\bar{a} M\bar{o}$ ' \bar{i} Hawai'i, Rulers of the Hawaiian Kingdom.

Fitting artifacts in this *wahi pana*, or legacy site, are $k\bar{a}hili$. $K\bar{a}hili$ were feathered standards symbols of rank that were displayed at ceremonial gatherings of chiefs and rulers and are exceptionally unique to Hawai'i. Portraying the majesty of Hawai'i's rulers attended by bronze $k\bar{a}hili$ will bear witness for all time of the sovereign nation of Hawai'i.

IN SUMMARY

Unifying symbolism and commemoration is very important.

The Eternal Flame, as an iconic monument of sacrifice and honor rightfully belongs in a **Memorial Mall**, that reveres those who served in the Armed Forces and also be located in proximity to the Korean/Vietnam War Memorial that honors those who died in service to our nation.

Equally vital, unifying symbols of Hawai'i in a *wahi pana*, or legacy site, will bring nobility to the *Ali'i* of the Hawaiian Kingdom and also restore Queen Lili'uokalani to a regal place of honor to reinstate her eminence in the history of Hawai'i. DOING SO WILL BE FOREVER—*PONO*.
