On November 8, 1883, the SS Mariposa entered the harbor of Honolulu and the bells of Our Lady of Peace Cathedral rang loud and strong as crowds gathered on the wharf to witness the arrival of the Saint Francis Sisters from Syracuse, New York. These seven heroic women came because they listened to the heart of Christ and answered the cry of the Native Hawaiian people who were dying of Hanson's Disease.

Mother Marianne's hard work in the community was treasured by even the King and Queen of Hawaii as was evident in the high honor she received as she was presented the medal of the Royal Order of Kapiolani by King Kalakaua. Her desire to serve the poor and outcast among us continues to motivate each and every one of us to make a difference in this community.

In 1884, at the request of the government, she established Malulani Hospital, the first general hospital on the island of Maui. As a woman of strength and deep character, Mother Marianne convinced government officials that there was a vital need to save the homeless female children of patients with Hansen's disease and opened the Kapiolani Home.

This enduring legacy of Christians in Hawaii, specifically the Roman Catholic Church, is a great one and we are so very pleased to honor this wonderful woman who taught this community a great deal about love, commitment and care of the sick of the dying. We pray that each January 23rd, the community will pause and consider this Saint for all of us who reminds us that the life and dignity of every human person is indeed precious and sacred!

Good afternoon Chair Rhoads and members of the Judiciary Committee. I am testifying in support of this bill.

I am Patrick Boland, a long time friend of Kalaupapa and a student of its history.

In 1883, at the invitation of the Kingdom, Mother came with a group of her Franciscan Sisters to Hawai'i to serve the sick, primarily those suffering from leprosy. She was put in charge of the Kaka'ako Branch Hospital until 1888 when she went to Kalaupapa to manage the Bishop Home for Girls and Unprotected Women.

There she labored for 30 years, until her death in 1918, caring for those society had cast out. She brought cheer, peace, and dignity to the patients, alleviating their physical and spiritual sufferings. Her heroic love and devotion is a model of service.

In 2012 she was canonized a saint of the Catholic Church, being one of only 12 Americans so recognized; one of the others being St. Damien, her companion in service to the patients.

I note that Hawai'i already has a St. Damien Day, as established by HRS Sec. 8-8. It is certainly appropriate to provide similar recognition to St. Marianne.

Comments: Chair, JUD Committee Right Honorable Members I support HB 2539 Relating to Saint Marianne Cope Day. However, as the title reads, this will not permit combining Saint Damien De Veuser. If he is already recognized by a similar "special" day as is proposed today for his former colleague, these two days should be combined and celebrated together, unless the intent of the co-sponsors' is to bring the focus of the Capitol law making upon the plight and needs of the Hansen's disease community. The late Director Loretta Fuddy, Dept. of Health, had just visited the Molokai facility for her annual meeting with the patients and the staff. We had a memorial service at the Co-Catheral of Saint Theresa on School Street. I did not know that Ms. Fuddy had been on the choir of this church where my wife and I were married in 1980. There is a Stain Glass Window of Saaints Marianne and Damlen on the Mauka side of the Church. However, if the makers' intent is solely to honor one of our own Saints whose relics are being returned to Hawaii, it does bear special and separate day honor. We are living in an interesting time. As a Catholic, in April 2014, the church will be canonizing two Saints: Pope John XX III and Pope John Paul II. Despite the dedication of the two saints to devote their service to the Big Island, Oahu, and Molokal, much have still to be accomplished, not just in care but concerning the "stigma". At the foot of the "Fr." Damien statue mauka of the Capitol is a brief background about the priest as well the multiple use of the word "Kokua". Please read it again today. It will bring you "chicken skin". That is the kind of person "Mother" Marianne Cope was ... "A Kokua". Please obtain a waiver to the rules and unanimously consent to jointly honor Saint Damien and Saint Marlanne on the same day. If a rule change has to occur to the House and Senate Rules, so be it.
