Chair Carroll and Members of the Committee:

My name is Anthony Lenzer. I am a member of several senior advocacy organizations, but am testifying today as an individual. I am aware, as are the organizations I belong to, that financial abuse of older people is a growing problem in Hawaii and in the nation. Such abuse is frequently accompanied by other forms of abuse, such as physical or emotional abuse, and thus is part of a complex problem, which has both criminal and social components. I support the intent of this bill, which is to bring suspected abuse to the attention of an appropriate Police Department with a minimal amount of delay. The bill also provides other types of referrals, beyond those of the police department. I am aware that there are differing opinions as to exactly what responsibilities police agencies and the Department of Human Services, adult protective services, will have in cases of this sort. I also understand that some police agencies may not have personnel with adequate training and understanding of these issues to effectively deal with complaints about financial abuse. It would therefore seem desirable that training and support for the police to be part of an overall approach to the problem.

There were six bills on the subject of financial of abuse of elders which have been introduced during the current session. I commend the legislature for recognizing the significance of this problem, and appreciate the opportunity to testify in support of the intent of House Bill 382.
