Re: H.B. 389 Relating to Income Tax

Department of Taxation (Department) appreciates the intent of H.B. 389, but hasconcerns about its ability to implement the provisions of this bill due to the technological limitations of the Department's computer system and limited staffing resources.

H.B. 389 allows taxpayers, with an income tax refund of \$20 or more, an option to designate \$5 or \$10 to certain special funds or accounts for taxable years beginning after December 31, 2012. Currently, taxpayers may designate \$5 to Hawaii children's trust fund, domestic violence and sexual assault special fund, and spouse and child abuse funds as set forth in section 235-102.5(d), Hawaii Revised Statutes.

Implementation of this measure's provisions will require software coding and testing resources. In particular, the Department is concerned with the provision which allows taxpayers the option to choose between differing amounts for donation.

The Department anticipates commencing the development of the Tax System Modernization (TSM) project before the end of the year. The TSM project is the Department's highest priority and all of our available staff resources will be focusing on its development. For these reasons, diverting valuable staff resources to accommodate the changes which do not generate revenue, as required by H.B. 389, will be difficult at this time.

In FY 2012, the domestic violence and child abuse neglect special fund totaled \$154,465. The Department estimates that these funds may net an increase of \$31,000 per year, if H.B. 389 is adopted.

Good afternoon.
