I. OVERVIEW OF PROPOSED LEGISLATION

H.B. 436 proposes to amend Section 386-80, Hawaii Revised Statutes (HRS), which relates to qualified impartial physicians appointed by the director, by proposing that the specialty of the physician is appropriate to the injury being examined.

The Department supports the measure.

II. CURRENT LAW

Currently, Section 386-80, HRS, does not specify that a physician appointed by the director to be a physician whose specialty is appropriate for the injury being examined.

III. COMMENTS ON THE HOUSE BILL

Qualifying the specialty of the physician will ensure that the claimant will be examined by a physician knowledgeable in the injury of the claimant.
