HTDC: [§206M-18] Assistance by state and county agencies. Every state or county agency may render services to the development corporation upon request of the development corporation. [L 1983, c 152, pt of §2],

#### HB 473 H.D. 1 RELATING TO THE NATURAL ENERGY LABORATORY OF HAWAII AUTHORITY

The Natural Energy Laboratory of Hawaii Authority (NELHA) strongly supports H.B. 473 H.D. 1 which amends Chapter 209E, Hawaii Revised Statutes, by adding language that would make businesses operating within research and technology parks established by NELHA <u>eligible</u> <u>for consideration</u> in the State's enterprise zone program. This measure would assist NELHA in attracting new projects to our technology park.

This measure will broaden the scope of businesses <u>eligible for consideration</u> of EZ benefits within our technology park. Last year we adopted a new Master Plan for the Hawaii Ocean Science and Technology Park. Much of the remaining lands available for lease are in areas designated for renewable energy and applied technology. This area has already designated as an "Enterprise Zone" by the County of Hawaii. Many new businesses and projects that we are targeting may not be <u>eligible for consideration</u> of EZ status given the current narrow definition. It is important to note that while this measure would broaden the definition of <u>eligible</u> businesses they still need to be <u>qualified</u> by the County and DBEDT before they could be able to receive EZ benefits.

We have been successful because the Legislature has given us the "tools" to allow us to succeed. This measure will add an additional tool to help us realize the goals of growing our economic development project and increasing the \$4.5M in State tax revenue that the park already generates.

Finally, we would like to respectfully suggest that the effective date of this measure be changed to July 1, 2013.
