Title of Bill:	HB 0478,HD2(hscr518) RELATING TO THE DEPARTMENT OF EDUCATION.
Purpose of Bill:	Authorizes schools to grow food in school gardens for consumption in the school lunch program; provided that the food is inspected and certified as safe by the Department of Agriculture. Allows nonprofit organizations to establish and administer fresh food distribution services. Effective July 1, 2013.

Department's Position:

The Department of Education supports school garden programs and curriculum related activities; but does not support amended new section in H.D. 2, as written.

Policies and procedures must be defined before commingling school garden produce with inventory procured to meet the federal meal pattern and food safety guidelines. Good Agricultural Practices (GAP) certification, traceability and liability lines must be established in case of food borne illnesses.

Processing raw, harvested produce will require addition cafeteria staff training, especially for high risk, commodity specific produce such as sprouts, melons, tomatoes, and leafy greens. Funding for additional labor hours associated with processing produce will be required. Currently, fifty-five percent of the full cost of a school lunch is labor.

The federal nutrition program requires equity in terms of availability and equal access of foods served to students participating in federal nutrition programs. DOE school gardens do not provide sufficient harvested quantities to meet meal participation needs.

Administration of a fresh food distribution service to a DOE school should also prescribe to the same standards of food safety, liability, equity, with established policies and procedures.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> HB478 HD2, which would authorize schools to grow food in school gardens for consumption in the school lunch program; provided that the food is inspected and certified as safe by the Department of Agriculture. It also allows nonprofit organizations to establish and administer fresh food distribution services.

OHA's strategic priorities include Mauli Ola (Health), which represents our commitment to improve the conditions of Native Hawaiians and quality of life by reducing the onset of chronic diseases. Obesity is a common condition of chronic diseases, and data suggests that Native Hawaiians and other Pacific Islanders are at greater risk for obesity and health complications. As such, OHA's Health Advocacy Initiative Core & Advisory Team is focusing its efforts on decreasing Native Hawaiian obesity rates in relation to Hawai'i's general population.

A pragmatic and holistic approach to address health disparities in our community is to encourage school gardens. School gardens have the potential to show children how to grow a variety of foods and increase their preference for and consumption of vegetables and fruits. In turn, by using the school garden as a teaching tool, it can demonstrate how to improve a diet with home-grown produce. A school garden also has the ability to provide children with a meaningful connection between the land they work on to grow their food, and how it supports a healthy sustainable community for themselves and their family.

At the same time, there is significant support for school gardens on state, national, and global platforms. Through the Farm to School and School Garden Hui, U.S. Department of Agriculture – People's Garden School Pilot Program, and the Food and Agriculture Organization of the United Nations, these government and non-government organizations state the necessity of supporting school gardens. These gardens provide children with hands-on learning opportunities that further support the notion of food security, environmental protection, and better nutrition.

Therefore, OHA urges this committee to **PASS** HB478 HD2. Mahalo nui loa for the opportunity to testify.

Comments: Dear Finance Committee members: I support the intent of HB 478 that schools should be able to grow food and serve it to children in their cafeterias once safe food handling procedures and Good Agricultural Practices have been established. However, it is ridiculous that the implementation date for this measure would be July 1, 2050. Don't our children and our state deserve better? Hawai'i s is highly dependent on imported foods and this program would essentially serve two purposes. First, it would help children make connections between agriculture and where their food comes from, beyond just the supermarket. This is especially important given that the average age for farmers in Hawai'i is 58 and that we are in desperate need of a new generation of farmers to grow our food. Second, it would help reduce our dependence on imported foods and serve it to school lunches. If the school lunch program was able to grow its own food and serve it to school children, it would reduce costs as well, which is obviously always an incentive to pass a measure.
