Comments: There has been encouraging dialogue between the department of land and natural resources and the taro security and purity task force on this issue. This bill would also encourage the department of agriculture to participate in the dialogue and review its available lease lands and rental rates for those parcels that may contain the unique requirements necessary for taro farming, both wet and dry, a small subset of all ag lands. Section 2 (3) may need further discussion with the agencies as to the most effective means of creating affordable lease rent rates; however, taro lands parcels around the state are sometimes assessed at rates more than 100 times their counterparts on larger tracts of prime ag lands due to the assigned value of adjacent properties. A fair and balanced agriculture valuation is necessary if farmers are to survive. This issue is addressed in HB488. Section 2(4) and (5) are critically important if state lease lands are to be accessible to taro farmers. Criteria to qualify for agriculture leases vary according to agency or program. In some cases, a farmer is required to have a college degree in agriculture; in others a minimum financial equity or bond is set, typically out of reach of taro farmers. There is no agricultural degree that prepares an individual with the skills to be a taro farmer; that is learned through apprenticeship and practice. Currently at least 2 million pounds of raw taro are imported into the state. The taro task force has stated that there is no reason for local growers not to meet the needs of the state. Additionally, new niche markets are developing for hand-pounded poi. An accessible means of informing new and existing taro farmers about available leases will encourage greater production of this staple crop for subsistance and commercial production and will improve food security for Hawaii. The benefit will be an increasing number of small farmers fulfilling a growing demand for high quality taro among consumers and feeding their families on each island. It will also provide taro growers on existing farms who have not had the capacity to fallow their lands due to market demands or who need to fallow to reduce infestations of apple snails, the opportunity to open alternative lands and allow existing acreage to rest.

Aloha Honorable Representatives,

Mahalo for HB 483. While at the Hana Taro Festival last year, they ran out of taro by 1:00 PM. I arrived at 2:00, expecting to get some fresh poi, but there was none to be had. Poi is \$6 / pound, and rising. We need more kalo cultivation in Hawaii Nei, and HB 483 is a good start to remediating our kalo shortage. Kalo makes up ½ of 1% of Hawaii's agricultural crop output as measured in dollars, according to HDOA in 2010, Hawaii grew \$2.5 million of kalo. To put that in perspective, Sugar and GMO seed production are about 51% of Hawaii's agricultural crop value at a little over \$300 million in sales, a large part of which leaves the state. GMO seeds are also exempt form state tax. We need to make an adjustment, more water and land for kalo please, because at \$6/Lb. someone can make a good living growing kalo, and the money will stay in Hawaii.
