Thank you for the opportunity to testify on HB 530, which designates November as Homeless Awareness Month. I am Betty Lou Larson, Legislative Liaison for housing and homeless issues at Catholic Charities Hawaii.

Homelessness impacts on the people of Hawaii in many ways – in their neighborhoods, around their businesses, in tourist areas, and among their friends or family member who may face homelessness. This complex issue requires greater collaboration and coordination if we are to end homelessness in Hawaii. Synergy is growing to identify critical strategic goals and initiatives to focus on ending homelessness. All parts of our community need to be involved to resolve this sometimes overwhelming social problem.

Partners in Care has promoted community awareness for over 10 years targeting the month of November especially since this coincides with national efforts during November. Other coalitions on the Neighbor Islands also often plan activities in November for homeless awareness and education.

By declaring November as Homeless Awareness Month, this will bring added community attention to what is being done to end homelessness. It will promote public awareness of homelessness as a significant societal, public health and welfare, and affordable housing shortage problem.

We urge your support for HB 530 and for community awareness of homelessness. We all must work together to solve the complex problem of homelessness.

Our core mission is to help our clients gain access to the resources, services, and fair treatment that they need to realize their opportunities for self-achievement and economic security.

Thank you for an opportunity to testify in **support** of House Bill 530, which would designate November as Homelessness Awareness Month.

The impact of homelessness is devastating for the individuals and families who struggle to survive without permanent housing. Homeless children are at greater risk of foster care placement, lowered academic achievement, and physical and mental injury. Individuals experiencing mental health problems or substance abuse disorders are often unable to address these challenges without stable housing. The suffering experienced by anyone without a permanent home is immeasurable.

For our entire community, we face a terrible cost as a people. Each individual experiencing homelessness challenges what we have historically valued as an island community and deeply undermines the spirit of aloha. We also know that by failing to ensure the health and well-being of all members of our community, we incur significant financial costs, estimated at up to \$40,000 per individual. But any of these costs pale in comparison to the harms befalling individuals experiencing homelessness.

We have seen increased attention to the homelessness crisis, but this very complex problem requires greater public education to help our community move to a solution. A Homelessness Awareness month will draw attention to this critical issue and promote greater understanding of the challenges and needs of people experiencing homelessness, ultimately helping restore the basic dignity and well-being of some of our community's most vulnerable citizens.

Again, thank you for providing us with an opportunity to testify in strong support of HB 530.

Mahalo for the opportunity to testify in support of HB 530 which will designate November as Homeless Awareness Month.

Aloha, my name is Jazlyn Wandasan and I am an MSW student from the Myron B. Thompson School of Social Work at the University of Hawai'i at Manoa. I was born and raised on the Wai'anae coast where the homeless community is pervasive. I went to school with people who were homeless, I had family who was homeless, and when I worked as a summer aide doing summer fun, I had children who were homeless. I have always been exposed to homelessness throughout my life. And I admit, as an adolescent, I did not understand the seriousness of this issue. Everywhere I went I saw the homeless community and at-risk youths endangered of being homeless. For me, this was "normal," it was just how things were. But it should not have been that way.

It was not until I left and returned from college that I began to really see the issue as an issue. That is why I am in support of this bill. This population has become very dear to me.

I have seen the positive impact awareness months have had on communities. For example, April is Sexual Assault Awareness Month and already I see events planned to gather people to fight against sexual violence.

I believe in the necessity of prevention and awareness events and programs and I think in order to combat homelessness in Hawaii we need to further educate our communities. So many people have been falling into hard times and are in danger of being homeless. I believe that by raising the public's awareness not only can we gather supporters, we can also promote individual's access to resources and provide respite to the many struggling families out there who may fall between the cracks. It is my hope that we can find more effective ways to support our homeless communities.

My name is Trisha Bise and I am currently a first year MSW student of the Myron B. Thompson School of Social Work at the University of Hawai'i at Manoa. I am writing in full support of HB 530, which is trying to designate November as "Homelessness Awareness Month".

Homelessness is a social issue that affects multiple aspects of our society. It touches upon the topics of affordable housing, shelter, mental health, general assistance, medical care, and access to resources. Many people are aware that homeless individuals exist in their communities but some fail to educate themselves behind the core issues of this oppressed population.
