## House Bill 536, House Draft 1 Relating to Public Housing

Honorable Chair Chun Oakland and Members of the Senate Committee on Human Services, thank you for the opportunity to provide you with comments regarding House Bill (H.B.) 536, House Draft (HD) 1, relating to public housing.

The Hawaii Public Housing Authority (HPHA) <u>supports</u> enactment of this measure which prohibits the admission or requires the termination of tenancy of any person who owns or acquires a home within the state.

Under the current statute, the HPHA is not able to consider whether an applicant is a homeowner. The HPHA is committed to serving the neediest of Hawaii's residents and have over 10,000 families on our waitlist. By allowing HPHA to deny admission or terminate the tenancy of an individual or family who owns or acquires a home, the HPHA will be able to house those who truly have no other means of shelter.

The HPHA appreciates the opportunity to provide the Senate Committee on Human Services with the agency's position regarding H.B. 536 HD1. We respectfully request the Committee to pass this measure favorably, and we thank you very much for your dedicated support.

Thank you for the opportunity to testify in support of HB 536 HD1. The purpose of this bill is to establish stricter assets guidelines to be eligible for Public Housing.

The HOMELESS & AFFORDABLE HOUSING INSTITUTE (HAHI) supports enactment of this measure which prohibits the admission or requires the termination of tenancy of any person who owns or acquires a home within the state.

Under the current statute, the HPHA is not able to consider whether an applicant is a homeowner. The state should be serving the most needy of Hawaii's residents and have over 16,000 families on our waitlist.

By allowing HPHA to deny admission or terminate the tenancy of an individual or family who owns or acquires a home, the HPHA will be able to house those who truly have no other means of shelter.

The HPHA will be able to prioritize its efforts on housing those who truly have no other resources to obtain housing.
