RELATING TO ECONOMIC DEVELOPMENT

Chair Tsuji and members of the Committee, thank you for the opportunity to testify on H.B. 555. The Department of Accounting and General Services (DAGS) supports the intent of H.B. 555 and provides the following comments:

 This measure is not applicable to DAGS because we do not have any overview or jurisdictional authority for planning, development, and financing of public infrastructure improvements, which are needed for designated regional master planned areas (such as residential subdivision developments; mass transit systems; transit-oriented development areas; school or recreational use districts; etc).
Pursuant to section 26-6, Hawaii Revised Statutes, DAGS only has the jurisdictional authority to implement planning, design, and construction phase work for State projects that are assigned to DAGS, in compliance with applicable laws, regulations, ordinances, rules, and statewide policies promulgated and managed by other Federal, State, or County agencies. Therefore, DAGS respectfully requests that the reference to "the department of accounting and general services" at page 2, line 15, be removed from the measure.

2. On an as needed basis, DAGS staff will work with other State agencies that have jurisdictional authority over developments within designated regional master planned areas to ensure that projects under DAGS management and control will comply with the applicable State Smart Growth Infrastructure Policy guidelines.
