HOUSE BILL NO. 631 RELATING TO FOOD

Chairperson Wooley, Chairperson Tsuji, and Members of the Committees:

Thank you for the opportunity to testify of House Bill 631, which proposes to permit non-genetically engineered food or ingredients to be labeled as "not genetically engineered" or " does not include a genetically engineered ingredient" and permits any person or agency to bring civil action against violators of the requirements. The Department provides comments.

The U.S. Food and Drug Administration is responsible for the regulation of food labeling, and has the expertise and resources to scientifically evaluate if food poses a health or safety risk. By some estimates, with over 80% of the food imported for consumption in Hawaii, and no federal labeling mandate, it creates a difficult environment for food distributors, food manufacturers and retailers to know whether the food is or is not genetically modified. In addition, according to the United States Department of Agriculture food that has been lawfully certified as eligible to be labeled, marketed, and offered for sale as organic pursuant to the federal Organic Food Production Act can be considered a non-genetically modified label.

1 **Department's Position:** The department opposes this bill.

2 **Fiscal Implications:** The department has not included or funded this initiative in the Executive

3 Biennium Budget and therefore may adversely affect other spending priorities.

4 **Purpose and Justification:** The Department does not object in principle to a labeling policy to enhance

5 public awareness of the absence of genetically engineered food or food ingredients in Hawaii markets.

6 However, the Department is not in a position to enforce such legislation as we do not conduct work in

7 recombinant DNA; and therefore, do not possess the requisite scientific expertise and experience to test

8 and determine whether a suspected food or food product has been genetically engineered or includes

9 genetically engineered ingredients. Currently, there is no conclusive scientific evidence of negative

10 health effects associated with the consumption of genetically engineered food or food products. As such

- 11 we do not believe such labeling is a health issue and thus do not support any such program being
- 12 assigned to the Department to administer.

HB 631 Relating to Food

Authorizes display on qualified food offered for retail sale a label stating "not genetically engineered" or "does not include a genetically engineered ingredient" if the statement is true. Makes an untrue statement a violation. Allows any person or public agency to seek an injunction to prevent or terminate a violation.

Chair Wooley, Chair Tsuji, Vice Chairs and Members of the Committees:

My name is Alan Gottlieb, and I am a rancher and the Government Affairs Chairperson of the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC) is the Statewide umbrella organization comprised of the five county level Cattlemen's Associations. Our 130+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council Strongly Supports HB 631.

HCC along with our National Organization, the National Cattlemen's Beef Association has always felt that labeling, such as Country of Origin labeling, should be a market driven tool, not a regulatory one. HCC support all types of farming & ranching; Natural, organic, conventional and cutting edge (including GMO, or other science advanced forms) and does not try to endorse one over the other. We don't see that the advancement of one, should be at the risk or detriment of the other. In fact, in the beef industry, we believe it is detrimental for all, if one attempts to market their product by saying or implying the other is bad for consumers. We believe we need to support each other and market our own niche with sensitivity.

We agree consumers have the right to know! We think it makes a lot of sense, for GMO free products to be allowed to label their products as such, placing it as a premium product in some people's mind. That premium price could then more than pay for adding a label stating the product is GMO free. Food labeled "Organic" generally sell for much more than their non-organic counterpart.

Whole Foods is a great model for giving consumers the things they want to know. They offer organic foods, GMO Free foods, natural foods, and 5 different levels of meat. They don't force producers to label their product GMO or non-organic, but they have signs by food bins letting consumers know if the food in the bin is organic, natural or GMO Free. If this is what consumers want, shouldn't we let markets use this for their competitive advantage.

There is no rational science based reason to "warn" consumers about GMO products. The FDA regulates all food labeling in the United States, and in their scientific judgment, there is no significant difference between foods produced using biotechnology and their conventional counterparts. With over one trillion servings of biotech foods consumed by the public, there has never been a documented incident of any harm to the health of consumers.

Re: HB 631 Labeling of Food as Not Genetically Engineered

I am the Chief Organic Officer/CEO of Down to Earth *Organic & Natural*, a Hawaii company established in 1977 which operates 5 natural foods stores in Hawaii, 4 on Oahu, 1 on Maui.

Down to Earth strongly supports the labeling of genetically engineered foods (GMOs), and in the absence of mandatory laws requiring such labeling, we support the right of food producers and manufacturers to label foods as being "made without genetic engineering", or "Non-GMO", or similar claims provided such claims are true.

While we support the intent of HB 631 which allows such labeling provided it is true, we have a number of concerns with the HB 631 as drafted as follows:

- 1. The bill regulates and specifically allows the use of the following claims, "not genetically engineered", and "does not include a genetically engineered ingredient". The bill does not address claims that may be worded differently thus the bill is incomplete, and in effect it allows other claims of being GMO free if worded differently even if such claims are not true or are deliberately false.
- 2. The bill does not establish any tolerance level for minute quantities of GMOs. The unfortunate reality is that due to the ubiquitous proliferation of GMOs foods may become contaminated with small quantities of GMOs due to cross pollination, or during transportation and processing. Thus an honest food manufacturer may be making best efforts to acquire non GMO ingredients and may be unaware of the small amounts of contamination. If they labels their foods under the provisions of this bill and if the foods are later found to have minute quantities of GMO, will they have broken the law or not? A tolerance level needs to be established.
- 3. The natural products industry has spent many years dealing with the GMO "problem". The industry's response has been twofold:
 - a. The formation of the Non-GMO Project (<u>www.nongmoproject.org</u>) a non-profit organization which verifies non GMO claims through independent testing and

process auditing. For verified products The Non GMO Project allows the use a seal "Non GMO Project Verified" that manufacturers may place on their product packaging. This provides truly independent verification of Non GMO claims that consumers can and do rely on. Over 5,000 products now have this seal.

- An increasing move towards organic foods as GMOs are not an approved "process" under the USDA National Organic Program.
- 4. The bill should specifically exclude Non GMO Project Verified products and certified organic products and their related claims from its provisions.
- 5. The enforcement provisions effectively delegate the state's duty of the administration and enforcement of its laws to "interested persons" presumably any individual, who may file a lawsuit seeking injunctive relief. As a result businesses may be subjected to numerous individual consumer lawsuits alleging that certain products with non GMO claims are not true. This may be duplicative, time consuming and expensive for businesses. The enforcement of the law should be done by a suitable state agency.

HB 631 starts an important discussion, but should not be passed without modification and industry consultation.
