HOUSE BILL NO. 673 HD 1 RELATING TO PESTICIDES

Chairperson Belatti and Members of the Committee:

Thank you for the opportunity to provide testimony on House Bill No. 673 H.D. 1. The purpose of this Act is to better address the potential health and environmental issues related to pesticides use by identifying trends in pesticide use.

The department has strong reservations as to the practical application and implementation of this bill particularly if the expectation is for the Department to respond to all complaints as outlined in this bill.

To establish and implement the proposed reporting system for Restricted Use Pesticide applications that this bill envisions would require that the Department obtain additional resources, in particular, increased staffing. There are approximately 500 Private applicators and 1,200 Commercial Applicators that hold certification licenses to apply Restricted Use Pesticides (RUPs). Given those numbers, the Department would be receiving hundreds of applicator reports per month which staff would have to review, collate, and process. In addition, new software would need to be developed and tested and costs would be incurred to maintain the system.

On another note, the Department needs to point out an inaccuracy in the bill that should be corrected. At page 1, line 13 - 17, HD 1 of the bill describes the summary of restricted use pesticide use which the Department's annual report should include as a "list of all restricted use pesticides used in each county in the State by type and volume, excluding pesticides defined in FIFRA, 40 Code of Federal Regulations Section 152.25(f), as minimum risk pesticides. " It is not appropriate to "exclude" minimum risk pesticides in the foregoing sentence because restricted use pesticides and minimum use pesticides are mutually exclusive classifications under



the U.S. Environmental Protection Agency's (EPA) rules that implement the Federal Fungicide, Insecticide, and Rodenticide Act (FIFRA). Restricted use pesticides are limited to use by certified applicators or persons under their direct supervision and minimum risk pesticides are exempt from FIFRA registration as a pesticide. We think that the bill intended to say that the Department's annual report should include a list of restricted use pesticides, etc., and not other pesticides. The Department offers the language below to correct this at page 1, line 12 - 17, to read:

"The summary shall include:

(1) A list of all restricted use pesticides used in each county in the State by type and volume."

The Department notes that, at page 3, line 4 - 8, the bill requires the Department to permit "an independent review of the restricted use pesticide use collection procedures implemented in accordance with this part, as deemed necessary to ensure accuracy, reliability, and validity of the data collected." We believe the bill should clarify that the independent review should be conducted by a "qualified entity or individual(s)".

The Department further notes that at page 2, line 9 - page 4, line 7, the bill requires a private or commercial applicator to provide certain information to an abutting property owner who makes a written request for information pertaining to the pesticide application. The Department is aware from its experience with public record requests for closed pesticide investigation files that some private applicators may object to having to provide some of the information required by this bill, such as quantity of pesticide applied, including any mixtures of pesticides (which are required to be identified by name), and geographical system coordinates. The bill should address what would happen if an applicator does not provide all the information required by the bill because the applicator considers the information to be confidential business information.

Dear Chair Belatti, Vice Chair Morikawa, and committee members,

HB 673 HD1 provides measures for obtaining information that would help us to understand the sources, transport, and fate of pesticides; better assess relationships between pesticide use and environmental and human health; and improve our ability to develop remedial and preventive solutions to related health problems. Pesticide contamination of Hawaii's soil, water, and biota is an ongoing concern with potential long-term consequences. Although we are quite capable of detecting pesticides in ambient water, soil, and tissue, our level of confidence in tracking a signal back to its sources is limited by the accuracy and precision of historic pesticide use information. Greater availability of detailed pesticide use information could reduce the costs of pesticide source tracking and increase the utility of the results for environmental planning and management purposes.

Thank you for hearing this proposed legislation. Please note that this testimony is advisory only and does not represent the official position of the University of Hawaii.

Thank you for this opportunity to submit testimony in strong support of H.B. No. 673, H.D. 1, Relating to Pesticides. My testimony is submitted in my capacity as an individual member of the Kaua'i County Council.

H.B. No. 673, H.D. 1 establishes a reporting system for pesticide usage in Hawai'i. These reports will serve as a tool to identify the potential health risks pesticides pose when in contact with humans.

Many community members on the Westside of Kaua'i have expressed great concerns regarding the pesticide activities conducted by major seed companies in the adjacent area near their homes. Chronic illness and poor health, especially respiratory complications and cancer, have been claimed to be linked with severe pesticide exposure.

In 2008, I introduced a measure that would establish a working group tasked with making recommendations on implementing pesticide buffer zones and other related issues in close proximity to schools. It is governments' role and fundamental responsibility to protect the health and welfare of the people and of the 'aina. There is no question that immediate action needs to take place in order to ensure our communities are safe from the potential long and short term harm caused by pesticides.

H.B. No. 673, H.D. 1 will help bring clarity to the unknowns that can lead to fear and misunderstanding.

For the reasons stated above I respectfully request your support for this measure. Again, thank you for this opportunity to submit testimony.

We carry out plant breeding work at our 2 Hawaii research sites to develop crops with improved characteristics including greater insect and disease resistance and higher yields. Our two parent seed locations multiply seed to develop new hybrids and varieties that are more productive for farmers in the US and around the world. DuPont Pioneer employs approximately 350 people in a wide range of types of jobs on Oahu and Kaua`i.

The Hawaii Department of Agriculture already has oversight of pesticide use, including the use and reporting of those categorized as restricted use. Record keeping requirements are already in place. Generation of a report by Hawaii Department of Agriculture will be time consuming and will add little new information.

Complaints regarding pesticide use are investigated by Hawaii Department of Agriculture. Requiring extensive reporting of information for products that are approved for use by the EPA creates a significant burden on applicators. Frequent reporting requests from an adjacent property owner will cause farmers, landscapers, pest control companies, hotel groundskeepers, as well as state and county employees to spend a great deal of time responding to these requests even when following all mandated guidelines. The US Environmental Protection Agency establishes guidelines and law for each pesticide approved for use on specific crops, which are followed by applicators.

Aloha Chair Belatti, Vice Chair Morikawa, and members of the Committee:

My name is Alicia Maluafiti, Executive Director of the Hawaii Crop Improvement Association, a nonprofit trade association representing Hawaii seed farmers. We oppose HB 673 HD 1 requiring the Department of Agriculture (DOA) to establish and implement a pesticide use reporting system in Hawaii.

While we believe that public health and safety is the top priority of our state legislature, we don't believe that targeting pesticide use is an appropriate, necessary or fiscally responsible policy. The Environmental Protection Agency (EPA) safety review involves over 100 toxicology and environmental studies on crop protection products that must demonstrate that their proper use do not pose unreasonable risks to human health or the environment before it can be registered for use by EPA. Therefore, HB 673 would place an unnecessary, duplicative, and costly administrative burden on the HDOA at a time when they are still struggling with labor shortages as a result of the last Reduction in Force (RIF).

It's unfortunate that the benefits of crop production products are rarely acknowledged and instead have become the target of every ill affecting society. The truth is that they help fight diseases that jeopardize public health by killing parasites like malaria and guinea worm. They combat global malnutrition and starvation by increasing crop yields, helping families worldwide afford more fresh produce. Currently, one-sixth of the world population, over 900 million people, suffers from malnutrition and continued advances in crop protection are needed as the world's population grows. Crop protection protects biodiversity by controlling noxious, invasive weeds that may choke waterways or overrun natural habitats. They also aid in the safety of our roadways by keeping road signs, right-of-ways, power lines, and railroad tracks visible and clear from weeds. It even helps to protect water quality and aquatic habitats by reducing soil erosion, which can sweep dirt and other materials into our waters.

With over 2 million farmers in the United States, crop protection products are critical to controlling insects, diseases, weeds, fungi and other undesirable pests that would otherwise threaten our food supply. Agricultural output has to double in the next 20-30 years in order to feed the world's population. By 2030, the United Nations predicts there is likely to be 1.7 billion more people to feed worldwide. Farmers must have access to crop protection solutions to grow more food per acre. HB 673 HD 1 only stigmatizes pesticide use unnecessarily. Mahalo for the opportunity to testify.
