I served with distinction and was honorably discharged in February of 2012. Over the span of three total combat tours as an infantry soldier, I injured my back and have developed arthritis in my hands and knees.

Dear Judiciary Committee Chair, Vice Chair and Members,

My name is Jim Hochberg. I have been an attorney here in Honolulu since 1984. Since last summer I have also been the President of Hawaii Family Advocates, a social action 501C4 independent expenditure non candidate committee.

I oppose HB 699 which seeks to legalize recreational use of marijuana for people 21 years and older.

Marijuana is currently classified as a Schedule I controlled substance under the <u>Controlled Substances Act</u> (<u>CSA</u>). As a Schedule I drug, marijuana is classified under the following criteria:

A. The drug has a high potential for abuse.

B. The drug has no currently accepted medical use in treatment in the United States

C. There is a lack of accepted safety for use of the drug under medical supervision.

The CSA mandates that the scheduling and approval of drugs, including marijuana, must be done on both legal and scientific bases. The scheduling of a drug must conform to all applicable criteria contained in the CSA if the medicine includes a controlled substance. In June 2011, the Drug Enforcement Administration (DEA) reviewed a petition to reschedule marijuana. Based upon scientific and medical evaluation, as well as scheduling recommendations from the Department of Health and Human Services (HHS), DEA denied the petition to reschedule marijuana. HHS determined that marijuana has a high potential for abuse, no currently accepted medical use in treatment in the U.S., and lacks accepted safety for use under medical supervision.

If that is the case, why would you legalize marijuana for recreational use? Because you want to raise tax revenues? Why stop at 15% tax on marijuana. Make the tax 100% to double the cost. It will also make it harder for the 20 year olds to afford it.

Why not legalize prostitution, pornography and lots of other vices so you can tax those transactions? If you want to relieve law enforcement of its duties by legalizing marijuana, why stop at marijuana in the drug war? Legalize all Schedule 1 controlled substances.

The reason you would not do those things is because they are bad policies. They are bad policies because people will be hurt or injured. In my opinion, your responsibility as legislators is to pass laws that point our society toward the good. We have to drive more slowly near schools and hospitals, because that is good. The police are there to ticket speeders who disregard that good law. Should you then remove all the speed limits so the police don't have responsibility any longer?

Your job is not to find ways to generate tax revenues unless the underlying activity is good for Hawaii.

What effect will legalized recreational marijuana have on our tourist industry? Have you thought much about that? Do you even know what being high on marijuana is like? If you don't, you should not legalize it because you have no idea what you are turning loose. If you do know first-hand, you would not vote for this bill.

This bill is way too broad. You define marijuana accessory so broadly that no one less than 21 years old is legally permitted to possess, use, display, purchase or transport a marijuana accessory. What would that cover? Try this list:

Dirt, water, fertilizer, garden hose, shovel, garden sheers, etc. How is that?

I oppose legalizing any vice as a means of raising tax revenue. In my opinion, any legislator that believes that is the appropriate exercise of the trust that was placed in you by the electorate, has sadly lost his or her way. We look to you to do what is good for Hawaii.

We have provided people with medical needs a license to possess and use medical marijuana, but we have not provided a way for most patients to get their medicine. We need a dispensing system for the vast majority of patients who have no way to produce or otherwise obtain their medication.

This picture shows the size of plants that have been grown outdoors. They are 12 inches tall. They need light for 12 hours a day or more. To get enough mature plant matter to use as medication, the patient or caregiver (grower) need s more plants than is currently legal to grow.

What about patients who can't afford the grow lights or have no room for such an expensive outlay? What about patients in care homes or assisted living? Don't we care about those patients who don't have the lifeline of a caregiver for their pain management?

A dispensary creates a way for all patients to get medicine. In California, patients with an authorized medical marijuana card can go to a dispensary and get the medication they need in a variety of forms. This, in turn, creates opportunity for small businesses. Hawaii's entrepreneurs would benefit from such a system here. This opportunity for local businesses would be even greater if Hawaii legalized the personal use of cannabis.

Time magazine says the legalization of personal use of marijuana will result in a \$1.4 billion loss to Mexican drug cartels. How many hundreds of millions would stay in Hawaii if personal use of cannabis were legal here? As this pro-legalization movement spreads across the country, Hawaii is poised to take advantage of America's No. 1 cash crop.

House Bill 699 intends mainly to decriminalize marijuana, which would be a great decision. But right now we have allowed medical marijuana, yet we have no system to distribute it. Once we have dispensaries, we have a system to control and distribute marijuana. Setting this up with reciprocity for mainland visitors who are medical marijuana patients would enable them to get their medication here while on vacation. This would result in an increase in tourism to the islands.

Colorado has collected more than \$22 million in taxes off their marijuana dispensing system. By adding a dispensing system, with reciprocity, to this bill, we would:

- 1. provide medical aid to those who need it
- 2. increase tourism
- 3. increase small business
- 4. keep money in Hawaii
- 5. increase the local tax base
- 6. provide the country with a model with which to move forward.
