# RESOLUTION URGING HAWAI'I DEPARTMENT OF TRANSPORTATION TO CONSTRUCT A SHARED-USE PATH ALONG KAHEKILI HIGHWAY

WHEREAS, a shared-use (bicycle and pedestrian) path along Kahekili Highway between East Hui 'Iwa Street and the Hygienic Store would improve the quality of life in the Kahalu'u community by providing:

- A safe route for our keiki to get to school and to the Kahalu'u Regional Park;
- Recreational opportunities that promote healthy lifestyles; and
- Options for residents to get around our community without having to add another car to traffic.

WHEREAS, the Hawai'i Department of Transportation's existing right-of-way along Kahekili Highway between East Hui 'Iwa Street and the Hygienic Store is wide enough to accommodate both a shared-use path and any of the highway widening/contraflow options currently under consideration;

WHEREAS, the Hawai'i Department of Transportation's Capital Improvement Budget for Fiscal Year 2011-2012 includes \$1.6 million for design and construction of shared-use paths along Kahekili Highway; and

WHEREAS, design and construction of a shared-use path could proceed expeditiously and would provide construction jobs during this period of economic recovery;

NOW, THEREFORE, the Kahalu'u Neighborhood Board No. 29 urges the Hawai'i Department of Transportation promptly to undertake the design and construction of a shared-use path along Kahekili Highway between East Hui 'Iwa Street and the Hygienic Store.

Copies of this resolution shall be transmitted to the Governor Neil Abercrombie, the State of Hawai'i Department of Transportation, State Senator Clayton Hee, and State Representative Jessica Wooley.

The Kahalu'u Neighborhood Board adopted this resolution unanimously at its January 11, 2012 meeting.

Dear House Finance Committee Members,

I am writing in strong support for HB736 and urge the Hawai`i Department of Transportation to revert to the original version of the bill, requiring the DOT to begin planning, designing and constructing the pedestrian/bicycle shared pathway along Kahekili Highway. The current bill provides the funding for the pathway, but does not require the DOT to take action and begin the necessary steps in preparation for the building of the pathway.

A shared-use pedestrian and bicycle pathway would improve the quality of life of Kahalu`u residents by helping to promote healthier lifestyles (exercise), a safer walking, jogging and bicycle riding path (paved and designated walking/riding area), and an alternative for community residents to get to nearby parks, schools, and convenience stores (fewer cars on the road).

IMPORTANT FACTS TO CONSIDER:

• There are currently no sidewalks in place on Kahekili Highway, so people walk, jog, or walk their pets on the shoulder strip.

• Since moving to Kahalu`u in 2010, there have been two pedestrian fatalities (June 2012 and November 2010) on the strip of Kahekili Highway, between the two points (East Hui Iwa street and Waihee road) of the proposed shared-use pathway.

• Following community input, the Kahalu`u Neighborhood Board unanimously adopted a resolution (January 11, 2012) urging the DOT to construct a shared-use pathway along Kahekili Highway.

There is a need for the shared-use pedestrian/bicycle pathway, reflected through overwhelming community support for the project. I respectfully urge you to pass HB736 in its original form, as submitted by Representative Jessica Wooley.

Please consider:

**Safety.** The City and County of Honolulu unfortunately ranks high nationwide in pedestrian deaths. While there has been a decline in bicycle/pedestrian accidents nationwide, Hawai'i has witnessed an increase in our death rate from bicycle/pedestrian accidents. At 5.7 deaths per million of our population, our rate is over twice the national average. Worse, of our total traffic deaths, over 25% are cyclists and pedestrians, again about twice the national rate. Roughly 80% of car/bicycle accidents are the fault of the automobile operator.

Traffic Congestion. In Boulder Colorado, a Transportation Management Plan -- which included enhanced bike/pedestrian facilities -- was implemented about 20 years ago. Pedestrian and bike trips both increased by over 10%, while car use diminished by 14% (growth in bus use accounts for the rest). Consider this potential in Honolulu, where our weather is conducive to outdoor activities year round. Many residents have indicated a desire to use bicycles for some part of their trip needs, if only there were safe streets and appropriate facilities. To date, 5.7% of us already walk or bike to work, 1.6 times the national average. Consider the untapped potential to economically reduce automobile use while still meeting transportation demand, if a comprehensive plan were adopted.

**Public Health.** One third of us are overweight or obese. This sad fact reflects, among other life style factors, the long-term consequences transportation decisions made in the past. Quite simply, we have not provided the capacity for people to walk and bicycle safely in our communities. Most trips of 1/4 to 1/2 mile are entirely feasible on foot, and 3 miles or more on bicycles, if only they were perceived to be safe.

#### H.B. 736, H.D. 1 RELATING TO TRANSPORTATION

House Committee on Finance

The Department of Transportation (DOT) opposes this bill.

According to the DOT's Statewide Bicycle Plan (Plan) and its priority list of bicycle projects Statewide, this area of Kahekili Highway is categorized as a Priority III. Based on the Plan's criteria and evaluation process, Priority III are facilities desired for construction beyond 20 years.

Furthermore, the DOT is currently re-evaluating the validity of the 1990 Final Environmental Impact Statement at the Kahekili and Likelike Highways Interchange, and along the Kahekili Highway corridor from Haiku Road to the Kamehameha Highway intersection. The DOT will be considering accommodations for all modes of transportation that includes a multi-use path along Kahekili Highway from the Haiku Road intersection to Kamehameha Highway near the Hygienic Store.
